INCIDENT MANAGEMENT SITUATION REPORT SUNDAY, SEPTEMBER 17, 2000 - 0900 MDT NATIONAL PREPAREDNESS LEVEL III

#### CURRENT SITUATION:

Five new large fires were reported, four in the Southern Area and one in the Northern Rockies Area. Crews reached containment goals on three fires, one each in Southern California, Eastern Great Basin and Rocky Mountain Areas. Initial attack activity was moderate in the Southern Area and light elsewhere. A trough moving through the Northern Rockies will bring showers and thunderstorms to Idaho, Montana, western Wyoming and northern Utah. Very high to extreme fire indices were reported in California, Idaho, Utah, Wyoming, Nevada, Montana, Arizona, New Mexico, Colorado, Kansas, Arkansas, Texas and Oklahoma.

### SOUTHERN AREA LARGE FIRES:

ARBUCKLE, Oklahoma Division of Forestry. This fire is located 11 miles northwest of Ardmore, OK, and is burning in grass, cedar, and oak. Crews continue to mopup and secure control lines.

SKELETON, Oklahoma Division of Forestry. This fire is burning in heavy brush fuels five miles west of Mulhall, OK. Spotting, crowning and torching was observed on the fire. Crews and one helicopter continued with containment efforts.

PONTOTOC, Oklahoma Division of Forestry. This fire is burning one half mile north of Pontotoc, OK. The fire continued to exhibit active burning in the interior. Crews continue to mopup and secure containment lines.

SHELL LAKE, Oklahoma Division of Forestry. This fire is burning in grass and timber two miles northwest of Sand Springs, OK. Very intense fire activity was observed. Torching and spotting created significant control problems

GIBSON, Oklahoma Division of Forestry. This wind driven fire is four miles east of Newkirk, OK. The fire escaped from a hay bale fire.

SUGARLOAF, Oklahoma Division of Forestry. This fire is burning in a mixed hardwood and pine plantation two miles north of Monroe, OK. The fire exhibited extreme fire activity. Spotting has been a major concern. Aircraft made numerous retardant drops to help protect structures.

KERNEL, Miami Agency, BIA. This fire is four miles east of Vamoosa, OK. The surface fire is backing down slopes into the wind and running upslope where fuels are continuous.

BILLY BELL, Oklahoma Division of Forestry. This fire is burning on Weyerhaeuser Timber Company land 18 miles west of Broken Bow, OK. No new information was received. This will be the last report unless new information is received.

LYTTON SPRINGS, Texas State Forest Service. The fire is 40 miles southeast

of Austin, TX, and is burning is pine and cedar. One residence was destroyed and four others are threatened.

CUMBY, Texas State Forest Service. The fire is 150 miles northeast of Dallas, TX, and is burning is pine. No other information was received.

#### ROCKY MOUNTAIN AREA LARGE FIRES:

ELDORADO, Boulder Dispatch Center Counties. A Type II Incident Management Team (Hartman) is assigned. This fire is burning eight miles southwest of Boulder, Colorado. Approximately 100 homes have been evacuated. High temperatures, low relative humidities and short range spotting are impeding containment efforts.

PEARL, Routt National Forest. This fire is located 20 miles north of Steamboat Springs, Colorado and is burning in spruce, fir and logging slash. Crews are making good progress with support from aircraft.

## NORTHERN ROCKIES AREA LARGE FIRES:

BUNYON POINT, Lewis and Clark National Forest. A Type I Incident Management Team (Bennett) is assigned. This fire is 22 miles west-southwest of Augusta, MT. No other information was received.

VALLEY COMPLEX, Bitterroot National Forest. A Type II Incident Management Team (Gauger) is assigned. These fires are seven miles south of Darby, MT. The complex consists of the Bear, Taylor, Taylor Spot, Hilltop, Razor, Fat and Mink fires. Warmer temperatures and lower humidities are resulting in increased fire activity. Crews constructed fireline around two areas that made short runs along the Razor fire.

SKALKAHO COMPLEX, Bitterroot National Forest. A Type II Incident Management Team (Hoff) is assigned. This group of fires is ten miles southeast of Hamilton, MT. Increased burning activity has been observed. Patrolling continues with mopup of internal hotspots. Additional acreage reflects acres from the Skalkaho Pass fire that was transferred from the Middle Fork Complex.

MUSSIGBROD COMPLEX, Beaverhead-Deerlodge National Forest. These fires are 12 miles northwest of Wisdom, MT. The complex includes the Mussigbrod and Maynard fires. Rehabilitation continues in all divisions including dozer and handlines. Crews are working interior hotspots.

MIDDLE FORK COMPLEX, Beaverhead-Deerlodge National Forest. A Type II Incident Management Team (Swope) is assigned. These fires are 30 miles southwest of Philipsburg, MT. The complex consists of the Falls Creek, Cougar Creek, Coyote Springs, Medicine Lake, Skalkaho Pass, Lick Creek and Cooper Creek fires. Crews continued to make good progress on securing containment lines, mopup and cold trailing. Rehabilitation continues to progress along the fire perimeter.

ALDER CREEK, Lolo National Forest. This fire is 31 miles southeast of Missoula, MT. Crews continued with direct line and mopup. Aerial observation reported a few hot spots in the interior perimeter.

### EASTERN GREAT BASIN AREA LARGE FIRES:

CLEAR CREEK COMPLEX, Salmon-Challis National Forest. A Type I Incident Management Team (Stam) is assigned. This complex consists of the Clear

Creek, Marlin Springs, Full Circle and Sisters fires. The 3rd Battalion, 2nd Marines from Camp Lejeune, North Carolina, commanded by LTC Smith, is committed. Fire activity was moderate with occasional torching and short duration crown runs observed in some interior islands of unburned fuel. Short range spotting was also observed. Crews continue to patrol containment lines.

GREEN, Upper Snake River District, BLM. This fire is burning in sagebrush and timber 18 miles east of Rexburg, ID. Crews have made good progress towards containment objectives.

FONTENELLE, Bridger-Teton National Forest. This fire is 20 miles north of Kemmerer, WY. This is the last report unless new information is received.

SCF WILDERNESS, Salmon-Challis National Forest. Eleven wildland fires are currently burning within the Salmon Challis Wilderness Complex: Little Pistol, Indian Creek, Filly, Butts, Papoose, Parker, Packer Meadow, Shell Rock, Wilson Creek, Jackass and Jack Creek. Increased fire activity was observed with some torching and spotting noted on the Shellrock fire. Norton Lookout is being threatened and will be wrapped with fire resistant material.

NAVAJO MT. 1, Navajo Area Office, BIA. Crews continue to work on containment of slopovers.

SIERRA, Gila National Forest. This fire is near the Beaverhead Work Center. A Fire Use Management Team (Cook) is assigned and will also manage the Bloodgood incident. This lightning ignited wildland fire is being managed to accomplish resource objectives.

BLOODGOOD, Gila National Forest. This fire is located five miles southwest of the Gila Cliff Dwellings. The fire continues to be very active due to high temperatures and dry fuels.

ARROW, Apache-Sitgreaves National Forest. This fire is 5 miles south of Hannagan Meadow and is being managed to accomplish resource objectives.

Across Oklahoma, Texas and the Gulf Coast states a high pressure aloft and at the surface will keep the region very dry. High temperatures in Oklahoma, South Texas and the Gulf Coast states will range from the upper 70's to the lower 90's. Minimum afternoon humidities will be 20 to 30 percent inland and 30 to 45 percent along the immediate coast. Winds will be northeast to east at 10 to 15 mph.

A trough will move through the Northern Rockies which will bring some showers and thunderstorms to Idaho, Montana, western Wyoming, and northern Utah. Conditions will be dry behind the trough in Washington and Oregon. Utah, southern Wyoming, and Colorado will be warm, windy and dry ahead of the trough. The rest of the Southwest will be dry.

High temperatures in the west will range from the 70's and 80's in the north to the 90's and 100's in the south. Minimum humidities will generally be in the teens through the 30's with some single digits in the driest area in the south. Winds across the Pacific Northwest will be out of the northwest from 10 to 15 mph. Parts of Utah, Wyoming and Colorado will have winds out of the southwest at 15 to 25 mph, with gusts to 30 mph. The Southwest will have upslope, up valley, or southwest winds less than 15 mph.
