

INCIDENT MANAGEMENT SITUATION REPORT
 THURSDAY, NOVEMBER 9, 2000 - 0730 MST
 NATIONAL PREPAREDNESS LEVEL II

CURRENT SITUATION:

The Southern Area reported no new large fires. Initial attack activity was light in the south due to higher relative humidity and scattered showers. One large fire in North Carolina was contained. Very high to extreme fire indices were reported in North Carolina and Virginia.

SOUTHERN AREA LARGE FIRES:

NOLICHUCKY, Cherokee National Forest. A Type I Incident Management Team (Gage) is assigned. This complex consists of the Horsehitch, Rocky Top and Clark Creek fires in Greene County, TN. A total of two cabins and two outbuildings have been destroyed on the Horsehitch fire. Current priorities are firefighter and public safety and structure protection.

SHENANDOAH COMPLEX, Shenandoah National Park. A Type I Incident Management Team (Stutler) is assigned. This complex consists of the Pinnacles and the Old Rag fires, which are five miles southeast of Luray, VA. The burnout operation on the east flank of the fire has been completed. Mopup and rehabilitation operations have begun.

SOUTHEAST DISTRICT COMPLEX, Kentucky State Division of Forestry. A Type I Incident Management Team (Frye) is assigned. These fires are burning in hardwoods intermixed with pine and brush in several counties surrounding Pineville, KY. Crews are making good progress on fireline construction. A rehabilitation plan is being developed.

BRUSHY RIDGE COMPLEX, National Forests in North Carolina. A Type I Incident Management Team (Melton) is assigned. The Brushy Ridge and Chimney fires are burning in the Linville Gorge Wilderness 20 miles north of Marion, NC. Mopup and rehabilitation activities are underway. Highway 1238 remains closed to public travel.

BLEVINS, Cherokee National Forest. The fire is five miles west of Roan Mountain, TN. No new information was received.
