

INCIDENT MANAGEMENT SITUATION REPORT  
SUNDAY, OCTOBER 14, 2001- 0900 MDT  
NATIONAL PREPAREDNESS LEVEL 2

CURRENT SITUATION:

Initial attack activity was light nationwide. Very high to extreme fire indices were reported in California and Colorado.

EASTERN AREA SUPPORT:

NEW YORK CITY CACHE SUPPORT, Federal Emergency Management Agency. A Type 1 Incident Management Team (Lohrey) is assigned. The team is assigned to manage warehouse operations at Pier 36 and four distribution centers in New York City, NY.

DUANE STREET SUPPORT, Federal Emergency Management Agency. A Type 1 Incident Management Team (Stam) is assigned. The team will continue to offer incident planning support to the Fire Department of New York and fourteen other cooperating agencies at the Duane Street Fire Station.

SOUTHERN CALIFORNIA AREA LARGE FIRES:

STABLES, Angeles National Forest. This fire is one mile northeast of Santa Clarita, CA. A Type 2 Incident Management Team (Walker) is assigned, and a Unified Command with Los Angeles County is in place. The fire crossed control lines several times.

OUTLOOK:

High pressure over the Northern California Area continues to dominate, bringing sunny skies. High temperatures along the coast will be in the 60s with inland highs in the 80s and 90s. Minimum relative humidity will be 12 to 28 percent. Winds will be gusty and north to northeast at 10 to 25 mph.

The Southern California Area will continue to experience very warm temperatures with low relative humidities as a pacific ridge moves into the state. Temperatures will be in the 80s in the mountains and 90s in the inland valleys and deserts. Minimum relative humidity will be 5 to 15 percent. Winds will be northeast at 20 mph through some canyons and

passes, otherwise variable at 5 to 15 mph.
