

INCIDENT MANAGEMENT SITUATION REPORT  
 MONDAY, OCTOBER 29, 2001- 0530 MDT  
 NATIONAL PREPAREDNESS LEVEL 2

CURRENT SITUATION:

Initial attack activity was moderate in Southern Area and light elsewhere. Very high to extreme fire indices were reported in Arizona, California and Virginia.

EASTERN AREA SUPPORT:

DUANE STREET SUPPORT, Federal Emergency Management Agency. A Type 1 Incident Management Team (Stam) is assigned. The team will continue to provide planning support at the Duane Street Fire Station and logistics support to manage warehouse operations at Pier 36.

EASTERN AREA LARGE FIRES:

IRVING, State of Massachusetts. This fire, located in the Irving State Forest, is near Irving, MA. Access to the fire is difficult due to rugged terrain. Public access to the Irving State Forest is restricted. No further information was received.

REDBIRD FALL FIRES, Daniel Boone National Forest. This incident includes 13 fires and is nine miles east of Manchester, KY. Structure protection remains in effect. No new information received.

KERNS, George Washington and Jefferson National Forests. This fire is located four miles east of New Market, VA. No other information was received.

PAW PAW, Virginia State. This fire is near Paw Paw, VA. Several structures remain threatened. No further information was received.

OUTLOOK:

\*\*\* RED FLAG WARNING FOR MOST OF NORTHERN FLORIDA DUE TO LOW HUMIDITY. \*\*\*

High pressure over the Southern Area will bring mostly sunny weather. High temperatures in the 60s, except 70s over portions of Florida. Winds 5 to 15. Minimum relative humidity 25 to 35 percent in northern Florida, and 30 to 45 percent elsewhere.

An approaching trough will bring cooler temperatures and higher humidity for southern California. This trough is expected to bring the first significant precipitation to the area on Tuesday since last spring. It will be cloudy, with some areas of morning drizzle over the coastal slopes and valleys in the south and a chance of some rain in the north, slowly spreading southward. Temperatures will range from the 60s in the valleys and mid 50s to the low 60s in the mountains. Relative humidity will range from 40 to 50 percent. Winds will be from the southwest to west at 15 to 25 mph over the mountains and deserts, with higher winds over the crest of the Sierras.

A low pressure trough will move on shore, bringing rain to the Northern California Area. Snow level will be between 5,000 and 6,000 feet in the mountains. Maximum temperatures in the 40s to 50s. Winds south to southwest 10 to 20 mph, gusting to 30 to 35 mph on ridges. Minimum relative humidity 50 percent and above.
