INCIDENT MANAGEMENT SITUATION REPORT SATURDAY, NOVEMBER 17, 2001 - 0900 MST NATIONAL PREPAREDNESS LEVEL 2

CURRENT SITUATION:

Initial attack activity was moderate in the Southern Area and light elsewhere. Four new large fires were reported, three in Southern Area and one in Eastern Area. Four fires were contained, three in the Southern Area and two in the Eastern Area. Very high to extreme fire indices were reported in Indiana, New Hampshire, West Virginia, North Carolina, Kentucky, Montana, and Colorado.

SOUTHERN AREA LARGE FIRES:

LARMON, National Forests of North Carolina. A Type 1 Incident Management Team (Humphrey) is assigned. This fire is 2.5 miles northeast of Hot Springs, NC. Road closures and evacuations of private residences remain in effect. Threat continues to 66 primary residences and four outbuildings.

EASTERN DISTRICT COMPLEX, Kentucky Division of Forestry. This complex of 32 fires is located in six counties surrounding Betsy Lane, KY, and is under a unified command with a Type 2 Incident Management Team (Ferguson) and Kentucky Division of Forestry (Andersen). One new fire within the complex is being initial attacked. Containment was achieved on four new fires yesterday Pike county schools remain closed due smoke. Crews made good progress on several fires within this complex.

DISTRICT 2 RIDGECREST, Tennessee Division of Forestry. A Type 1 Incident Management Team (Raley) is assigned. A projected wind event the next two days could seriously affect containment expectations. Structure protection/evacuation plans are being developed with assistance of the Red Cross, Tennessee Emergency Management Authority and Sevierville County Sheriff's Office.

REDBIRD FALL FIRES, Daniel Boone National Forest. A Type 1 Incident Management Team (Bateman) is assigned and is working under a unified command with the Kentucky Division of Forestry. This complex of fires is located nine miles east of Manchester, KY. No significant change occurred.

CHATTAHOOCHEE FIRE SUPPORT, Chattahoochee-Oconee National Forest. A Type 1 Incident Management Team (Studebaker) is assigned. The Team is located nine miles north of Dahlonega, GA, and is providing initial attack and rehabilitation support on the Chattahoochee-Oconee NF, including the Glass Mine (915 acres), Cooper Gap (88 acres), Picklesimer Inc. (200 acres), and Blue Lake (35 acres) fires.

SHARP, Great Smoky Mountains National Park. This fire started 11/10, and is located within the Great Smoky Mountains National Park and on private land. The fire has not reached Nolan and Deep Creek drainages.

KENTUCKY RIVER COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Sloan) is assigned. This complex is located in nine

counties surrounding Hazard, KY. This complex had four new starts yesterday, the largest one was contained at 40 acres. The National Guard is assisting with helicopter water drops.

SOUTHEASTERN DISTRICT COMPLEX, Kentucky Division of Forestry. A Type 2 Incident Management Team (Farson) is assigned. This complex of fires is near Pikeville, Manchester and London, KY. No significant changes occurred.

NORTH END COMPLEX, Cherokee National Forest. This complex is located near Johnson City, TN., and includes the Green Mountain (2,200 acres), Peter's Cemetery (100 acres), Clark Creek (224 acres), Railroad Grade #4 (10 acres), Fork Mountain (2 acres), Pine Mountain (0.1 acre), Snake Spur (0.2 acre), and Snake Spur 2 (0.5 acre) fires. One new start occurred within this complex.

HIGH GROUNDS, Oklahoma Division of Forestry. This fire is six miles north of Hulbert, OK. Very little fire activity occurred yesterday.

ROCKY TOP, Oklahoma Division of Forestry. This fire is southeast of Stilwell, Oklahoma.

HILL TOP, Arkansas Forestry Commission. This fire is eight miles west-southwest of Harrison, AR. No significant changes occurred.

CLINCH MT., Virginia Department of Forestry. This fire is located near Gate City, VA. and is burning in steep and rugged terrain. Acreage adjustment is due to more accurate mapping. Burn out operations are underway.

GREAT GULF, Daniel Boone National Forest. This fire is located 20 miles southwest of Corbin, KY. No significant changes occurred. Burn out operations were successful.

EASTERN AREA LARGE FIRES:

PUNKIN, Mark Twain National Forest. This fire is seven miles northwest of West Plains, Missouri. The fire is burning in a mixed hardwood forest.

DRY FORK, Mark Twain National Forest. This fire is located five miles southwest of Fremont, MO. No significant changes have occurred.

DOGTAIL, New York Forest Rangers. This fire is located 18 miles east of Poughkeepsie, NY, and is burning in New York and Connecticut. No significant changes occurred.

WHITE OAK, West Virginia State Forestry. This fire is five miles from Gilbert, WV.

GRAPEVINE CREEK, West Virginia State Forestry. This fire is near Matewan, WV, and is currently in a patrol status.

HIGHWAY 218, Ohio Division of Forestry. This fire is located near Scottown, OH. The fire is burning on private land.

ROUND BOTTOM CREEK, West Virginia Commerce Forestry Division. This fire is near the town of Peytona, WV. The West Virginia National Guard is providing support.

SANDLICK BRANCH, West Virginia Commerce Forestry Division. This fire is located in Logan County, WV. The West Virginia National Guard is providing support.

HEAD OF TRACE BRANCH OF MILL CREEK, West Virginia Commerce Forestry Division. This fire is located close to Fort Gay, WV, and is burning near a residential area. Smoke and traffic are hampering suppression efforts.

High pressure will maintain its grip over a majority of the Southern Area today. Low pressure and an onshore flow of Gulf moisture will continue to affect a large portion of Texas and Oklahoma, with scattered showers and thunderstorms forecasted for the region. Flash flood watches are in effect for portions of south Texas through Saturday. Patchy morning fog with mostly sunny and mild conditions will prevail later today from Kentucky, Tennessee, and Mississippi eastward to the Atlantic. Scattered clouds and a few showers may reach western Louisiana and Arkansas. Temperatures will be in the mid 60s to near 70, with lower 80s in Florida. Minimum relative humidity will be 27 to 37 percent in the southern Appalachian Mountains and vicinity, 40 to 60 percent in the rest of the region, and 70 percent in some portions of Texas and Oklahoma. Winds will be light and variable in the southern Appalachian Mountains and vicinity. Winds will be north to northeast at 5 to 10 mph from the Carolinas through northern Florida, and northeast at 10 to 20 mph for the remainder of Florida. Winds will be east to southeast at 5 to 10 mph from Alabama westward. Precipitation amounts of 1/10 to 1 / 2 inch are possible across the area, with up to 2 inches possible in Texas.

A weak trough will move through the central portion of southern California with a little cooler weather expected. Expect partly cloudy conditions to the north and mostly sunny conditions to the south. Maximum temperatures will be in the 60s for the mountains, 70s for the valleys, and low 80s in the deserts. Minimum relative humidities will be 25 to 35 percent. Winds will be south to southwest at 10 to 15 mph.
