INCIDENT MANAGEMENT SITUATION REPORT WEDNESDAY, SEPTEMBER 11, 2002 0530 MDT NATIONAL PREPAREDNESS LEVEL 3

CURRENT SITUATION:

Initial attack activity was light across the nation. Nationally, 122 new fires were reported. No new large fires were reported. Very high to extreme fire indices were reported in Arizona, California, Colorado, Idaho, Kansas, Maine, Montana, Nebraska, Nevada, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming.

SOUTHERN CALIFORNIA AREA LARGE FIRES:

CURVE, Angeles National Forest. A Type 1 Incident Management Team (Studebaker) is assigned. This fire is 30 miles north of Azusa, CA. Slow rates of spread with isolated torching and spotting were observed in mixed conifer forest and heavy brush in the Iron Creek drainage. Crews are mopping up and burning out. Limited access and steep terrain are hampering containment efforts. Two hundred buildings are threatened; structure protection is in place. Highway 2 is closed. Reduction in acreage was due to better mapping.

MOUNTAIN, Los Angeles County. This fire is within the city limits of Glendale, CA and is burning in grass and brush. Rapid rates of spread with extreme fire behavior were observed. Crews and engines are holding and providing structure protection for 200 threatened residences and 10 commercial properties.

ROCKY MOUNTAIN AREA LARGE FIRES:

MT. ZIRKEL COMPLEX, Routt National Forest. A transfer of command from Bennett's Type 1 Incident Management Team to a Type 3 organization will occur today at 1200. This complex, comprised of the Burn Ridge and Hinman fires, is 25 miles north of Steamboat Springs, CO. Smouldering and creeping were observed in heavy dead and down spruce, lodgepole pine and fir. Personnel are patrolling and mopping up.

BIG FISH, White River National Forest. A Fire Use Management Team (Cook) is assigned. The Team is also managing the Lost Lakes fire. This lightning-caused Wildland Fire Use Incident, which began on July 19th, is 34 miles southwest of Steamboat Springs, CO. The fire is being managed for resource benefit and a confinement strategy is in place. Favorable weather conditions minimized fire behavior in heavy dead and down spruce, fir and aspen. Personnel completed installation of hoselays and sprinkler systems from Paradise Creek to Mirror Creek.

LOST LAKES, Routt National Forest. A Fire Use Management Team (Cook) is assigned. This lightning-caused Wildland Fire Use Incident, which began on July 8th, is 20 miles west of Yampa, CO and is burning in heavy dead and down spruce and fir. The fire is in monitor status and is being managed for resource benefit.

OUTLOOK:

The Southern California Area can expect mostly sunny skies with a chance of afternoon showers and thunderstorms in the eastern deserts. High temperatures will be in the mid 70's to mid 80's in coastal areas, 70's to near 90 in the mountains, 90's in the valleys and in the low 90's to 102 in the deserts. Minimum relative humidity will range from 7 to 20 percent in the mountains and deserts, 10 to 25 percent in the inland valleys, and above 45 percent near the coast. Winds will be northwest at 6 to 12 mph in the mountains, south to west at 7 to 15 mph in the deserts, and onshore at 7 to 15 mph along the coast.

An upper level low pressure system moving across the Rocky Mountain Area will bring showers and thunderstorms. High temperatures will be 55 to 65 in the mountains and 70 to 80 at lower elevations. Minimum relative humidity will range from 25 to 35 percent. Winds will be variable at 5 to 15 mph.

LOOKOUTS

Lookouts are often better situated to notice the cumulative changes of fire behavior.

- Fire Order #8 says, "Establish lookouts in potentially hazardous situations." Should you utilize lookouts at all times?
 - X Lookouts should be posted at all times.
- What are you looking for when you are selecting a lookout location?
 - X Choose a good vantage point, preferably with a good overview of the entire area where firefighters are located, including escape routes and safety zones.
 - <u>X</u> <u>Utilize aircraft, but have an alternative on the ground.</u>
- What are the desired qualities, capabilities, knowledge, and responsibilities of a lookout person?
 - <u>X</u> <u>Experienced firefighter.</u>
 - <u>X</u> <u>Solid knowledge of fire behavior and ability to recognized and monitor other environmental hazards.</u>
 - X Good communicator--keeps the crew advised of fire behavior changes, tracks weather trends and relays the information, informs crew of work progress and updates from the latest strategy and tactical briefings.
 - <u>Monitors and accounts for all individuals within his/her assigned area at all times, and will notify others if breaks are needed.</u>
- What is the necessary equipment for a lookout?
 - <u>PPE, radio with extra batteries, compass, binoculars, belt weather kit, IAP, map, food, and water.</u>
