INCIDENT MANAGEMENT SITUATION REPORT SUNDAY OCTOBER 3, 2004 – 0800 MDT NATIONAL PREPAREDNESS LEVEL 2

CURRENT SITUATION:

Initial attack activity was light nationally with 41 new fires reported. Very high to extreme fire indices were reported in Arizona, California, Nebraska and Wyoming.

Presidential Disaster Declarations have been issued for Hurricane Frances in Florida on 9/4; for Hurricane Ivan in Alabama, Florida, Louisiana and Mississippi on 9/16; and for Hurricane Jeanne in Florida on 9/26. An Area Command Team (Zimmerman) is assigned to the Florida Disaster Field Office, Orlando, FL. Numerous resources have been mobilized as part of the relief effort, including aviation assets, mobile caterers and showers, national buying teams, crews and miscellaneous overhead personnel.

SOUTHERN AREA INCIDENTS:

HURRICANE FRANCES / IVAN RESPONSE, Federal Emergency Management Agency (FEMA). A Type 1 Incident Management Team (Hart) is managing a base camp at Saufley Field Naval Air Station in Pensacola, FL. A Georgia Type 2 Incident Management Team (Kline) is assigned to Saufley Field Naval Air Station in Pensacola, FL, and is supporting the receiving and distribution of relief supplies. A Type 2 Incident Management Team (Mullenix) is managing a base camp in Brewton, AL, supporting the receiving and distribution of supplies and debris removal in central Alabama.

HURRICANE JEANNE RESPONSE, Federal Emergency Management Agency (FEMA). A Type 1 Incident Management Team (Kearney) is managing a base camp in Martin County, FL. A Type 1 Incident Management Team (Frye) is assigned to the Jacksonville Naval Air Station, Jacksonville, FL and is supporting the receiving and distribution of relief supplies.

HURRICANE JEANNE RECOVERY, State of Florida. Three Florida Division of Forestry Type 2 Incident Management Teams (Beauchamp, Johnson and Jones) are assigned in Indian River, St. Lucie and Polk Counties, FL, and are managing the distribution of relief supplies.

HURRICANE IVAN RECOVERY, Gulf Islands National Seashore. A National Park Service All-Risk Incident Management Team (Wissinger) is assigned. The Team is managing clean-up and recovery efforts.

OUTLOOK:

Weather Discussion: High pressure will firmly establish itself over the West today. The only remaining area of organized thunderstorms will be concentrated over the Four Corners region. There is also a slight chance of thunderstorms over the California Sierra Crest. Elsewhere, conditions will be dry and warm with temperatures well above normal for this time of year.
