INCIDENT MANAGEMENT SITUATION REPORT SUNDAY, JULY 9, 2006 – 0800 MDT NATIONAL PREPAREDNESS LEVEL 3

CURRENT SITUATION:

Initial attack activity was light nationally with 196 new fires reported. Seven new large fires (*) were reported, five in the Western Great Basin Area and one each in the Southern California and Eastern Great Basin Areas. Three large fires were contained, two in the Eastern Great Basin Area and one in the Southern California Area. Very high to extreme fire indices were reported in Arizona, California, Minnesota, Montana, Nebraska, Nevada, North Dakota, South Dakota and Utah

A Type 1 Incident Management Team (Opliger) is assigned to incident C10157, 60 kilometers west of Quesnel, British Columbia, Canada.

WESTERN GREAT BASIN AREA INCIDENTS/LARGE FIRES:

BEATTY, Battle Mountain Field Office, Bureau of Land Management. This fire is six miles northeast of Beatty, NV in brush and grass. Limited access is hampering containment.

MCCONNELL, Winnemucca Field Office, Bureau of Land Management. This fire is four miles from Orvada, NV in grass and sage. Thunderstorms and active fire behavior are hindering containment.

CYANCO. Winnemucca Field Office, Bureau of Land Management. This fire is 10 miles south of Winnemucca, NV burning in grass and brush. Active fire behavior with rapid rates of spread was observed.

LINCOLN COUNTY COMPLEX, Ely Field Office, Bureau of Land Management. A Type 2 Incident Management Team (Suwyn) is assigned. This complex is ten miles south of Caliente, NV in grass, sagebrush, juniper and pinyon pine. Smoldering was reported.

SAWTOOTH, Battle Mountain Field Office, Bureau of Land Management. This fire is four miles northwest of Beatty, NV in grass. A ranch and a radio tower are threatened. Extreme fire behavior was reported.

BLUE MOUNTAIN, Winnemucca Field Office, Bureau of Land Management. This fire is 16 miles west of Winnemucca, NV in grass. Extreme fire behavior was reported.
