Columbia Complex, Southeast, Washington DNR. IMT 1 (Lohrey). Fifteen miles northeast of Walla Walla, WA. Grass, brush and timber. Single and group torching and short uphill runs. Residences, a ski area and commercial resources threatened. Evacuation orders in effect.

Polallie, Okanogan-Wenatchee NF. IMT 2 (Reed). Fifteen miles northwest of Cle Elum, WA. Subalpine fir, lodgepole pine and brush. Minimal fire behavior. Residences, Forest Service structures and campgrounds threatened. Forest road closures in effect.

Twin Lakes Complex (two fires), Wallowa-Whitman NF. IMT 2 (Lunde). Twenty-one miles southeast of Joseph, OR. Timber. Moderate fire behavior. Structures, mine sites and fisheries habitat threatened. Community of Cornucopia evacuated
