Area Command Team (Rounsaville) assigned to assist in creating a strategic plan for suppression action in Florida.

Florida Bugaboo, National Forests in Florida. IMT 1 (Quesinberry) and NIMO (Ferguson). Baker County, FL. Southern rough. Extreme fire behavior with torching and spotting. Numerous structures in several communities remain threatened.

Bugaboo Scrub, Okefenokee NWR. Sixteen miles west of Folkston, GA.. Southern rough and timber. Moderate to extreme fire activity with torching. Numerous structures remain threatened.

Bugaboo Srub 2, Georgia Forestry Commission. IMT 2 (Hannemann). IMT also managing the Sweat Farm Road fire. Started on private land five miles east of Fargo, GA. Southern rough and timber. High rates of spread, torching and spotting.

Dairy Road, Florida DOF. Seven miles northwest of Keystone Heights, FL. Timber and brush. Extreme fire behavior. Numerous residences threatened. Reduction in acreage due to more accurate mapping.

Big Turnaround Complex, Okefenokee NWR. IMT 1 (Ruggiero). Ten miles southeast of Waycross, GA. Southern rough and timber. Moderate to extreme fire behavior with widespread torching. Folkston and surrounding communities remain threatened.

BICY Complex, Big Cypress National Preserve. IMT 1 (Stanich). Sunniland, FL. Includes previously reported Strickland, FT6, Midrest and Trail fires. Southern rough. Spotting. Numerous structures threatened.

Balsa, Florida DOF. Started on private land five miles east of Naples, FL. Palmetto and brush. No further information received.

Airport Road, Florida DOF. IMT 2 (Utley). IMT also managing the Red Oak and Lee House. Three miles southwest of Ormond Beach, FL. Hardwood litter. Smoldering.

Roundabout Swamp, Georgia Forestry Commission. Started on private land four miles west of Pearson, GA. Southern rough and timber.

Sweat Farm Road, Georgia Forestry Commission. Started on private land 10 miles west of Waycross, GA. Southern rough and timber. Backing fire and reburning. State park remains threatened.

Knee Knocker Swamp, Georgia Forestry Commission. One mile northwest of Nahunta, GA. Southern rough and logging slash. Structures remain threatened. Active surface fire.

Lee House, Florida DOF. Started on private land three miles southeast of Cassia, FL. Southern rough. Minimal. Acreage correction in table.

Fakahatchee, Florida DOF. Six miles southwest of Miles City, FL. Timber and palmetto. Backing with occasional run. No further information received.

Middle of Nowhere, Florida DOF. Charlotte County, FL. Southern rough. Spotting. Active fire spread.

Cherokee Road, Florida DOF. Four miles southeast of Gateway, FL. Palmetto and pine. No new information.

Dregger, Georgia Forestry Commission. Five miles south of Glennville, GA. Southern rough and palmetto. Minimal fire activity. No new information. Last report unless new information is received.

Red Oak, Florida DOF. Started on private land two miles southwest of Pine Lakes, FL. Brush. Minimal fire activity.

Target, Florida DOF. Ten miles southeast of Saint Cloud, FL. Southern rough. No further information.

Green Valley, Florida DOF. Started on private land thirteen miles north of Winter Haven, FL. Brush. Minimal fire activity.

Mother's Day, Florida DOF. Twelve miles northwest of Pensacola, FL. Timber and brush. Spotting.

Compa, Florida Panther National Wildlife Refuge. Twenty-five miles east of Naples, FL. Timber and grass. Active surface fire.

IN COUNTRY NOT SEEN IN DAYLIGHT

Often firefighers arrive on a fire after dark. This is recognized as Watchout Situation #2. Before safely fighting fire in country not seen in daylight, firefighters must be able to answer the following questions:

- Can the resources you are replacing give you a thorough briefing? Identify whom you might get information from. Can you meet up with the departing crew/engine leaders?
- Can you observe the area/use scouts? List ways you could observe the area you need to work.
- Have escape routes and safety zones been thoroughly scouted and marked for night use? Talk about what constitutes an escape route and a safety zone; who would identify them; and in what ways might they be marked.
- Have potential dangers been located; can they be mitigated? What are the dangers associated with Watchout Situation #2? How can they be worked around?
- Reduce the risks by:
 - Posting lookouts.
 - Checking communications.
 - Retreat if you have doubts about your escape routes or safety zones or the situation becomes too complex. Give examples of arriving on a fire after dark and what was done to allow you to fight fire safely in country not seen in daylight.
