**Florida Bugaboo**, National Forests in Florida. Unified Command between NIMO (Ferguson) and Florida IMT 2 (Beauchamp). Baker County, FL. Southern rough. Moderate fire activity. Several communities remain threatened. Increase in acreage due to more accurate mapping.

**Sweat Farm Road**, Georgia Forestry Commission. North Carolina IMT 2 (Hildreth). IMT also managing the Bugaboo Scrub 2, Roundabout Swamp and Kneeknocker Swamp fires. Started on private land ten miles west of Waycross, GA. Southern rough and timber. Crowning and spotting. Residences threatened.

**Big Turnaround Complex**, Okefenokee NWR. IMT 1 (Oltrogge). Ten miles southeast of Waycross, GA. Southern rough and timber. Active fire behavior. Large acreage growth due to burn out operations. Structures, historic sites and recreation facilities remain threatened.

**BICY Complex** (five fires), Big Cypress National Preserve. IMT 1 (Stanich). IMT 1 (Whitney) ordered. Fiftyone miles west of Ft. Lauderdale, FL. Southern rough. Running. Traffic flow remains impacted on I-75.

**Bugaboo Scrub 2**, Georgia Forestry Commission. Started on private land five miles east of Fargo, GA. Southern rough and timber. Low intensity fire behavior.

**Roundabout Swamp**, Georgia Forestry Commission. Started on private land four miles west of Pearson, GA. Southern rough and timber. Minimal fire activity.

**Knee Knocker Swamp**, Georgia Forestry Commission. One mile northwest of Nahunta, GA. Southern rough. Minimal fire activity.

**Dairy Road**, Florida DOF. Seven miles northwest of Keystone Heights, FL. Southern rough. Minimal fire activity.

**Deland Complex** (five fires), Florida DOF. Six miles west of Ormond Beach. Southern rough. Active interior burning.

**Paterson**, Florida DOF. Eighteen miles east of Lehigh Acres, FL. Southern rough. Moderate fire activity with spotting.

**Stag Road,** North Carolina DOF. Five miles north of Hampstead, NC. Chaparral. Running, torching and spotting. Voluntary evacuations in effect.

**Burgandy Road,** Florida DOF. Eight miles east of Carlos Park, FL. Southern rough. Spotting. Residences threatened. Voluntary evacuations.

Callaway Height, Florida DOF. Eight miles northeast of Callaway, FL. Southern rough. Minimal fire activity.

**Chestnut Mountain,** Chattahoochee-Oconee NF. Eight miles southwest of Blairsville, GA. Hardwood litter. Moderate fire activity.

**St. George Break**, Georgia Forestry Commission. Three miles west of St. George, GA. Southern rough and timber. No new information.

**Buck Shank**, Great Smoky Mountains National Park. Ten miles south of Maryville, TN. Hardwood litter. No new information.

#### **RESPONDING TO VEHICLE FIRES**

Suppression of vehicle fires is extremely dangerous and poses many health hazards to firefighters. The following procedures are recommended:

- Secure the scene and provide or request assistance for traffic control.
- Provide for your escape route at the scene.
- Do not use road flares if fuel is leaking from the vehicle or if wildland fuel is nearby.
- Vehicle fires are considered a hazardous materials scene. Suppression action should only be taken if the crew is trained, equipped, and authorized in the use of Self-Contained Breathing Apparatuses (SCBA).
- If taking suppression action on wildland fuels, firefighters should ensure that they are a safe distance from the burning vehicle (100-feet minimum), and avoid contact with vehicle fire smoke or fumes.
