Pole Creek, Teton Dispatch Counties. One mile northeast of Pinedale, WY. Brush. Running fire behavior. Structures threatened. Evacuations in effect.

Salt Lick, Bridger-Teton NF. IMT 2 (Suwyn). Twenty-five miles north of Pinedale, WY. Timber. Extreme fire behavior.

Milford Flat, Southwest Area, Utah State Division of Forestry Fire & State Lands. IMT 1 (Muir). Three miles north of Milford, UT. Grass and brush. Isolated torching and creeping.

Black Pine 2, Sawtooth NF. IMT 2 (Grant). Started on private land eleven miles southeast of Malta, ID. Grass, brush and juniper. Short crown runs, backing and flanking fire. Structures remain threatened.

Mathis, Southeast Area, Utah State Division of Forestry Fire & State Lands. IMT 2 (Harvey). Nine miles north of Price, UT. Grass, juniper and timber. Minimal fire behavior. Coal mines, methane gas wells, and numerous residences remain threatened.

Black Rock Gulch, Arizona Strip Field Office, BLM. IMT 2 (Lund). Thirty miles south of St. George, UT. Grass, brush, juniper and timber. No active fire spread. Structures remain threatened.

Greenville, Cedar City Field Office, BLM. Six miles southwest of Beaver, UT. Brush, slash and juniper. Creeping with isolated torching. Interstate 15 remains threatened.

- Is the observed fire weather consistent with the forecast?
- Have you established a new organizational structure and communicated it to the other forces associated with the fire?
- Can you control the fire with the resources available (either on the incident or soon to be on the incident) under expected conditions?
- Have you developed a plan to attack the fire?
 - Direct or indirect
 - Anchor points
 - Escape routes
 - Head or flank attack
 - Priority areas
- Have you communicated this to all personnel assigned to the incident, including new arrivals?
- Can you see all of the fire area?
- Can you communicate with everyone on the fire and with dispatch?
- Are escape routes established?
 - If you are using the black, is it completely burned and without a reburn potential?
- Are safety and the standard fire orders being followed?
- Will you contain the fire before the next operational period?
- Have you reported the status of the fire to dispatch?
- Do you have a complete list of what resources have been ordered for the fire?
