Milford Flat, Southwest Area, Utah State Division of Forestry Fire & State Lands. IMT 1 (Muir). Three miles north of Milford, UT. Grass and brush. Isolated torching and creeping.

Black Pine 2, Sawtooth NF. IMT 2 (Grant). Started on private land eleven miles southeast of Malta, ID. Grass, brush and juniper. Short crown runs, backing and flanking fire. Structures remain threatened.

Salt Lick, Bridger-Teton NF. IMT 2 (Suwyn). Twenty-five miles north of Pinedale, WY. Timber. Creeping fire with isolated torching. Structures threatened. Road closures and evacuations in effect. Precipitation occurred over the fire area yesterday.

Greenville, Cedar City Field Office, BLM. Six miles southwest of Beaver, UT. Brush, slash and juniper. Creeping with isolated torching. Structures and Interstate 15 remains threatened.

Black Rock Gulch, Arizona Strip Field Office, BLM. Transfer of command from IMT 2 (Lund) back to local unit on 7/15. Thirty miles south of St. George, UT. Grass, brush, juniper and timber. Hot spots along perimeter but minimal fire spread. Structures remain threatened. Increase in acreage due to more accurate mapping.

Tongue Complex (three fires), Boise District, BLM. IMT 2 (Johnson). IMT also managing the Boulder Creek fire. Forty-five miles south of Silver City, ID. Brush, grass and juniper. Active fire behavior. Structures remain threatened.

Boulder Creek, Boise District, BLM. Eight miles south of Silver City, ID. Grass, brush and juniper. Minimal fire behavior. Structures remain threatened.

Neola North, Uintah and Ouray Agency, BIA. Three miles north of Neola, UT. Brush and timber. Active burning in pockets with occasional torching.

Bohannon, Idaho Falls District, BLM. FUMT (Ourada/Soper). Ten miles northeast of Salmon, ID. Timber. Creeping fire.

Zena Creek, Payette NF. IMT 2 (Heintz). Twenty-five miles northeast of McCall, ID. Timber litter. Moderate fire behavior with single tree torching.

Pole Creek, Sublette County. One mile east of Pinedale, WY. Grass and brush. Creeping fire behavior with interior runs. Structures threatened. Evacuations lifted.

Johnson East, Bear River Area, Utah State Division of Forestry Fire & State Lands. Twelve miles northwest of Tremonton, UT. Grass and brush. Running fire.

Jungle, Manti-Lasal NF. Thirteen miles west of Ferron, UT. Timber litter and spruce. No new information. Last report unless new information is received.

Tag WFU, Payette NF. Previously reported WFU incident. Forty-four miles northeast of Yellowpine, ID. Grass, brush. Active ground fire. Last narrative report unless significant activity occurs.
