Area Command Team (Ribar) is assigned to manage large fires for the Boise National Forest.

Murphy Complex, Twin Falls District, BLM. IMT 1 (Hawkins). Fifty-six miles southwest of Twin Falls, ID. Brush and juniper. Moderate fire activity with some running. Numerous communities and ranches remain threatened. Evacuation of Jarbidge remains in effect. Reduction in acreage due to more accurate mapping.

Salt Creek, South Central Area, Utah Division of Forestry. IMT 1 (Ruggiero). Five miles east of Nephi, UT. Chaparral, timber and grass. Extreme wind-driven fire behavior with rapid rates of spread in some areas. Precipitation resulted in smoldering and creeping in other areas. Structures remain threatened.

Dakota Hill (five fires), Zion NP. IMT 2 (Sciacca). Twelve miles north of Springdale, UT. Hardwood litter, dead and down timber, grass. Minimal fire behavior with smoldering and creeping. Structures remain threatened. Evacuations on North Fork Road and road closures remain in effect.

East Zone Complex (three fires), Payette NF. IMT 2 (Heintz). IMT 1 (Pincha-Tulley) ordered. Thirty-two miles northeast of McCall, ID. Timber litter. Moderate fire behavior with torching. Bridges, campgrounds and numerous structures remain threatened.

Granite, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber, grass, dead and down timber. Structures remain threatened. No further information received.

Middle Fork Complex (40 fires), Boise NF. IMT 2 (Whalen). Eighteen miles northeast of Lowman, ID. Timber and brush. Group torching, long-range spotting and moderate surface burning. Structures remain threatened.

Tongue Complex (three fires), Boise District, BLM. IMT 2 (Johnson). Forty-five miles south of Silver City, ID. Brush, grass and juniper. Light fire activity with torching.

Paradise, Cedar City Field Office, BLM. Ten miles northwest of Modena, UT. Timber, brush and grass. Backing fires, running and torching. Structures remain threatened.

Cascade Complex (17 fires), Boise NF. IMT 2 (Suwyn). IMT 1 (Opliger) ordered. Three miles northeast of Cascade, ID. Timber. Active fire behavior. Structures remain threatened.

Kimbell, Salt Lake Field Office, BLM. Seven miles northwest of Grantsville, UT. Timber and grass. Active fire behavior with running and torching. Reduction in acreage due to more accurate mapping.

Pearlie, Boise District, BLM. Six miles northeast of Parma, ID. Short grass. Active fire behavior with running. Communication tower and power lines threatened.

Trapper Ridge, Boise NF. FUMT (Hahnenberg). Twenty-eight miles northeast of Idaho City, ID. Timber litter. Active fire behavior with torching and moderate rates of spread.

Van Horn, Salmon-Challis NF. Fifteen miles north of Challis, ID. Timber litter, snags, dead and down timber. Creeping and torching. Structures remain threatened.

Black Pine 2, Sawtooth NF. Started on private land eleven miles southeast of Malta, ID. Grass, brush, pinyon pine and juniper. Running, torching with spotting.

North Fork, South Idaho Timber Protective Association, Idaho Department of Lands. Fourteen miles southeast of Donnelly, ID. Timber, heavy dead and downed logs and snags. Short runs and individual tree torching.

Krassel Complex (5 fires), Payette NF. FUMT (Perkins). Forty-four miles northeast of Yellow Pine, ID. Grass, brush, timber litter and downed logs. Moderate fire activity with short runs.

Jim Canyon, Sawtooth NF. Seven miles west of Curlew, ID. Brush, juniper and grass. No new information.

Predictive Services Discussion: Thunderstorm activity increasing and becoming wetter the next couple of days. The number and coverage of thunderstorms will be on the increase as monsoon moisture spreads into the West increasing relative humidity in many locations. Thunderstorms are expected to be mostly wet today and will develop over the Four Corner states, the Great Basin, southern California, the Sierra Nevada mountains, southeast Oregon, Montana and Wyoming. Hot conditions will continue today across Montana into the northern Great Plains in combination with windy conditions.

THUNDERSTORM SAFETY

Thunderstorms cause significant hazards for wildland firefighters, including downbursts that can cause extreme fire behavior and lightning. When thunderstorm development is likely, lookouts should be posted and aware of signs of a developing storm. A sudden reversal in wind direction, a noticeable rise in wind speed, and a sharp drop in temperature may note the mature stage of a storm. Heavy rain, hail and lightning occur only in the mature stage of a thunderstorm. During a storm, use the following guidelines:

- Do not lie down.
 - The best position is sitting on the pack or crouching with feet close together.
 - Avoid sitting directly on the ground, if possible; but, if necessary, keep feet and butt close together.
 - Avoid grouping together. Keep a minimum of 15 feet between people when possible.
 - Removing caulk boots will not provide safety if stocking covered or bare feet are then in contact with the ground--don't bother!
- "Stay out of dry creek beds" is correct for flash floods, but has nothing to do with lightning.
- Handheld radios (with short rubber antennas) or cell phones are safe to use. Communication is vital to crew safety. Do not use land line radios or radios with elevated antennas.
- Wide, open spaces are better than trees or clumps of trees in the vicinity. Ridge tops, etc., should be avoided.
- If you feel the hair on your arms or head "stand up," there is a high probability of a strike in the vicinity. Crouch or sit on a pack.
- Put down all tools.
- Take shelter in vehicles if possible.
