Area Command Team (Zimmerman) is assigned to assist the Northern Rockies with analyzing assessments for long duration fires and emerging incidents.

**Jocko Lakes**, Flathead Agency, BIA. IMT 2 (McNitt) and IMT 1 (Wilcock). Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole. Backing fire with short runs. Community of Seeley Lake and numerous structures threatened. Evacuations and Highway 83 restrictions in effect. Reduction in acreage due to more accurate mapping.

**Skyland,** Flathead NF. Transfer of command from IMT 2 (LaFave) to IMT 1 (Pendleton) tomorrow. Thirty-two miles east of Kalispell, MT. Timber and grass. Backing fire with some spotting. Structures threatened.

**Chippy Creek**, Northwestern Land Office, Montana DNR. IMT 2 (Raley). Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole and logging slash. Extreme fire behavior with group tree torching. Structures threatened.

**Ahorn**, Lewis and Clark NF. IMT 1 (Whitney). Thirty miles west of Augusta, MT. Timber. Creeping and smoldering with group tree torching. Structures threatened.

**Meriwether**, Helena NF. IMT 1 (Oltrogge). Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Backing fire and spotting. Structures threatened.

**Rattlesnake**, Nez Perce NF. IMT 2 (Secrest). Twenty-five miles south of Elk City, ID. Timber and grass. Active surface fire with isolated torching. Community of Comstock threatened.

**Sawmill Complex** (three fires), Lolo NF. IMT 2 (Heintz). Twenty-two miles southeast of Missoula, MT. Timber. Moderate fire behavior with uphill runs, torching and backing fire. Structures threatened. Evacuations in effect.

**Brush Creek**, Flathead NF. IMT 2 (Koehler). Twenty-five miles west of Whitefish, MT. Timber. Uphill crown runs with long range-spotting. Structures threatened.

**Tin Cup,** Bitterroot NF. IMT 2 (Kaage). Four miles west of Darby, MT. Timber and logging slash. Crowning, torching and spotting with active backing fire. Structures threatened. Evacuations in effect.

**Rombo Mountain**, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Bug-killed timber. Crown runs, group tree torching and spotting. Structures threatened.

**Echo Springs**, West St. Joe Area Office, Idaho Department of Lands. Six miles southwest of St. Maries, ID. Timber and logging slash. No new information.

**Bridge**, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber. Short crown runs with long-range spotting.

**Poe Cabin,** Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Sciacca). Twenty-three miles southwest of Grangeville, ID. Timber and grass. Isolated torching and creeping.

**Fool Creek**, Lewis and Clark NF. Thirty miles northwest of Choteau, MT. Timber and snags. Surface fire with short crown runs and isolated torching. Structures threatened.

**Conger Creek**, Lolo NF. Twenty miles north of Ovando, MT. Timber. Moderate fire behavior with torching, spotting and backing. Structures threatened.

**Pattengail Creek**, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and downed fuels. Surface fire with group tree torching and spotting.

**Chimney Complex**, Craig Mountain Area Office, Idaho Department of Lands. Nineteen miles south of Lewiston, ID. Timber and grass. Creeping, smoldering and isolated torching.

**Porcupine,** Gallatin NF. Thirty-one miles north of Livingston, MT. Timber. Smoldering. Precipitation occurred over the fire area yesterday. Last report unless significant activity occurs.

**Garceau**, Flathead Agency, BIA. Fifty-five miles south of Whitefish, MT. Timber and grass. No new information. Last report unless new information is received.

**Owl**, Yellowstone NP. Forty-five miles south of Bozeman, MT. Timber and grass. No new information. Last report unless new information is received.

Area Command Team is assigned to manage large fires for the Boise and Payette National Forests. Transfer of command from Area Command Team (Ribar) to Area Command Team (Loach) on 8/9.

**Cascade Complex** (six fires), Boise NF. Transfer of command from IMT 1 (Opliger) to IMT 1 (Broyles) ongoing. Three miles northeast of Cascade, ID. Timber. Moderate fire behavior with torching and short-range spotting. Community of Yellow Pine and numerous structures threatened.

**East Zone Complex** (three fires), Payette NF. Transfer of command from IMT 1 (Pincha-Tulley) to NIMO (Ferguson) tomorrow. Thirty miles northeast of McCall, ID. Timber, brush and grass. Active fire behavior torching and long-range spotting. Communities of Secesh and Warren, historic sites and bridges threatened.

**Combine,** Idaho Falls District, BLM. Started on private land thirty-one miles south of American Falls, ID. Brush. Extreme fire behavior with running. Structures threatened.

**Raines**, Payette NF. Transfer of command from FUMT (Ourada/Soper) to NIMO (Ferguson) tomorrow. FUMT is also managing the Krassel Complex. Thirty-eight miles northeast of McCall, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with torching and short runs. Structures threatened. Reduction in acreage due to assignment of the northern portion of this fire to the Rattlesnake fire.

**Shower Bath**, Salmon-Challis NF. IMT 2 (Saleen). Eighteen miles northwest of Challis, ID. Timber. Group tree torching.

**Middle Fork Complex** (four fires), Boise NF. Transfer of command from IMT 2 (Harvey) to IMT 2 (Lund) today. Fifteen miles northeast of Garden Valley, ID. Timber and brush. Active surface fire with torching and spotting. Structures threatened.

#### Wildland Urban Interface Hazards

Firefighters in the wildland urban interface may encounter hazards other than the fire itself, such as hazardous materials, utility lines and poor access.

#### Hazardous Materials

Common chemicals used around the home may be a direct hazard to firefighters from flammability, explosion potential and/or vapors or off-gassing. Such chemicals include paint, varnish and other flammable liquids; fertilizer; pesticides; cleansers; aerosol cans, fireworks, batteries and ammunition. In addition, some common household products such as plastics may give off very toxic fumes when they burn. Stay OUT of the smoke from burning structures and any unknown sources such as trash piles.

#### Illicit Activities

Marijuana plantations or drug production labs may be found in wildland urban interface areas.
 Extremely hazardous materials such as propane tanks and flammable/toxic chemicals may be encountered, as well as booby traps.

#### Propane tanks

• Both large (household size) and small (gas grill size) liquefied propane gas (LPG) tanks can present hazards to firefighters, including explosion. See the "LPG Tank Hazards" discussion for details.

#### Utility lines

• Utility lines may be located above and below ground and may be cut or damaged by tools or equipment. Don't spray water on utility lines or boxes.

#### Septic tanks and fields

• Below-ground structures may not be readily apparent and may not support the weight of engines or other apparatus.

#### New construction materials

Many new construction materials have comparatively low melting points and may "off-gas"
extremely hazardous vapors. Plastic decking materials that resemble wood are becoming more
common and may begin softening and losing structural strength at 180° F, though they normally do
not sustain combustion once direct flame is removed. However, if they continue to burn they exhibit
the characteristics of flammable liquids.

#### Pets and livestock

 Pets and livestock may be left when residents evacuate and will likely be highly stressed, making them more inclined to bite and kick. Firefighters should not put themselves at risk to rescue pets or livestock.

#### Evacuation occurring

Firefighters may be taking structural protection actions while evacuations of residents are occurring.
Be very cautious of people driving erratically. Distraught residents may refuse to leave their
property, and firefighters may need to disengage from fighting fire to contact law enforcement
officers for assistance. In most jurisdictions firefighters do not have the authority to force
evacuations. Firefighters should not put themselves at risk trying to protect someone who will not
evacuate!

#### Limited access

 Narrow one-lane roads with no turn-around room, inadequate or poorly maintained bridges and culverts are frequently found in wildland urban interface areas. Access should be sized-up and an evacuation plan for all emergency personnel should be developed.
