Area Command Team (Zimmerman) is assigned to assist the Northern Rockies with analyzing assessments for long duration fires and emerging incidents.

**Jocko Lakes**, Flathead Agency, BIA. Transfer of command from IMT 2 (McNitt) to IMT 1 (Wilcock) today. Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole pine. Group torching and short-range spotting. Community of Seeley Lake and numerous structures threatened. Evacuations and Highway 83 restrictions in effect.

**Skyland**, Flathead NF. IMT 1 (Pendleton). Thirty-two miles east of Kalispell, MT. Timber and grass. Short crown runs with isolated torching. Structures threatened.

**Chippy Creek**, Northwestern Land Office, Montana DNR. IMT 2 (Raley). Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole and logging slash. Increased fire behavior. Residences threatened. Evacuations in effect.

**Ahorn**, Lewis and Clark NF. IMT 1 (Whitney). Thirty miles west of Augusta, MT. Timber. Creeping and smoldering with group tree torching. Structures threatened.

**Meriwether**, Helena NF. IMT 1 (Oltrogge). Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Isolated torching. Structures threatened.

**Rattlesnake**, Nez Perce NF. IMT 2 (Secrest). Twenty-five miles south of Elk City, ID. Timber and grass. Active surface fire with short crown runs and isolated torching. Community of Comstock is threatened.

**Sawmill Complex** (three fires), Lolo NF. IMT 2 (Heintz). Twenty-two miles southeast of Missoula, MT. Timber. Active fire behavior with crown runs, spotting and group tree torching. Structures threatened. Evacuations in effect.

**Brush Creek**, Flathead NF. IMT 2 (Koehler). Twenty-five miles west of Whitefish, MT. Timber. Active surface fire with short range crowning and isolated torching. Structures threatened. Evacuations in effect.

**Tin Cup**, Bitterroot NF. IMT 2 (Kaage). Four miles west of Darby, MT. Timber and logging slash. Active ground fire with isolated torching. Structures threatened. Evacuations in effect.

**Rombo Mountain**, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Bug-killed timber. Crown runs, group tree torching and spotting. Structures threatened.

**Echo Springs**, West St. Joe Area Office, Idaho Department of Lands. Six miles southwest of St. Maries, ID. Timber and logging slash. Isolated torching and creeping. Structures threatened. Reduction in acreage due to more accurate mapping.

**Bridge**, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber. Short crown runs with group tree torching.

**Poe Cabin**, Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Sciacca). Twenty-three miles southwest of Grangeville, ID. Timber and grass. Creeping and smoldering.

**Fool Creek**, Lewis and Clark NF. Thirty miles northwest of Choteau, MT. Timber and snags. Torching and spotting. Structures threatened. Light precipitation occurred over the fire area yesterday.

**Chimney Complex**, Craig Mountain Area Office, Idaho Department of Lands. Nineteen miles south of Lewiston, ID. Timber and grass. Creeping, smoldering and isolated torching.

**Conger Creek**, Lolo NF. Twenty miles north of Ovando, MT. Timber. Moderate fire behavior with torching, spotting and backing. Structures threatened.

**Pattengail Creek**, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and downed fuels. Creeping.

**Garceau**, Flathead Agency, BIA. Fifty-five miles south of Whitefish, MT. Timber and grass. No further information.

Area Command Team is assigned to manage large fires for the Boise and Payette National Forests. Transfer of command from Area Command Team (Ribar) to Area Command Team (Loach) on 8/9.

**Cascade Complex** (six fires), Boise NF. IMT 1 (Broyles). Three miles northeast of Cascade, ID. Timber. Moderate fire behavior with torching and short-range spotting. Community of Yellow Pine and numerous outlying structures threatened.

**East Zone Complex** (three fires), Payette NF. NIMO (Ferguson). NIMO team also managing the Raines fire. Thirty miles northeast of McCall, ID. Timber, brush and grass. Active fire behavior with group torching and short-range spotting. Communities of Secesh and Warren, historic sites and bridges threatened.

**Middle Fork Complex** (eight fires), Boise NF. IMT 2 (Lund). IMT 2 also managing Trapper Ridge fire. Fifteen miles northeast of Garden Valley, ID. Timber and brush. Interior burning with isolated torching. Structures threatened.

**Shower Bath**, Salmon-Challis NF. IMT 2 (Saleen). Eighteen miles northwest of Challis, ID. Timber. Torching, flanking and head fire.

**Trapper Ridge**, Boise NF. Twenty-eight miles northeast of Idaho City, ID. Timber. Active ground fire. Structures threatened.

**Raines**, Payette NF. Thirty-eight miles northeast of McCall, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with group torching and short runs. Structures threatened.

**Combine**, Idaho Falls District, BLM. Started on private land thirty-one miles south of American Falls, ID. Sage brush, juniper and grass. Extreme wind-driven fire activity with rapid rates of spread.

**Krassel Complex** (seven fires), Payette NF. FUMT (Ourada/Soper). Forty-four miles northeast of Yellow Pine, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with torching and short crown runs.

**Granite Creek**, Bridger-Teton NF. Fifteen miles southeast of Jackson, WY. Timber with heavy dead and down fuels. Creeping and smoldering.

**Trout Meadows**, Umatilla NF. IMT 2 (Paul). Thirty-two miles southwest of La Grande, OR. Timber. Active fire behavior. Structures threatened. Evacuations in effect.

**Easton Ridge**, Southeast District, Washington State DNR. Washington IMT 2 (Gormley). Three miles southwest of Easton, WA. Timber. Creeping with occasional torching.

**Battle Creek Complex**, Wallowa-Whitman NF. Transfer of command from IMT 2 (Batten) back to local unit on 8/10. Twenty-seven miles northeast of Joseph, OR. Timber, brush and grass. Creeping and smoldering.

**Shelton**, Oregon Department of Forestry. Oregon IMT (Savage). Ten miles southeast of Fossil, OR. Timber, brush, and grass. Creeping and smoldering. Reduction in acreage due to more accurate mapping.

**Spear Springs**, Burns Fire Zone, Malheur NF. IMT 2 (West). Twenty-one miles north of Burns, OR. Timber, brush and grass. Spotting, short uphill runs and torching.

**Juniper Ranch**, Burns District, BLM. IMT 1 (Hoff). IMT also managing Coleman Mountain Fire. Twenty-seven miles northwest of Burns Junction, OR. Brush and grass. Extreme fire behavior with significant runs and torching.

**Coleman Mountain**, Burns District, BLM. Thirty-seven miles west of Burns, OR. Sage brush, juniper and grass. Extreme fire behavior with torching and spotting. Structures threatened.

**Butte Fire**, Vale District, BLM. Sixteen miles south of Juntura, OR. Grass and brush. Moderate rates of spread. Power lines threatened.

**Domke Lake Complex**, Okanogan/Wenatchee NF. IMT 2 (Schulte). Thirty-six miles northwest of Chelan, WA. Bug-killed timber. Active surface fire with group tree torching and short runs. Structures threatened.

**Tolo**, North Cascades NP. Thirty-three miles west of Winthrop, WA. Timber. No new information.
