Area Command Team (Zimmerman) is assigned to assist the Northern Rockies with analyzing assessments for long duration fires and emerging incidents.

**Jocko Lakes**, Flathead Agency, BIA. IMT 1 (Wilcock). Twenty-six miles northeast of Missoula, MT. Timber with dead and down lodgepole pine. Active fire with torching and spotting. Community of Seeley Lake and numerous structures threatened. Evacuations in effect.

**Chippy Creek**, Northwestern Land Office, Montana DNR. IMT 1 (Bennett). Forty-two miles southwest of Kalispell, MT. Timber, dead and down lodgepole and logging slash. Active surface fire with upslope runs and torching. Residences threatened. Evacuations in effect.

**Columbine 1**, Yellowstone NP. IMT 2 (Grant). Fifty-three miles west of Cody, WY. Timber. Active fire behavior with crown runs, single tree and group torching. Residences threatened. East Gate Highway intermittently closed.

**Sawmill Complex** (three fires), Lolo NF. IMT 2 (McNitt). Twenty-two miles southeast of Missoula, MT. Timber and grass. Single and group tree torching with backing fires. Structures threatened.

**Wicked Hicks Complex** (2 fires), Gallatin NF. IMT 1 (Stanich). Includes previously reported as Wicked Creek and Hicks Park fires. Twenty-seven miles south of Livingston, MT. Timber. Moderate fire activity with short runs and torching. Structures threatened. Evacuations in effect.

**Brush Creek**, Flathead NF. IMT 2 (Koehler and Hill). Twenty-five miles west of Whitefish, MT. Timber with heavy dead and down fuels. Active surface fire with torching, isolated crown runs and spotting. Structures threatened. Evacuations in effect.

**Rattlesnake**, Nez Perce NF. IMT 2 (Kusicko). Twenty-five miles south of Elk City, ID. Timber and grass. Active surface fire with single tree torching. Community of Concord and outlying structures threatened.

**Powder River Complex** (9 fires), Miles City Field Office, BLM. IMT 2 (Johnson). Thirty-five miles southeast of Ashland, MT. Timber, brush and grass. Extreme fire behavior. Structures threatened.

**Fool Creek**, Lewis and Clark NF. IMT 1 (Whitney). IMT also managing the Ahorn fire. Thirty miles northwest of Choteau, MT. Timber and snags. Extreme fire behavior with plume dominated winds and extended crown runs, long range spotting. Structures threatened. Evacuations in effect.

**Rat Creek**, Beaverhead/Deerlodge NF. IMT 2 (Kaage). Twenty five miles west of Wisdom, MT. Timber. Short crown fire with group torching and long-range spotting. Structures threatened.

**Poe Cabin,** Craig Mountain Area Office, Idaho Department of Lands. IMT 2 (Sciacca). Twenty-three miles southwest of Grangeville, ID. Timber and grass. Single tree torching, moderate upslope runs and short-range spotting. Structures threatened. Reduction in acreage due to more accurate mapping.

**Skyland**, Flathead NF. IMT 1 (Pendleton). Thirty-two miles east of Kalispell, MT. Timber and grass. Torching and occasional short duration crown runs. Structures threatened.

**Rombo Mountain**, Bitterroot NF. FUMT (Svalberg). Eighteen miles south of Darby, MT. Bug-killed timber. Active fire behavior with single and group tree torching, short crown runs and spotting. Structures threatened.

**Boundary Junction**, Clearwater NF. Fifteen miles southeast of Pierce, ID. Timber, brush and grass. Moderate fire activity with group tree torching.

**Bridge**, Clearwater NF. Forty-five miles southwest of Missoula, MT. Timber and brush. Active backing fire with isolated single tree and group torching and medium-range spotting.

**Ahorn**, Lewis and Clark NF. Thirty miles west of Augusta, MT. Timber. Surface fire with isolated group torching and uphill runs. Structures threatened. Evacuations in effect.

**Meriwether,** Helena NF. Thirty-seven miles northwest of Helena, MT. Timber, brush and grass. Surface fire with isolated single tree torching. Structures threatened.

**Russell Ridge**, Maggie Creek Area Office, Idaho Department of Lands. Four miles southwest of Orofino, ID. Timber and grass. Active fire behavior.

**Pattengail Creek**, Beaverhead/Deerlodge NF. Ten miles northeast of Wisdom, MT. Timber with dead and down fuels. Active fire with runs and spotting.

**Pine Crest**, Southern Land Office, Montana DNR. Seven miles southeast of Columbus, MT. Sage brush and grass. Extreme fire behavior. Structures threatened. Evacuations in effect.

**Conger Creek**, Lolo NF. Twenty miles north of Ovando, MT. Timber. Moderate surface fire with backing fire and upslope runs.

**Muskrat Lake,** Fort Berthold Agency, BIA. Fifty-eight miles southwest of Minot, ND. Light logging slash. Creeping.

**Moose Creek WFU**, Nez Perce NF. Previously reported WFU incident. Thirty five miles northeast of Elk City, ID. Timber. Spotting. Last narrative report unless significant activity occurs.

**Landmark Complex** (two fires), Boise NF. IMT 2 (Suwyn). Thirty-four miles southeast of McCall, ID. Timber. Torching, creeping and smoldering. Structures threatened.

**Shower Bath**, Salmon-Challis NF. Eighteen miles northwest of Challis, ID. Timber with heavy dead and down fuels. Active fire with running, torching and long-range spotting. Structures threatened.

**Hardscrabble**, Bridger-Teton NF. FUMT (Reinarz). Twenty-six miles northwest of Dubois, WY. Bug-killed timber. Torching with short-range spotting.

**Mitchell,** Idaho Falls District, BLM. IMT 2 (Whalen). IMT also managing the Cleveland fire. Ten miles north of Holbrook, ID. Timber, brush and grass. Active backing with group tree torching. Structures threatened.

**Cow Creek,** Twin Falls District, BLM. Thirteen miles west of Fairfield, ID. Brush and grass. Isolated torching and creeping. Structures threatened.

**Middle Fork Complex** (three fires), Boise NF. IMT 2 (Lund). IMT also managing the Trapper Ridge WFU. Fifteen miles northeast of Garden Valley, ID. Timber and brush. Creeping, backing and smoldering fire with single tree torching. Reduction in acreage due to more accurate mapping.
