Area Command Team (Loach) is assigned to manage large fires for the Boise and Payette National Forests.

Greys Creek, Payette NF. IMT 2 (Harvey). Thirteen miles south of Council, ID. Timber and grass. Extreme fire behavior with torching, spotting and crowning. Structures threatened. Evacuations and road closures in effect.

Sandy, Boise District, BLM. Eight miles northeast of Payette, ID. Grass and sagebrush. Extreme fire behavior. Structures threatened.

Castle Rock, Sawtooth NF. IMT 1 (Pincha-Tulley). Three miles west of Ketchum, ID. Timber, heavy dead and down fuels, brush and grass. Minimal fire behavior with isolated torching. Evacuations in effect.

Cascade Complex (2 fires), Boise NF. IMT 1 (Muir). Twenty-seven miles east of Cascade, ID. Timber. Minimal fire behavior. Local communities, cultural sites, and historical cabins are threatened.

East Zone Complex (3 fires), Payette NF. NIMO (Ferguson). Twenty-five miles northeast of McCall, ID. Timber, brush and grass. Moderate surface fire with group tree torching and short runs. Communities of Secesh, South Fork and Warren threatened.

Confluence Complex (2 fires), Salmon-Challis NF. IMT 2 (Lund). Includes Papoose fire previously reported under the Krassel Complex, and the Clear Sage fire previously reported under the Shower Bath Complex.. Twenty eight miles southwest of North Fork, ID. Mixed conifer with dead and down fuels. Torching and backing fire.

Shower Bath Complex (2 fires), Salmon-Challis NF. Transfer of command from FUMT (Reinarz) back to local unit today. Eighteen miles northwest of Challis, ID. Timber with heavy dead and down fuels. Creeping and smoldering. Structures, historic cabins and cultural sites threatened. Reduction in acreage due to transfer of Clear Sage fire to Confluence Complex.

Krassel Complex (5 fires), Payette NF. FUMT (Hahnenberg). Forty-four miles northeast of Yellow Pine, ID. Timber, grass and heavy dead and down fuels. Active fire behavior with isolated torching and short crown runs. Structures threatened. Reduction in acreage due to transfer of Papoose fire to Confluence Complex.
