**Grays Creek**, Payette NF. IMT 2 (Harvey). Thirteen miles south of Council, ID. Timber and grass. Creeping and smoldering. Structures threatened. Area closures and evacuations in effect. Precipitation occurred over the fire area yesterday.

**Chief Parrish**, Southwest Area Office, Idaho Department of Lands. IMT 2 (Saleen). One mile south of Banks, ID. Timber, brush and grass. Active fire behavior. Community of Banks threatened. Highway 55 restrictions and area closures in effect.

**Cascade Complex**, Boise NF. IMT 2 (Whalen). Twenty-seven miles east of Cascade, ID. Timber. Creeping and smoldering with torching. Structures, power lines, cultural sites and historical cabins are threatened. Evacuations and road closures in effect. Precipitation occurred over the fire area yesterday.

**East Zone Complex** (3 fires), Payette NF. IMT 1 (Broyles). IMT also managing Donnelly zone of the Grays Creek fire. Twenty-five miles northeast of McCall, ID. Timber, brush and grass. Creeping and smoldering. Structures threatened. Road closures in effect. Precipitation occurred over the fire area yesterday.

**Confluence Complex** (3 fires), Salmon-Challis NF. IMT 2 (Lund). Twenty-eight miles southwest of North Fork, ID. Mixed conifer, brush, grass and heavy dead and down fuels. Minimal fire behavior. Structures threatened. Area closures in effect. Precipitation occurred over the fire area yesterday.

**Shower Bath Complex** (2 fires), Salmon-Challis NF. Eighteen miles northwest of Challis, ID. Timber with heavy dead and down fuels. Creeping, smoldering and isolated torching. Structures threatened. Scattered precipitation occurred over the fire area yesterday.

#### Lookouts

Lookouts are often better situated to notice the cumulative changes of fire behavior.

- Fire Order #8 says, "Establish lookouts in potentially hazardous situations." Should you utilize lookouts at all times?
  - Lookouts should be posted at all times.
- What are you looking for when you are selecting a lookout location?
  - Choose a good vantage point, preferably with a good overview of the entire area where firefighters are located, including escape routes and safety zones.
  - Utilize aircraft if they are available, but only as a complement to established lookouts on the ground. Never rely exclusively on aircraft as your lookout.
- What are the desired qualities, capabilities, knowledge, and responsibilities of a lookout person?
  - Experienced firefighter.
  - Solid knowledge of fire behavior and ability to recognized and monitor other environmental hazards.
  - Good communicator--keeps the crew advised of fire behavior changes, tracks weather trends and relays the information, informs crew of work progress and updates from the latest strategy and tactical briefings.
  - Monitors and accounts for all individuals within his/her assigned area at all times, and will notify others if breaks are needed.
- What is the necessary equipment for a lookout?
  - PPE, radio with extra batteries, compass, binoculars, belt weather kit, IAP, map, food, and water.
