**Grass Valley**, San Bernardino NF. IMT 2 (Kaage). Twelve miles north of San Bernardino, CA. Timber and grass. Group tree torching, crown runs and spotting. Numerous structures threatened. Evacuations in effect.

**Slide**, San Bernardino NF. CAL FIRE IMT 1 (McGowan). Ten miles north of San Bernardino, CA. Timber and grass. Group tree torching, crown runs and spotting. Numerous communities, gas lines and ski facilities threatened. Evacuations in effect.

**Witch**, Monte Vista Unit, CAL FIRE. CAL FIRE IMT 1 (Kerschen). One mile east of Ramona, CA. Timber, brush and grass. Extreme wind-driven fire behavior with rapid rates of spread and long-range spotting. Multiple communities threatened. Evacuations in effect.

**Poomacha**, Monte Vista Unit, CAL FIRE. Seven miles east of Pauma Valley, CA. Chaparral and grass. Extreme rates of spread and long-range spotting. Numerous residences threatened. Evacuations in effect.

**Rice**, Monte Vista Unit, CAL FIRE. CAL FIRE IMT 1 (Morris). Seven miles east of Fallbrook, CA. Brush and grass. Extreme fire behavior with rapid rates of spread and long-range spotting. Fallbrook and Oceanside communities threatened. Evacuations in effect.

**Santiago**, Orange County FD. Unified Command between IMT 1 (Whitney), CAL FIRE and Orange County. Twelve miles east of Santa Ana, CA. Brush and grass. Extreme wind-driven fire behavior. Multiple communities and utilities threatened. Evacuations in effect.

**Harris**, Monte Vista Unit, CAL FIRE. Unified Command between CAL FIRE IMT 1 (Windsor), Forest Service, San Diego, Chula Vista and San Miguel. Two miles southeast of Potrero, CA. Brush and grass. Extreme fire behavior. Multiple communities and utility infrastructure threatened. Evacuations in effect.

**Ranch**, Angeles NF. IMT 1 (Pincha-Tulley). Six miles north of Castaic, CA. Chaparral and oak woodland. Backing fire with short runs. Numerous structures and utility infrastructure threatened. Road closures and evacuations in effect.

**Buckweed**, Los Angeles County FD. Unified Command between IMT 1 (Opliger), CAL FIRE and LA County. Fourteen miles west of Palmdale, CA. Brush and grass. Creeping and smoldering. Multiple communities threatened. Evacuation order remains for Bouquet Canyon. Road closures in effect.

**Ammo**, Camp Pendleton Marine Corps Base, DOD. Five miles from north of San Clemente, CA. Chaparral. Active fire behavior with spotting. Structures threatened. Evacuations in effect.

**Canyon**, Los Angeles County FD. Two miles north of Malibu, CA. Chaparral. High rates of spread and long-range spotting. Multiple communities threatened. Road closures and evacuations in effect.

Rosa, Riverside Unit, CAL FIRE. One mile southwest of Temecula, CA. Chaparral. No new information.

Magic, Los Angeles County FD. Three miles west of Santa Clarita, CA. Chaparral and grass. No new information.

#### McCoy, Cleveland NF. Four miles southwest of Julian, CA. Grass. No new information.
