**Trigo**, Cibola NF. Ten miles east of Belen, NM. IMT 2 (Cowie). Hardwood litter. Wind-driven fire behavior with rapid rates of spread and spotting. Structures, communications towers and observatory threatened.

**Alamo**, Coronado NF. Thirteen miles west of Nogales, AZ. IMT 2 (Small). Grass. Backing fire. Ranches threatened and Pena Blanca Lake area evacuated. Portion of the fire has crossed into Mexico.

**Pepper**, Lincoln NF. Four miles southwest of Weed, NM. Timber with heavy down fuels. Creeping, smoldering and isolated torching.

**Center Peak**, Socorro District, New Mexico State Forestry. Twenty-eight miles southeast of Animas, NM. Grass and shrubs. Minimal fire activity.

**Pinnacle Ridge**, North Carolina DOF. Four miles southwest of Waynesville, NC. Hardwood litter. Smoldering. Blue Ridge Parkway and watershed threatened.

**Lost**, Osage Agency, BIA. Eighteen miles northwest of Owasso, OK. Hardwood litter. Creeping and smoldering with interior flare-ups. Structures threatened.

**Burn Out,** Okmulgee Field Office, BIA. Thirteen miles southeast of Bristow, OK. Grass. Creeping and smoldering with interior flare-ups. Precipitation occurred over the fire area yesterday.

**Rattlesnake Mountains**, Okmulgee Field Office, BIA. Five miles north of Shady Grove, OK. Hardwood litter and grass. Smoldering. Precipitation occurred over the fire area yesterday.

**Camelot**, Tennessee Division of Forestry. Four miles northwest of Rogersville, TN. Hardwood litter. No new information.

**Sandy Bottom**, North Carolina DOF. Twenty-two miles northwest of Asheville, NC. Hardwood litter and brush. Smoldering. Light rain received over the fire.
