BTU Lightning Complex (31 fires), Butte Unit, Cal Fire. Cal Fire IMT 1 (Lewin). Twenty-seven miles north of Yuba City, CA. Timber, brush and logging slash. Active fire behavior. Numerous residences and structures threatened. Community of Jarbo Gap threatened. Precautionary evacuation advisories have been issued for several communities. Highway 70 closed.

SHU Lightning Complex (50 fires), Shasta-Trinity Unit, Cal Fire. Cal Fire IMT 1 (Kerschen). Shasta and Trinity counties, CA. Timber, brush and grass. Extreme fire behavior. Junction City, Platina, Corman Ranch and power generation system threatened. Evacuation orders in effect.

Whiskeytown Complex (3 fires), Whiskeytown National Recreation Area, NPS. IMT 2 (McNitt). Twelve miles west of Redding, CA. Timber and brush. Moderate fire activity with short runs. Communication towers, power lines, and recreation infrastructure threatened.

Lime Complex (41 fires), Shasta-Trinity NF. IMT 1 (Opliger). Fourteen miles west of Hayfork, CA. Timber. Active backing and flanking fire with short uphill runs. Numerous structures, ranches and youth camps threatened. Evacuations in effect.

Iron Complex (27 fires), Shasta-Trinity NF. IMT 1 (Broyles). One mile north of Junction City, CA. Heavy timber, brush and grass. Moderate fire activity with wind-driven runs. Communities threatened. Highway 299 has restricted traffic flow.

MEU Lightning Complex (63 fires), Mendocino Unit, Cal Fire. Cal Fire IMT 1 (Waterman). Mendocino County, CA. Timber and grass. Moderate to rapid rates of spread with torching and spotting. Utility infrastructure and numerous residences threatened. Communities of Leggett and Singley threatened. Evacuations in effect.

Canyon Complex (17 fires), Plumas NF. IMT 1 (Pincha-Tulley). Sixteen miles northeast of Paradise, CA. Timber. Increased rates of spread with wind-driven runs and isolated torching. Residences and archeological sites threatened. Road closures in effect.

American River Complex (3 fires), Tahoe NF. IMT 1 (Summerfelt). Eleven miles northeast of Foresthill, CA. Timber, brush and chaparral. Active surface fire with short uphill runs and single and group tree torching. Watershed, power lines and residences threatened.

Yuba River Complex (3 fires), Tahoe NF. IMT 2 (Joseph). Thirteen miles northeast of Nevada City, CA. Timber and brush. Backing fire with uphill runs. Several communities, hydroelectric facilities and recreation sites threatened.

Cub Complex (2 fires), Lassen NF. IMT 2 (Batten). Sixteen miles southwest of Chester, CA. Timber. Short uphill runs, isolated torching and short-range spotting. Structures and Highway 32 threatened.

Peterson Complex, Lassen NF. Unified command between IMT 1 (Ruggiero) and Cal Fire. Transfer of command from IMT 1 (Ruggiero) back to local unit tomorrow. Twelve miles east of Cassell, CA. Timber and grass. Creeping and smoldering.

Corral, Lassen-Modoc Unit, Cal Fire. IMT 1 (Larsen). Twenty-three miles west of Termo, CA. Timber. Winddriven fire activity with short-range spotting.

Siskiyou Complex (3 fires), Klamath NF. IMT 2 (Paul). Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Increased rates of spread with short uphill runs and occasional torching. Campground and residences threatened.

Mad Complex (4 fires), Six Rivers NF. Humboldt County, CA. Timber, brush and grass. Increased fire activity with isolated torching. Residences threatened.

Hell's Half Complex (2 fires), Six Rivers NF. IMT 2 (Secrest). Eight miles southwest of Burnt Ranch, CA. Timber. Active fire with group tree torching, crown runs and spotting. Structures threatened.

Ukonom Complex (3 fires), Six Rivers NF. IMT 2 (Lund). Ten miles east of Orleans, CA. Timber. Increased surface fire activity with isolated torching. Structures threatened.

Yolla Bolly Complex (17 fires), Mendocino NF. IMT 2 (Harvey). Previously reported as June ABCD Misc. Complex. Twenty-four miles southwest of Chico, CA. Chaparral, timber and grass. Active running fire with spotting. Yolla Bolly Middle Eel Wilderness area closed. Structures threatened.

Soda Complex (4 fires), Mendocino NF. IMT 2 (Heintz). Fifteen miles northwest of Upper Lake, CA. Chaparral, mixed conifer and oak woodlands. Plume-dominated fire activity. Residences threatened.

Alps Complex (13 fires), Shasta-Trinity NF. IMT 2 (Soper). Twenty miles northwest of Junction City, CA. Timber and brush. Moderate fire activity. Residences threatened. Reduction in acreage due to the transfer of one fire to the Iron Complex.

TGU Lightning Complex (3 fires). Tehama-Glenn Unit, Cal Fire. Tehama County, CA. Chaparral. Slow rate of spread.

Mill Complex, Lassen NF. Sixteen miles northeast of Los Molinos, CA. Timber. No further information received. Last report unless significant activity occurs.

Humboldt Complex, Humboldt-Del Norte Unit, Cal Fire. Humboldt County, CA. Timber, slash and grass. Slow rate of spread with spotting. Numerous residences threatened.
