Eight MAFFS C-130 air tankers are supporting the State of California. All aircraft are based at McClellan Airport in Sacramento California. The Mission Commander is LTC Roger Williams, 145th Air Wing Air National Guard, North Carolina. Three aircraft are provided by the 145th Airlift Wing, Charlotte, North Carolina, three from the 302nd Airlift Wing, Colorado Springs, CO and two from the 153rd Airlift Wing, Cheyenne, Wyoming.

Zimmerman's Area Command Team is providing planning and incident management support to the Shasta-Trinity National Forest. Lohrey's Area Command Team is managing large fire complexes on the Lassen National Forest. Gage's NIMO Team is supporting the ONCC Multi-Agency Coordinating Group.

**BTU Lightning Complex** (11 fires), Butte Unit, Cal Fire. Cal Fire IMT 1 (Lewin). Twenty-seven miles north of Yuba City, CA. Timber, brush and logging slash. Spotting. Power transmission lines, numerous residences and structures threatened. Precautionary evacuation in effect for several communities. Highway 70 closed. Reduction in acreage due to more accurate mapping.

**SHU Lightning Complex** (3 fires), Shasta-Trinity Unit, Cal Fire. Cal Fire IMT 1 (Kerschen). Shasta and Trinity counties, CA. Timber, brush and grass. Moderate fire behavior. Residences and power generation system threatened. Evacuations in effect.

**Whiskeytown Complex**, Whiskeytown National Recreation Area, NPS. IMT 2 (McNitt). Twelve miles west of Redding, CA. Timber and brush. Backing fire with creeping and smoldering. Structures threatened.

**Lime Complex** (38 fires), Shasta-Trinity NF. IMT 1 (Opliger and Wilcock). Fourteen miles west of Hayfork, CA. Timber. Active backing and flanking fire with short uphill runs and short-range spotting. Communities of Hyampon and Wildwood, ranches and youth camps threatened. Traffic control on Highway 36 in effect.

**Iron Complex** (6 fires), Shasta-Trinity NF. IMT 1 (Broyles). One mile north of Junction City, CA. Heavy timber, brush and grass. Terrain-driven surface fire with single and group tree torching. Communities of Big Bar, Hawkins Bar and Trinity Village threatened. Advisory evacuations in effect. Temporary road closures and restricted traffic flow on Highway 299.

**MEU Lightning Complex** (40 fires), Mendocino Unit, Cal Fire. Cal Fire IMT 1 (Waterman). Mendocino County, CA. Timber and grass. Active fire behavior. Eight communities threatened. Evacuations in effect.

**Canyon Complex** (8 fires), Plumas NF. IMT 1 (Pincha-Tulley). Sixteen miles northeast of Paradise, CA. Timber. Increased activity with multiple spot fires. Residences and archeological sites threatened. Highway 70 closed.

**American River Complex** (3 fires), Tahoe NF. IMT 1 (Summerfelt). Eleven miles northeast of Foresthill, CA. Timber, brush and chaparral. Short active crown runs with short-range spotting and backing. Watershed, power lines and residences threatened.

**Yuba River Complex**, Tahoe NF. Transfer of command from IMT 2 (Joseph) back to local unit today. Thirteen miles northeast of Nevada City, CA. Timber and brush. Backing fire. Several communities, hydroelectric facilities and recreation sites threatened.

**Cub Complex** (2 fires), Lassen NF. IMT 1 (Ruggiero). Sixteen miles southwest of Chester, CA. Timber. Running and torching with long range spotting. Structures threatened. Highway 32 closed.

**Mad Complex**, (3 fires), Six Rivers NF. Twenty-three miles east of Redcrest, CA. Timber, brush and grass. Moderate fire activity with creeping. Residences threatened.

**Hell's Half Complex** (2 fires), Six Rivers NF. IMT 2 (Secrest). Eight miles southwest of Burnt Ranch, CA. Timber. Active fire with group tree torching and short uphill crown runs. Residences threatened.

**Soda Complex** (3 fires), Mendocino NF. IMT 2 (Heintz). Fifteen miles northwest of Upper Lake, CA. Chaparral, mixed conifer and oak woodlands. Backing fire with torching and uphill runs. Residences threatened. Reduction in acreage due to more accurate mapping.

**Corral**, Lassen-Modoc Unit, Cal Fire. IMT 1 (Larsen). Twenty-three miles west of Termo, CA. Timber. Smoldering and creeping with isolated single tree torching. Reduction in acreage due to more accurate mapping.

**Yolla Bolly Complex** (8 fires), Mendocino NF. IMT 2 (Harvey). Twenty-four miles southwest of Chico, CA. Chaparral, timber and grass. Active backing with short uphill runs. Structures threatened.

**Ukonom Complex** (4 fires), Six Rivers NF. IMT 2 (Lund). Ten miles east of Orleans, CA. Timber. Surface fire activity with isolated torching and spotting. Structures threatened.

**Siskiyou Complex** (3 fires), Klamath NF. IMT 2 (Paul). Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Backing fire with occasional torching and short uphill runs. Historic and cultural resources threatened.

**Alps Complex** (7 fires), Shasta-Trinity NF. IMT 2 (Soper). Twenty miles northwest of Junction City, CA. Timber and brush. Smoldering, creeping and backing fire with torching and short runs. Reduction in acreage due to the transfer of the Buckhorn Fire to the Iron Complex.

**Humboldt Complex,** Humboldt-Del Norte Unit, Cal Fire. Humboldt County, CA. Timber, slash and grass. Increased fire activity.

No Mans, Klamath NF. Nine miles southwest of Happy Camp, CA. Timber. No further information received.

#### Initiate All Actions Based On Current And Expected Fire Behavior

- Can the resources you are replacing give you a thorough briefing? What information will you want to get from resources you are replacing?
- Can you observe the area or use scouts? What information are the scouts looking for?
- Have escape routes and safety zones been thoroughly scouted? List some ways your crew will scout out an area before you begin working
- Are escape routes and safety zones marked for night use? How do you adjust marking safety zones and escape routes for night use?
- Have potential dangers been located and can they be dealt with? List some dangerous fire behavior you may encounter and how you would deal with it.
- Do you have access to weather and fire behavior forecasts? What is your unit's procedure for obtaining forecasts?
- To reduce risk, initiate the following:
  - Post lookouts.
  - · Check communications.
  - Retreat if you have doubts about your escape routes or safety zones or it the situation becomes too complex. Discuss fires where you have adjusted your actions based on current and expected fire behavior.
