Eight MAFFS C-130 air tankers are supporting the State of California. All aircraft are based at McClellan Airport in Sacramento, California. The Mission Commander is LTC Tom Jackie, 145th Air Wing Air National Guard, North Carolina. Three aircraft are provided by the 145th Airlift Wing, Charlotte, North Carolina, three from the 302nd Airlift Wing, Colorado Springs, Colorado and two from the 153rd Airlift Wing, Cheyenne, Wyoming.

Area Command Team (Loach) is managing fire complexes on the Shasta-Trinity, Mendocino and Six Rivers National Forests. NIMO Team (Gage) is supporting the ONCC Multi-Agency Coordinating Group. NIMO Team (Whitney) has been ordered to replace Gage's NIMO Team.

BTU Lightning Complex (14 fires), Butte Unit, Cal Fire. Cal Fire IMT 1 (Morris). Twenty-seven miles north of Yuba City, CA. Timber, brush and logging slash. Torching and spotting with sustained runs. Power transmission lines, numerous residences and structures threatened. Evacuations in progress. Highway 70 closed. Reduction in acreage due to more accurate mapping.

SHU Lightning Complex (3 fires), Shasta-Trinity Unit, Cal Fire. Cal Fire IMT 1 (Kerschen). Shasta and Trinity counties, CA. Timber, brush and grass. Extreme fire behavior. Residences, infrastructure and recreation sites threatened. Evacuations in progress.

Whiskeytown Complex, Whiskeytown National Recreation Area, NPS. IMT 2 (McNitt). Twelve miles west of Redding, CA. Timber and brush. Short runs with group tree torching. Structures threatened.

American River Complex (2 fires), Tahoe NF. IMT 1 (Summerfelt and Muir). Eleven miles northeast of Foresthill, CA. Timber, brush and chaparral. Active fire with sustained crown runs, torching and short-range spotting. Watershed, power lines and residences threatened.

Canyon Complex (8 fires), Plumas NF. Transfer of command from IMT 1 (Pincha-Tulley) to IMT 1 (Pendleton) occurred. Sixteen miles northeast of Paradise, CA. Timber. Intense surface fire. Residences and archeological sites threatened. Evacuations in effect. Roads closed.

Lime Complex (36 fires), Shasta-Trinity NF. IMT 1 (Wilcock). Fourteen miles west of Hayfork, CA. Timber. Active backing and flanking fire with uphill runs. Communities, ranches and youth camps threatened.

Yolla Bolly Complex (3 fires), Mendocino NF. Twenty-four miles southwest of Chico, CA. Chaparral, timber and grass. Single and group tree torching. Reduction in acreage due to two fires being incorporated into the Lime Complex. Remaining fires of this Complex will merge with the Lime Complex today.

Iron Complex (6 fires), Shasta-Trinity NF. IMT 1 (Broyles). IMT also managing the Alps Complex. One mile north of Junction City, CA. Heavy timber, brush and grass. Backing and flanking fire with single and group tree torching. Communities threatened.

Alps Complex (12 fires), Shasta-Trinity NF. Twenty miles northwest of Junction City, CA. Timber and brush. Smoldering, creeping and backing fire with occasional torching.

MEU Lightning Complex (37 fires), Mendocino Unit, Cal Fire. Cal Fire IMT 1 (Waterman). Mendocino County, CA. Timber and grass. Isolated torching and short runs. Four communities threatened. Evacuations in effect.

Cub Complex (2 fires), Lassen NF. IMT 2 (Kaage). Sixteen miles southwest of Chester, CA. Timber. Active surface fire with isolated and group tree torching. Residences threatened. Highway 32 closed. Evacuations in effect.

Hell's Half Complex (2 fires), Six Rivers NF. IMT 2 (Secrest). Eight miles southwest of Burnt Ranch, CA. Timber. Extreme fire behavior with group tree torching and long crown runs. Communities threatened. Evacuations in effect.

Ukonom Complex (2 fires), Six Rivers NF. IMT 2 (Paul). Ten miles east of Orleans, CA. Timber. Active surface fire with torching and uphill runs. Structures threatened. Area closures in effect.

Siskiyou Complex (2 fires), Klamath NF. IMT 2 (Swartzlander). Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Active fire behavior with uphill runs, torching and long range spotting. Historic and cultural resources threatened.

Soda Complex (2 fires), Mendocino NF. IMT 2 (Heintz). Fifteen miles northwest of Upper Lake, CA. Timber. Active fire with single and group tree torching and short uphill runs. Residences threatened.

Blue 2, Six Rivers NF. IMT 2 (Svalberg). Twelve miles east of Klamath, CA. Timber. Active fire behavior with group tree torching and short crown runs. Cultural and heritage resources threatened.

Yuba River Complex, Tahoe NF. Thirteen miles northeast of Nevada City, CA. Timber and brush. Backing fire with short runs and isolated torching. Several communities, hydroelectric facilities and recreation sites threatened.

Mad Complex, (3 fires), Six Rivers NF. Twenty-three miles east of Redcrest, CA. Timber, brush and grass. Moderate fire activity with smoldering and creeping.

Humboldt Complex, Humboldt-Del Norte Unit, Cal Fire. Humboldt County, CA. Timber, slash and grass. Residences threatened. No further information received.

Bear Wallow Complex, Klamath NF. Confine/contain management strategy. Thirteen miles southeast of Happy Camp, CA. Backing fire with isolated torching. Last report unless significant activity occurs.
