Rich, Plumas NF. IMT 1 (Hoff). Twenty miles west of Quincy, CA. Timber. Moderate fire behavior with group torching and short crown runs. Residences, communication site and power lines threatened. Evacuations in effect.

Lime Complex (2 fires), Shasta-Trinity NF. IMT 1 (Hughes). Fourteen miles west of Hayfork, CA. Timber. Moderate fire behavior with group tree torching and short-range spotting. Residences, ranches and youth camps threatened. Evacuations in effect.

Panther, Klamath NF. IMT 1 (McGowan). Fourteen miles southwest of Happy Camp, CA. Timber and brush. Moderate fire behavior with isolated single and group tree torching. Structures and cultural resources threatened.

Ukonom Complex, Six Rivers NF. IMT 1 (Dietrich and Wilcock). IMTs are also managing the Siskiyou Complex and the Blue 2 fire. Ten miles east of Orleans, CA. Timber. Moderate fire behavior with isolated single and group tree torching. Structures, cultural sites, and telecommunication facility threatened.

Iron and Alps Complexes (3 fires), Shasta-Trinity NF. Transfer of command from IMT 1 (Opliger) to IMT 2 (Kaage) tomorrow. One mile north of Junction City, CA. Heavy timber, brush and grass. Moderate fire behavior with short runs, flanking, backing, single tree torching and spotting. Power lines and residences threatened.

Bear Wallow Complex (2 fires), Klamath NF. IMT 2 (Swartzlander). Confine/contain management strategy. Thirteen miles southeast of Happy Camp, CA. Timber and brush. Moderate fire behavior with isolated torching. Residences threatened.

Siskiyou Complex (2 fires), Klamath NF. Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Moderate fire behavior with single and group tree torching. Cultural sites threatened.

Blue 2, Six Rivers NF. Twelve miles east of Klamath, CA. Timber. Moderate fire behavior with backing and group tree torching. Cultural and communications sites threatened. Trail and road closures in effect.

Yolla Bolly Complex (3 fires), Mendocino NF. IMT 1 (Larsen). Forty-seven miles southwest of Redding, CA. Timber. Smoldering and creeping. Residences and cultural sites threatened.

Canyon Complex (6 fires), Plumas NF. IMT 2 (Sciacca). Sixteen miles northeast of Paradise, CA. Timber. Moderate fire behavior with short runs and isolated tree torching.
