Craig, Butte Unit, Cal Fire. Cal Fire IMT 1 (Streblow). Twelve miles east of Oroville, CA. Brush. Residences and cultural resources threatened. No further information received. Reduction in acreage due to more accurate mapping.

Iron and Alps Complexes (3 fires), Shasta-Trinity NF. IMT 1 (Molumby). One mile north of Junction City, CA. Heavy timber, brush and grass. Flanking and backing fire with short uphill runs, torching and short-range spotting. Numerous residences and structures threatened.

Siskiyou Complex, Klamath NF. IMT 1 (Wilcock). IMT is also managing the Blue 2 fire and Ukonom Complex. Eighteen miles southwest of Happy Camp, CA. Conifer and hardwood overstory with heavy timber litter. Backing, creeping and smoldering. Cultural sites threatened.

Blue 2, Six Rivers NF. Twelve miles east of Klamath, CA. Timber. Backing, creeping, smoldering and isolated torching. Cultural and communication sites threatened. Road and trail closures in effect.

Panther, Klamath NF. IMT 1 (McGowan). Fourteen miles southwest of Happy Camp, CA. Moderate fire behavior. Timber and brush. Residences threatened. Restricted traffic flow on state highway 96.

Ukonom Complex, Six Rivers NF. Ten miles east of Orleans, CA. Timber. Backing and flanking fire with short uphill runs, isolated torching and short-range spotting. Structures, cultural sites and a telecommunication facility are threatened.

Bear Wallow Complex (2 fires), Klamath NF. IMT 2 (Swartzlander). FUMT (Beckman) ordered. Confine/contain management strategy. Thirteen miles southeast of Happy Camp, CA. Timber and brush. Backing fire. Roads and trails closed.

Yolla Bolly Complex (3 fires), Mendocino NF. IMT 2 (Blume). Forty-seven miles southwest of Redding, CA. Timber. Active fire with short crown runs, torching and short-range spotting.

Lime Complex (2 fires), Shasta-Trinity NF. IMT 2 (Woychak). Fourteen miles west of Hayfork, CA. Timber. No further information received.

Canyon Complex, Plumas NF. Transfer of command from IMT 1 (Hoff) to Minnesota IMT 2 (Mannelin) today. Sixteen miles northeast of Paradise, CA. Timber. Downhill backing, smoldering and creeping.

Dozer/Tractor Plow Operations

Dozers/tractor plows provide suppression and support capability for fire operations. When working on or around dozers on the fireline, it is important to respect the following guidelines:

- Load/unload equipment from the transport in a safe manner on a level, stable surface.
- Park transport in an area free of fuel. Clear an area if needed to protect parked equipment.
- Do not sit or bed down near equipment. Walk around the equipment before starting or moving it.
- Lower the dozer blade and/or fire plow to the ground when the equipment is idling or stopped.
- When working a dozer or tractor plow, stay at least 100 feet in front or 50 feet behind the equipment.
- Allow no one but the operator to ride on the equipment.
- Never get on or off equipment while it is moving.
- Provide front and rear lights for equipment working at night or in heavy smoke.
- Provide lights and fluorescent vests to personnel working with dozer/tractor plow units.
- Use hand signals for direction and safety. (See Fireline Handbook, Appendix A, for hand signals.)
- Do not use a dozer or tractor plow without a canopy or brush guard and radio communications.
- Operators will wear required PPE and carry a fire shelter.
- Be aware of different fuel types, rates of spread, and flammability.
- Watch for wetlands, steep slopes, rocks, ditches, and other obstacles that might stop the equipment.
- Do not get too far ahead of a firing crew during firing operations.
- Anchor the line to a secure firebreak and create a black line (burn out) until the fire is completely enclosed.
- Tractor plow operators should wear headgear protection for head, face, eyes, and ears while also providing radio reception and ventilation capabilities.
- Tractor plow crews should consist of a minimum of two people.
- When the dozer or tractor plow is equipped with a hand-clutch lever, always take equipment out of gear when mounting and dismounting.
