**Swanson Lake**, Northeast District, Washington DNR. Washington IMT 2 (Reed). Four miles southwest of Creston, WA. Timber, grass and brush. Moderate fire behavior with creeping and torching. Residences and cultural sites threatened.

**Summit Springs Complex** (3 fires), Sisters Unit, Oregon DOF. Oregon IMT 2 (Hirsch). Nine miles north of Sisters, OR. Timber and brush. Active fire behavior. Structures and cultural sites threatened.

**Wild Rivers Complex,** Siskiyou NF. IMT 2 (Suwyn). Seventeen miles southwest of Grants Pass, OR. Timber, brush and grass. Creeping and smoldering with isolated torching.

**North Fork,** Umpqua NF. IMT 2 (Batten). IMT is also managing the Rattle incident. Twenty-six miles northeast of Glide, OR. Timber. Minimal fire behavior with creeping and smoldering.

**Bridge Creek,** Ochoco NF. IMT 2 (Rapp). Five miles southwest of Mitchell, OR. Logging slash. Creeping, smoldering and isolated torching. Reduction in acreage due to more accurate mapping.

**Ochoco Fire Use – WFU** (2 fires), Ochoco NF. FUMT (Reidy). Ten miles southwest of Dayville, OR. Timber. Creeping with isolated torching.

**Snow Creek Complex** (5 fires), Deschutes NF. IMT 2 (LaFave). Fourteen miles west of Sunriver, OR. Timber. Minimal fire behavior. Cultural sites threatened. Area closures in effect.

**Predictive Services Discussion:** Warm and dry conditions continue throughout much of the West. Isolated dry thunderstorms are possible in northeast Nevada, northern Utah and western Wyoming. A large low pressure system will approach the Northwest with scattered showers mainly west of the Cascades today, spreading east overnight into Monday. Wind speeds will also begin to increase across the West. Tropical Storm Fay will continue to slowly move westward along the Gulf Coast and bring heavy rainfall to western Florida, Alabama and Mississippi.

#### Attempting a Frontal Assault On a Fire

Attempting a frontal assault on a fire is recognized as Watchout Situation #10 and is a potentially dangerous tactic.

- If your tactics include a frontal assault, the following checklist must be adequately addressed before engaging the fire:
  - Has the fire been scouted and sized up? Who will scout and size up a fire and what are they looking for?
  - Is your position defensible? List what makes a firefighter's position defensible. (Anchor points, safety zones, escape routes, etc.)
  - Are escape routes and safety zones adequate? Review what constitutes an adequate safety zone and escape route.
  - Do you have an anchor point? How would you establish an anchor point for a frontal assault on a fire?

- Do you have adequate resources to complete the assault? Discuss things you need to consider; for example, if the frontal assault fails, do you have backup?
- Are you informed on strategy, tactics, and hazards? Consider what could happen if someone has a different approach than you; i.e., the IC has a burnout operation planned while you are attempting frontal assault.
- Is the terrain favorable to holding the fire? Discuss ways the terrain will influence where you will make a stand.
- In order to reduce the risks, reassess your tactics, post lookouts, identify situations in which firefighters may be enticed to attempt frontal assault on a fire. Review why this may or may not be a good idea.
