#### **Entrapment Avoidance**

Entrapment Avoidance is described in the NWCG Glossary as follows: "A process used to improve the safety of personnel on the fireline, which emphasizes tools and tactics available to prevent being trapped in a burnover situation. This process includes appropriate decision making through risk management, application of LCES, use of pre-established trigger points, and recognition of suitable escape routes and safety zones.

- Avoiding situations where firefighters become entrapped is the first corcern when devising strategy and tactics. The following discussion points are among the things that should be considered.
- Review how LCES relates to the 10 Standard Fire Orders.
