**Gulch,** Shasta-Trinity NF. IMT 2 (Kaage). Three miles west of Platina, CA. Timber and brush. Group torching, spotting and backing fire. Structures threatened. Evacuation advisory in effect. Reduction in acreage due to more accurate mapping.

**Bear Wallow Complex**, Klamath NF. NIMO (Gage). NIMO also managing the Panther Fire. Previously reported confine/contain management strategy. Fourteen miles west of Etna, CA. Timber and brush. Wind-driven runs.

**Deerhorn**, Hoopa Valley Tribe. One mile southeast of Weitchpec, CA. Timber and grass. Backing fire.

**Siskiyou/Blue 2 Complex,** Klamath NF. Eighteen miles southwest of Happy Camp, CA. Timber and brush. Minimal fire activity with backing, occasional short uphill runs and single tree torching.

**Panther,** Klamath NF. Confine/contain management strategy. Fifteen miles south of Happy Camp, CA. Timber and brush. Active surface fire with some isolated torching.
