**Predictive Services Discussion:** A cold front will move onshore across the Pacific Northwest, bringing cloudy and cooler conditions, along with showers along the coast. However, further south across northeast California and Nevada, this system will bring gusty southwest winds of 20-35 mph with low humidity. Gradual warming and drying across the Southwest and into the Central Rockies as high pressure strengthens across the Four Corners region. Some of this warm, dry air will also spread further east, across the Ohio Valley and into much of the Southeast, except for coastal areas where heavy rain is expected. Elsewhere mainly seasonable early fall conditions.
