NIMO (Gage) and North Carolina IMT 2 (Hildreth) are assigned to manage large fires and provide support to initial attack operations for the West Branch Operational Area in Texas. Texas IMT 2 (Hannemann) is managing existing and new fires located in Texas state initial attack zones.

**Jarhead**, Big Cypress National Preserve. IMT 1 (Hughes). Seven miles north of Oasis, FL. Southern rough. Active fire behavior. Structures threatened.

**Pains Bay**, Alligator River NWR. IMT 1 (Quesinberry). Nineteen miles south of Manns Harbor, NC. Grass. Minimal fire activity. Structures threatened.

**Honey Prairie**, Okefenokee NWR. Georgia State IMT 2 (Kline). Fifteen miles northeast of Fargo, GA. Southern rough. Active fire behavior.

**Dickens County Complex** (three fires), Texas Forest Service. Seven miles southeast of Dickens, TX. Grass. Moderate fire activity. Structures threatened.

**Rock House**, Texas Forest Service. Twenty-one miles southwest of Fort Davis, TX. Grass. Minimal fire activity.

**Deaton Cole**, Texas Forest Service. Thirty-seven miles southwest of Ozona, TX. Brush and grass. Minimal fire activity.

**Oasis**, Texas Forest Service. Four miles northwest of Telegraph, TX. Hardwood slash, brush and grass. Minimal fire activity.

**Schwartz**, Texas Forest Service. Twenty miles east of Marathon, TX. Hardwood slash, brush and grass. Moderate fire activity. Structures threatened.

**611 Gas Plant**, Texas Forest Service. Thirteen miles northwest of Sweetwater, TX. Grass. Active fire behavior. Structures threatened.

**Gage Holland**, Texas Forest Service. Six miles west of Alpine, TX. Hardwood slash, brush and grass. Moderate fire activity. Structures threatened.

**Slope**, Florida DOF. Twelve miles east of East Naples, FL. Southern rough. No new information. Last report unless new information is received.

\* **Matt Loop**, Texas Forest Service. Five miles south of Big Springs, TX. Grass. Active fire behavior. Structures threatened.

\***Iron Mountain**, Texas Forest Service. Ten miles northwest of Alpine, TX. Grass. Active fire behavior.
