NIMO (Gage) and North Carolina IMT 2 (Hildreth) are assigned to manage large fires and provide support to initial attack operations for the West Branch Operational Area in Texas. Texas IMT 2 (Hannemann) is managing existing and new fires located in Texas state initial attack zones.

Jarhead, Big Cypress National Preserve. Transfer of command from IMT 1 (Hughes) to local unit tomorrow. Seven miles north of Oasis, FL. Southern rough. Moderate fire activity. Structures threatened.

Pains Bay, Alligator River NWR. IMT 1 (Quesinberry). Nineteen miles south of Manns Harbor, NC. Brush. Minimal fire activity.

Honey Prairie, Okefenokee NWR. Georgia IMT 2 (Kline). Fifteen miles northeast of Fargo, GA. Southern rough. Active fire behavior.

Predictive Services Discussion: critical fire weather conditions due to low relative humidity of 25-35 percent will develop over parts of southern Florida and the Florida Panhandle. Elsewhere, weakening winds but relative humidity below 15 percent across the Southwest will limit near-critical fire weather conditions to parts of far West Texas. A complex frontal system in the central US will trigger showers and thunderstorms from the Great Lakes to southern Texas with strong thunderstorms possible from lowa to the Texas coast. Scattered showers and thunderstorms will also develop from western New York to Florida. In the West, a cold front entering the Great Basin will spread rain and snow showers across the Pacific Northwest.
