**Table Mountain**, Okanogan/Wenatchee NF. IMT 1 (Morcom). Eight miles northeast of Cle Elum, WA. Timber, logging slash, brush and grass. Backing fire with short upslope runs. Numerous structures threatened. Evacuations and road closures in effect.

**Wenatchee Complex** (10 fires), Okanogan/Wenatchee NF. Transfer of command from IMT 1 (Pendleton) to IMT 1 (Reinarz) will occur today. Two miles west of Wenatchee, WA. Timber, brush and grass. Upslope runs with spotting. Numerous residences threatened. Evacuations in effect.

**Goat**, Okanogan/Wenatchee NF. IMT 2 (Leitch). Three miles southwest of Pateros, WA. Timber and grass. Active fire behavior with torching and short-range spotting. Numerous structures threatened.

**Cascade Creek**, Gifford Pinchot NF. IMT 2 (Nickey). Eight miles north of Trout Lake, WA. Timber. Active fire behavior.

**Pole Creek**, Deschutes NF. Transfer of command from IMT 2 (Watts) back to the local unit will occur 9/29. Six miles southwest of Sisters, OR. Timber. Minimal fire activity with occasional torching. Numerous residences threatened.

**Okanogan Complex** (3 fires), Okanogan/Wenatchee NF. Transfer of command from IMT 2 (Williams) back to the local unit will occur today. Eight miles southeast of Carlton, WA. Timber. Backing fire with isolated torching. Structures threatened.

**Yakima Complex**, Okanogan/Wenatchee NF. Seventeen miles northwest of Ellensburg, WA. Timber, brush and grass. No new information.

**McGuire Complex** (2 fires), Nez Perce NF. IMT 1 (Joseph). One mile northwest of Dixie, ID. Timber. Creeping and smoldering with occasional single tree torching and short-range spotting. Communities threatened. Evacuations in effect.

**Sheep**, Nez Perce NF. IMT 1 (Turman). One mile east of Lucille, ID. Timber, brush and grass. Moderate fire activity with occasional torching. Structures threatened. Precipitation occurred over the fire area yesterday.

**Condon Mountain**, Flathead NF. IMT 2 (Pearson). Three miles northeast of Condon, MT. Timber. Backing fire with isolated group tree torching and short uphill runs. Residences threatened. Area closures in effect.

**Eagle Creek**, Northern Cheyenne Agency, BIA. IMT 2 (Heintz). Thirteen miles southwest of Lame Deer, MT. Grass. Creeping and smoldering. Reduction in acreage due to more accurate mapping.

**Sawtooth**, Bitterroot NF. IMT 2 (Hall). Seven miles southwest of Hamilton, MT. Timber. Creeping and smoldering with single tree torching. Numerous structures threatened.

Millie, Gallatin NF. Twenty miles south of Bozeman, MT. Timber. Creeping and smoldering.

**Cottonwood Creek**, Dakota Prairie National Grasslands. Started on private land thirty miles southwest of Watford City, ND. Juniper, brush and grass. Creeping with single tree torching. Residences threatened. Reduction in acreage due to more accurate mapping.

# What the SAFECOM system IS

The Aviation Safety Communiqué (SAFECOM) AMD-34/FS-5700-14 should be used to report any condition, observation, act, maintenance problem, or circumstance with personnel or the aircraft that has the potential to cause an aviation-related mishap. SAFECOMS are a tool used to identify, document, track, and correct safety related issues.

#### What the SAFECOM system IS NOT

- NOT intended for initiating punitive actions,
- NOT to be used as a complaint system or for personal attacks,
- NOT used by contracting officers for contract evaluations/award purposes,
- NOT a substitute for "on-the-spot" corrections to a safety concern,
- Does NOT replace the requirement for initiating an accident or incident report.

#### SAFECOMs provide the necessary feedback for development of the following communication tools:

- Accident Prevention Bulletins
- Lessons Learned
- Safety Alerts
- Technical Bulletins

- Airwards
- Information sharing Memos
- Maintenance deficiencies (ADs, SBs, etc)
- Safety trends
- Training needs
