Extreme fire behavior with sustained crown runs and long-range spotting. Numerous structures, youth camps, communication site and a ski area are threatened. Evacuations in effect.

Bison, Western Nevada Agency, BIA. IMT 2 (Whalen). Five miles east of Gardnerville, NV. Pinyon pine, juniper and brush. Smoldering with isolated torching. Structures threatened. Evacuations and road closures in effect. Reduction in acreage due to more accurate mapping.

Black, Ely District, BLM. Previously reported incident. Fifteen miles south of Baker, NV. Pinyon pine and juniper. Crowning and spotting. Last report unless significant activity occurs.

* **White Pine**, Humboldt-Toiyabe NF. Twenty-eight miles south of Ely, NV. Timber and grass. Torching. Last report unless significant activity occurs.

Predictive Services Discussion: Scattered thunderstorms will develop across southern California, the Southwest, the Great Basin, and the southern and central Rockies. Most storms will produce some rain but a few could produce locally heavy rain. Temperatures will remain very warm in the Southwest but will cool slightly in the northern half of the West. Heat will continue across the Plains with mild to warm conditions east of the Mississippi. Scattered thunderstorms will form along the Gulf and Atlantic Coasts. In Alaska, warmer conditions will develop over most of the state with only an isolated shower or thunderstorm in the Interior.

ESCAPE ROUTES

*LCES (Lookouts, Communication, Escape Routes, and Safety Zones)
Category*



An escape route is a preplanned and understood route to reach a safety zone.

- What are the primary concerns in choosing an escape route?
 - Select the closest, least obstructed route.
 - Plan for more than one escape route.
 - Avoid an uphill escape.
 - Scout and clearly mark the route for visibility (aids during smoky situations or night operational periods). NWCG recommends using hot-pink flagging marked "Escape Route" (NFES 0566). Crews with colorblind members may wish to carry and utilize fluorescent chartreuse flagging (NFES # 2396).
 - Determine escape time--consider slowest person, fatigue, and temperature factors.
 - Continuously reassess the situation with regard to work progress and additional resource arrivals.
 - Assure all line personnel are familiar with escape routes.
 - Vehicles parked for escape.
