Rockport, Northwest Area, Utah DOF. Ten miles northeast of Park City, UT. Brush and grass. Active fire behavior. Structures threatened. Evacuations and area closures in effect.

Millville, Bear River Area, Utah DOF. Six miles southeast of Logan, UT. Timber and grass. Active fire behavior. Numerous structures threatened. Evacuations in effect.

Beaver Creek, Twin Falls District, BLM. IMT 1 (Lund). Twelve miles northeast of Fairfield, ID. Timber, brush and grass. Extreme fire behavior with crowning. Structures threatened. Forest closures in effect.

Pony Complex, Boise District, BLM. IMT 2 (Wilde). Twelve miles north of Mountain Home, ID. Timber, brush and grass. Active fire behavior with single tree torching and short-range spotting. Structures threatened. Road and area closures in effect.

Elk Complex, Boise NF. Includes previously reported Elk incident. IMT 1 (Harvey). Ten miles southwest of Pine, ID. Timber, brush and grass. Extreme fire behavior with crown runs and long-range spotting. Numerous structures threatened. Evacuations, road and area closures in effect.

Patch Springs, Salt Lake Field Office, BLM. Two miles northwest of Terra, UT. Timber. Active fire behavior with group tree torching. Structures threatened.

State, Bear River Area, Utah DOF. IMT 2 (Day). Eight miles west of Portage, UT. Timber, brush and grass. Active fire behavior. Structures threatened. Evacuations in effect.

McCan, Twin Falls District, BLM. IMT 2 (Kidd). Four miles northwest of Fairfield, ID. Timber, brush and grass. Creeping and smoldering with single tree torching. Structures threatened. Reduction in acreage due to more accurate mapping.

Placer, Boise NF. Four miles south of Idaho City, ID. Timber, brush and grass. Moderate fire behavior with group tree torching.

Tank, Boise District, BLM. Twenty miles southeast of Jordan Valley, OR. Timber, brush and grass. Creeping with occasional single tree torching.

Lodgepole, Salmon-Challis NF. IMT 2 (Whalen). Ten miles west of Challis, ID. Timber and brush. Creeping with isolated torching. Road closure in effect.

Ridge, Boise NF. Fourteen miles northeast of Lowman, ID. Timber. Creeping and smoldering with isolated torching.

Predictive Services Discussion: A cold front will bring showers and a few thunderstorms to western Washington and northwestern Oregon. Scattered showers and thunderstorms will continue over the Southwest, with widely scattered thunderstorms over the central Rockies and the higher elevations of Utah. Scattered showers and thunderstorms will spread across the Plains and the Southeast. Temperatures will continue very warm over the West and the South, with some cooling in the Northwest. The Upper Midwest, Great Lakes, and much of the East will remain mild.

MY SAFETY

Miscellaneous Category

An important aspect of safety is individual responsibility for one's own health & safety. Even with the best supervision, each individual firefighter will occasionally be required to make personal decisions concerning their safety. It is important that individual responsibility be taught as the basis for a viable safety program. Some of those individual responsibilities are:

- Fitness for duty. Begin each work shift both mentally and physically prepared for the rigors of wildland firefighting. Getting adequate sleep, maintaining a healthy diet, and proactively participating in physical training are the foundation of "My Safety".
- Utilization of personal protective equipment. Wear your PPE without being told. Each individual is responsible for performing their own risk assessments. If a hazard is identified that can be mitigated by wearing a particular PPE component it should be utilized. Fireline supervisors have more important duties to focus on other than performing glove patrol.
- Following safe work practices. Using a spotter when backing up vehicles is the prudent and professional course of action. If you are unsure of how to perform a job task safely, ask your supervisor or experienced coworker.
- Using the correct reference materials is an important aspect of safety. You should have a working knowledge of the Red Book, FLHB, IRPG, and your local operating guidelines.
- Ensure instructions are clearly understood. Communication is a basic responsibility for all fire personnel. Ask appropriate questions to clarify uncertain issues. Speak up when you observe hazards that may place yourself or others at risk.
- Maintain situational awareness at all times. Awareness is a vital component of "My Safety". Pay attention to what is happening around your area of operations. Always display an awareness of what is happening around you by asking questions or making comments.

Summary: Do not expect someone else to be responsible for your safety. Take it upon yourself to make "My Safety" your number one priority.

Discussions points:

1. Talk about ways you can improve on your safety.
2. Have your supervisor talk about their expectations for individual safety.
