- * Watermelon Hill, Washington State Fire Marshal's Office, DNR. IMT 2 (Leitch). Started on private land seven miles southwest of Cheney, WA. Timber and grass. Active fire behavior with long-range spotting. Evacuations and area closures in effect.
- * **0297 PR**, Prineville District BLM. Started on private land three miles northeast of Post, OR. Juniper, brush and grass. Active fire behavior with single tree torching.

Carlton Complex, Northeast Region, DNR. IMT 1 (Opliger), IMT 2 (Rabe), IMT 2 (Allbee) and NIMO (Hahnenberg). Seven miles south of Twisp, WA. Timber, light logging slash and brush. Moderate fire behavior. Communities of Brewster and Malott threatened. Evacuations and road closures in effect.

* Chiwaukum Complex, Okanogan/Wenatchee NF. IMT 1 (Lewis). IMT is also managing the Mills Canyon fire. Includes previously reported Chiwaukum Creek fire. Nine miles northwest of Leavenworth, WA. Timber, heavy logging slash and brush. Active fire behavior with torching and long-range spotting. Numerous residences threatened. Evacuations, area and road closures in effect.

Mills Canyon, Southeast Region, Washington DNR. Two miles southwest of Entiat, WA. Timber, brush and grass. Creeping and smoldering. Residences threatened. Area closures have been lifted.

^{**} Uncontained large fires include only fires being managed under a full suppression strategy.

Waterman Complex, John Day Unit, Oregon DOF. IMT 2 (D. Johnson). Twenty miles northeast of Mitchell, OR. Timber, brush and grass. Active fire behavior with crown runs and long-range spotting. Structures threatened. Evacuations, area and road closures in effect.

Buzzard Complex (6 fires), Burns District, BLM. IMT 1 (Poncin) and IMT 2 (Watts). Thirteen miles northwest of Riverside, OR. Juniper, brush and grass. Minimal fire behavior. Structures threatened.

Sunflower, Umatilla NF. IMT 2 (Wilde). Ten miles north of Monument, OR. Timber and grass. Running fire with crowning and spotting. Structures threatened.

Pine Creek, Prineville District, BLM. IMT 2 (Fry). IMT is also managing the Black Rock fire and the Jack Knife fire. Eleven miles south of Fossil, OR. Juniper, brush and grass. Moderate fire behavior with group torching. Residences threatened.

* **Black Rock**, Prineville District, BLM. Started on private land ten miles east of Antelope, OR. Juniper and grass. Running fire with torching. Residences threatened.

Jack Knife, Prineville District, BLM. Eight miles southeast of Grass Valley, OR. Juniper, brush and grass. Creeping and smoldering.

Shaniko Butte, Warm Springs Agency, BIA. IMT 2 (Williams). Fifteen miles north of Warm Springs, OR. Juniper, brush and grass. Moderate fire behavior. Numerous structures threatened. Area closures in effect.

Pittsburg, Wallowa-Whitman NF. IMT 2 (B. Johnson). Twenty-one miles southwest of Grangeville, ID. Timber, brush and grass. Minimal fire behavior. Residences threatened. Area closures in effect.

Bridge 99 Complex, Deschutes NF. IMT 2 (Fillis). Twenty miles north of Sisters, OR. Mixed conifer, brush and grass. Active fire behavior with group torching and long-range spotting. Numerous structures threatened. Evacuations, area and road closures in effect. Reduction in acreage due to partitioning Bear Butte 2 fire with Logging Unit Complex.

* Logging Unit Complex (4 fires), Warm Springs Agency, BIA. IMT 1 (Schulte). Includes previously reported Logging Unit fire. Twenty-five miles northwest of Warm Springs, OR. Timber. Short-range spotting and occasional torching.

Bingham Complex (2 fires), Willamette NF. IMT 2 (Nickey). Five miles east of Marion Forks, OR. Timber. Isolated single tree torching. Structures threatened. Reduction in acreage due to more accurate mapping.

* 0386 PR Fox, Ochoco NF. Fourteen miles northwest of Paulina, OR. Timber and grass. Active fire behavior.

Oscar Canyon, Prineville District, BLM. Thirteen miles east of Post, OR. Juniper, brush and grass. No new information.

Lone Mountain 1, North Cascades NP. IMT 2 (Hutton). Three miles northeast of Stehekin, WA. Timber and brush. No further information received.

R Road, Spokane District, BLM. Ten miles east of Mansfield, WA. Brush and grass. No new information.

Gumboot, Burns District, BLM. Four miles north of Riley, OR. Timber, brush and grass. No new information.

White River, The Dalles Unit, Oregon DOF. Transfer of command from IMT 2 (Buckman) back to the local unit occurred yesterday. Fifteen miles west of Maupin, OR. Timber. No new information. Last report unless new information is received.

Predictive Services Discussion: The Pacific Northwest will see slightly less wind today but cooler temperatures and higher relative humidity. Generally wet showers and thunderstorms will continue over northern California and the western Great Basin where monsoon moisture continues to stream northward. Warming and drying are expected for much of the southwest U.S. and central Rockies with a ridge of high pressure. Showers and thunderstorms will also be focused along a stalled front stretching from the Gulf Coast states through the Appalachian Mountains

ENTRAPMENT AVOIDANCE

Operational Engagement Category

Avoiding situations where firefighters become entrapped is the first concern when devising strategy and tactics. The following discussion points are among the things that should be considered.

- Discuss the three types of safety zones and describe examples.
 - The burn
 - Natural features
 - Constructed sites
- Discuss the guidelines for distance separation to avoid radiant heat injury.
 - Four times the maximum flame height (20 feet-flame height x 4 = 80 feet radius from firefighters)
 - Discuss size based on amount of resources and equipment in the area.
- Discuss heat impact factors that will affect the guidelines for distance separation.
 - Convection heat from wind and terrain features
 - Location relative to fire spread
 - · Reburn potential of fuel in safety zone
- Discuss that firefighter's have a right to know the location of their escape routes and safety zones at all times.
- Discuss that firefighter have a right to ask for clarification when faced with unclear instructions or fear of the unknown.
- Describe a basic procedure for identification of effective escape routes and safety zones.

 - Identify
 - Time
 - Inform
 - Evaluate
