Cowbell, Big Cypress National Preserve, NPS. Transfer of command from IMT 1 (Wilkins) back to the local unit occurred yesterday. Thirty six miles west of Weston, FL. Tall grass, southern rough and timber. Moderate fire behavior with backing, creeping and isolated torching. Structures threatened. Area and trail closures in effect.

West Mims, Okefenokee National Wildlife Refuge. Georgia IMT 2 (Kline). Sixteen miles southeast of Fargo, GA. Timber and southern rough. Active fire behavior with flanking and backing. Structures threatened. Road, area and trail closures in effect.

30th Ave., Previously reported as 30th St. Florida Forest Service. Florida IMT 2 (Kern). Nine miles east of Golden Gate, FL. Southern rough. Minimal fire behavior with smoldering.

Parliament, Big Cypress National Preserve, NPS. Five miles northeast of Ochopee, FL. Southern rough and tall grass. Minimal fire behavior with smoldering. Area and trail closures in effect. Last report unless significant activity occurs.

* **Blackpoint**, Merritt Island National Wildlife Refuge. Three miles east of Titusville, Florida. Tall grass and southern rough. Moderate fire behavior with torching. Structures threatened.

Lead Place, Florida Forest Service. Six miles south of Tarrytown, FL. Southern rough. Minimal fire behavior.

Sod Farm 2, Florida Forest Service. Eight miles west of Orange City, FL. Southern rough. Minimal fire behavior.

* **MM 87 on 75**, Florida Panther National Wildlife Refuge. One mile southwest of Miles City, FL. Tall grass, southern rough and timber. Moderate fire behavior with isolated torching, backing and flanking.

* **Red Grange Blvd**, Florida Forest Service. Five miles southeast of Lakeshore, FL. Southern rough. Minimal fire behavior.

Predictive Services Discussion: A broad trough will slowly move across the U.S. through midweek before shifting to the eastern states as a ridge builds over the West Coast. A strong low pressure system will develop across the southern Plains, bringing spring snows to the central Rockies and High Plains over the weekend. As the storm moves east, rain and thunderstorms will spread across the country with heavy rain early in the week from Louisiana to the Great Lakes and continuing in the Southeast over midweek. The West will remain mostly dry with a couple of weak disturbances bringing scattered mixed precipitation to the Northwest and the Northern Rockies. Very warm conditions will precede the rains in the East over the weekend, then cool down across the eastern two-thirds of the nation for the work week. In the West, a gradual warmup will bring very warm weather to the Southwest and mild conditions farther north. In Alaska, a series of weak lows will move through the Gulf, bringing southerly flow and scattered showers to the southern and central regions of the state through the week. Temperatures will warm slowly across the state but will remain mild in the south and cool in the north. <http://www.predictiveservices.nifc.gov/outlooks/outlooks.htm>



LOOKOUTS (LCES)

Operational Engagement Category

Lookouts are often better situated to notice the cumulative changes of fire behavior.

- Fire Order #5 says “Post lookouts when there is possible danger.” Should you utilize lookouts at all times?
 - Lookouts should be posted at all times.
- What are you looking for when you are selecting a lookout location?
 - Choose a good vantage point, preferably with a good overview of the entire area where firefighters are located, including escape routes and safety zones.
 - Never rely exclusively on aircraft as your lookout.
- What are the desired qualities, capabilities, knowledge, and responsibilities of a lookout person?
 - Experienced firefighter.
 - Solid knowledge of fire behavior and ability to recognize and monitor other environmental hazards.
 - Knowledge of crew locations, escape and safety locations and trigger points.
 - Good communicator--keeps the crew advised of fire behavior changes, tracks weather trends and relays the information, informs crew of work progress and updates from the latest strategy and tactical briefings.
 - Monitors and accounts for all individuals within his/her assigned area at all times, and will notify others if breaks are needed.
- What is the necessary equipment for a lookout?
 - PPE, radio with extra batteries, compass, binoculars, belt weather kit, IAP, map, food, water and watch.
