**Nena Springs**, Warm Springs Agency, BIA. IMT 2 (Harrod). Seven miles northeast of Simnasho, OR. Timber and short grass. Minimal fire behavior. Structures threatened. Road and area closures in effect.

**Bridge Creek**, Colville Agency, BIA. IMT 2 (Sheldon). Eleven miles northeast of Keller, WA. Timber, tall grass, and light logging slash. Active fire behavior with backing, creeping and flanking. Road and area closures in effect. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

**Falcon Complex**, Umpqua NF. IMT 2 (Johnson). Twenty-five miles east of Tiller, OR. Timber, brush and grass. Active fire behavior with flanking, isolated torching, and smoldering. Structures threatened. Road closures in effect.

**Blanket Creek**, Rogue River - Siskiyou NF. IMT 1 (von Tillow). IMT is also managing the Spruce Lake fire. Nine miles northeast of Prospect, OR. Timber. Active fire behavior with smoldering and creeping. Structures threatened. Road, trail and area closures in effect.

**Spruce Lake**, Crater Lake National Park. Fifteen miles southwest of Diamond Lake, OR. Timber. No new information.

**Whitewater**, Willamette NF. IMT 1 (Schulte). Ten miles east of Idanha, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Structures threatened. Road, trail and area closures in effect.

**Noisy Creek**, Colville NF. IMT 2 (Rabe). Six miles southeast of Metaline Falls, WA. Timber and brush. Moderate fire behavior with backing, creeping and smoldering. Residences threatened. Evacuations, road, trail and area closures in effect. Precipitation occurred over the fire area yesterday.

**Flounce**, Medford District, BLM. ODF IMT 1 (Hessel). Started on state land 12 miles northwest of Shady Cove, OR. Timber, brush and tall grass. Minimal fire behavior with creeping and smoldering.

**Bear Butte**, Wallowa - Whitman NF. Twenty miles northwest of Baker City, OR. Timber. Minimal fire behavior. Structures threatened. Road and area closures in effect.

**Indian Creek**, Mt. Hood NF. Transfer of command from NIMO (Quesinberry) back to the local unit will occur on 8/17. Six miles south of Cascade Locks, OR. Timber. Minimal fire behavior with smoldering and creeping. Trail and area closures in effect. Precipitation occurred over the fire area yesterday.

**Chetco Bar**, Rogue River - Siskiyou NF. NIMO (Houseman). Sixteen miles west of Selma, OR. Timber and brush. Minimal fire behavior with flanking and backing. Road and trail closures in effect.

**Diamond Creek**, Okanogan - Wenatchee NF. IMT 2 (Andrews). Twenty-five miles north of Winthrop, WA. Timber and grass. Active fire behavior with short-crown runs, torching and spotting. Structures threatened. Road, trail and area closures in effect. Precipitation occurred over the fire area yesterday.

**Jones**, Willamette NF. IMT 2 (Ciraulo). Ten miles northeast of Lowell, OR. Timber and grass. Active fire behavior with torching, flanking and creeping. Structures threatened. Evacuations, road, trails and area closures in effect.

\* **Umpqua North Complex**, Umpqua NF. IMT 1 (Kurth). Fifty miles east of Roseberg, OR. Timber, brush and grass. Moderate fire behavior with creeping, smoldering and isolated torching. Residences threatened. Evacuations, road, area and trail closures in effect.

\* **Milli**, Deschutes NF. IMT 1 (Pearson) Nine miles west of Sisters, OR. Timber. Active fire behavior with wind-driven runs and spotting. Road, trail and area closures in effect.

**Jolly Mountain**, Okanogan - Wenatchee NF. IMT 2 (Sinclair). Thirteen miles northwest of Cle Elum, WA. Timber. Minimal fire behavior. Structures threatened. Trail and area closures in effect. Reduction in acreage due to more accurate mapping.

**Whychus**, Ochoco NF. Ten miles northeast of Sisters, OR. Brush and tall grass. Minimal fire behavior with creeping and smoldering. Structures threatened. Road and area closures in effect.

**East Saddle**, Mid-Columbia National Wildlife Refuge Complex. Ten miles west of Othello, WA. Brush and short grass. Moderate fire behavior. Structures threatened.

\* **Head Water**, Southeast Region, Washington DNR. Twenty-five miles north of Goldendale, WA. Timber. Moderate fire behavior. Structures threatened.

\* **Shan Creek**, Rogue River-Siskiyou NF. Ten miles west of Grants Pass, OR. Medium logging slash, timber and grass. Active fire behavior with flanking, group torching and uphill runs. Structures threatened. Road closures in effect.

Area Command Team (Stutler) is managing large fires on the Lolo National Forest and Flathead Reservation.

**Rice Ridge**, Lolo NF. IMT 2 (Goldman). Six miles north of Seeley Lake, MT. Timber. Active fire behavior with group torching, short-crown runs and uphill runs. Structures threatened. Road, trail and area closures in effect.

**Lolo Peak**, Lolo NF. Transfer of command from IMT 1 (Livingston) to IMT 1 (Poncin) will occur tomorrow. Ten miles southwest of Lolo, MT. Timber. Active fire behavior with torching, spotting and wind driven runs. Residences threatened. Evacuations, road, trail and area closures in effect.

**Sunrise**, Lolo NF. IMT 1 (Turman). IMT is also managing the Burdette fire. Eleven miles east of Superior, MT. Timber and brush. Active fire behavior with single-tree torching, short-range spotting and backing. Structures threatened. Road, trail and area closures in effect.

**Burdette**, Lolo NF. Thirteen miles southeast of Tarkio, MT. Timber. Minimal fire behavior with creeping and smoldering.

**Gibraltar Ridge**, Kootenai NF. IMT 2 (Connell). Seven miles east of Eureka, MT. Timber. Moderate fire behavior with spotting and single-tree torching. Residences threatened. Evacuations, road, trail and area closures in effect.

**Sapphire Complex** (3 fires), Lolo NF. IMT 2 (Pearson). Fifteen miles southeast of Clinton, MT. Timber. Moderate fire behavior with torching and backing. Structures threatened. Evacuations, road, trail and area closures in effect.

**Meyers**, Beaverhead - Deerlodge NF. IMT 2 (Esperance). Twenty-five miles southwest of Philipsburg, MT. Timber. Minimal fire behavior with torching, smoldering and creeping. Structures threatened. Evacuations, road and area closures in effect.

**Hanover**, Nez Perce - Clearwater NF. IMT 2 (Leach). Four miles northeast of Florence, ID. Timber, brush and grass. Moderate fire behavior with uphill runs and long-range spotting. Structures threatened. Road, trail and area closures in effect.

**Liberty**, Flathead Agency, BIA. Transfer of command from IMT 1 (McGowan) to IMT 2 (Rohrer) will occur tomorrow. Seventeen miles southeast of Arlee, MT. Timber. Minimal fire behavior with smoldering and creeping. Road, trail and area closures in effect. Precipitation occurred over the fire area yesterday.

**Park Creek**, Helena - Lewis and Clark NF. IMT 2 (Zombro). IMT is also managing the Arrastra Creek fire. Two miles north of Lincoln, MT. Timber. Minimal fire behavior with backing, creeping and smoldering. Structures threatened. Trail closures in effect.

**Arrastra Creek**, Helena - Lewis and Clark NF. Six miles northwest of Lincoln, MT. Timber. Minimal fire behavior with backing, creeping and single-tree torching. Structures threatened. Area closures in effect.

**Buck**, Idaho Panhandle NF. Sixteen miles southeast of Avery, ID. Timber and brush. Minimal fire behavior with isolated torching.

**Willow Creek**, Lewistown Field Office, BLM. Fifteen mile southeast of Lewistown, MT. Timber and short grass. Minimal fire behavior with creeping and smoldering.

**Predictive Services Discussion:** A breezy, post frontal westerly flow will continue across the northwestern states as a cold front moves east across the Northern Rockies. Scattered storms will be possible ahead of the approaching front. The Pacific Northwest, California, and the eastern two thirds of the Great Basin should be free of convection by afternoon. The Central Rockies and the Southwest will remain moist as monsoonal moisture continues to flow into both regions. Looking elsewhere, the Mid-Atlantic States and the Deep South will remain wet as a cold front remains stalled along the Atlantic and Gulf coasts. The Northeast can expect overall cool and breezy conditions that are fall-like.

## HAZARD TREE *SECURE FELLING AREA*

*Felling Safety Category*

The following fundamental safety principles for tree felling operations have been established based on repeated lessons learned following serious accidents. To protect sawyers, swampers, and operational personnel from exposure to potential traumatic injury or death during tree felling operations, the following safety procedures should be applied to all felling activities. Fireline supervisors should continue to monitor all felling operations to ensure the following safe job procedures are consistently applied:



- A secure felling area, **MINIMUM OF TWO AND ONE HALF (2.5) TIMES THE HEIGHT OF THE MATERIAL BEING FELLED IN ALL DIRECTIONS**, needs to be established and maintained by the faller during all tree felling operations. In addition, the entire downhill side on slopes must be secured if materials can fall/role for a long, unpredictable distance.
- No one shall be permitted in the secured felling area without the authorization of the faller.
- The faller shall establish a safety zone outside the secured area, and direct EVERYONE to remain there until all felling is completed, and an "all clear" has been communicated.
- Safety zones should be established, whenever practical, in the opposite direction of the planned fall, and at a distance of at least 2.5 times the height of the trees being felled.
- The faller shall assign lookout(s). The lookout(s) shall have reliable communications with the faller, and other personnel adjacent to the secure areas.
- Competent lookouts shall be established and maintained by the faller at all major access points of roads and trails that afford access to the secured felling area.
- The faller will ensure that no hazards remain such as hang-ups, unstable logs, or other dangers before approving access or leaving the secured area
