Predictive Services Discussion: A weakening cold front moving through the Pacific Northwest and the Northern Rockies will collect the monsoonal moisture and move it into the northern Great Plains where it will produce scattered wet storms. Behind the front over Oregon, Washington, northern Idaho and western Montana, expect breezy conditions to develop. With the thermal ridge still in place over the Southwest and California, hot and dry conditions will continue with overall poor overnight recoveries expected. The remnants of Harvey will move northeast toward Arkansas. Flooding concerns will expand northeastward into the Ozarks, where localized flooding concerns will arise. Meanwhile, the rain along the Texas coast will end.

## **SERIOUS INJURY PROCEDURES**

Firefighter Health & First Aid

Dealing with serious injuries on the fireline can add even more stress to our hectic work environment. In the event a fireline accident occurs, adherence to the following principles is important to insure an adequate and appropriate response is made.

Before entering the scene, determine whether it is safe to approach. Look for hazards as well as what may have happened. It may be necessary to move the patient or to make the area safe before doing an assessment.

Provide first aid and assess the extent of the injuries.

Make contact with your supervisor. Depending on the complexity of the fire, that could be your crew boss, the Division Supervisor, the IC, or even dispatch. If your fire has a medical plan, follow the plan.

Provide them with accurate, concise information on the following

- Number of people injured
- Type of injuries
- Severity of injuries (light, moderate, severe, life threatening)
- Mechanism of injury
- Vital signs (pulse, respirations, level of consciousness, etc)

Determine the best method of evacuation. Depending on the severity of injury or availability of resources, this decision may already be made for you.

Keep the radio frequency clear of non-emergency traffic, provide updates of the patient's condition and await instructions.

If evacuation is by helicopter, it may be necessary to construct a helispot. Document treatment provided in case it is necessary to send the information along with the patient in the aircraft.

If the patient needs to be carried to a road, insure enough people are available to work in relays.

Once the patient is clear, take a moment to write down witness statements, clean up notes and timelines, and document any other pertinent information.
