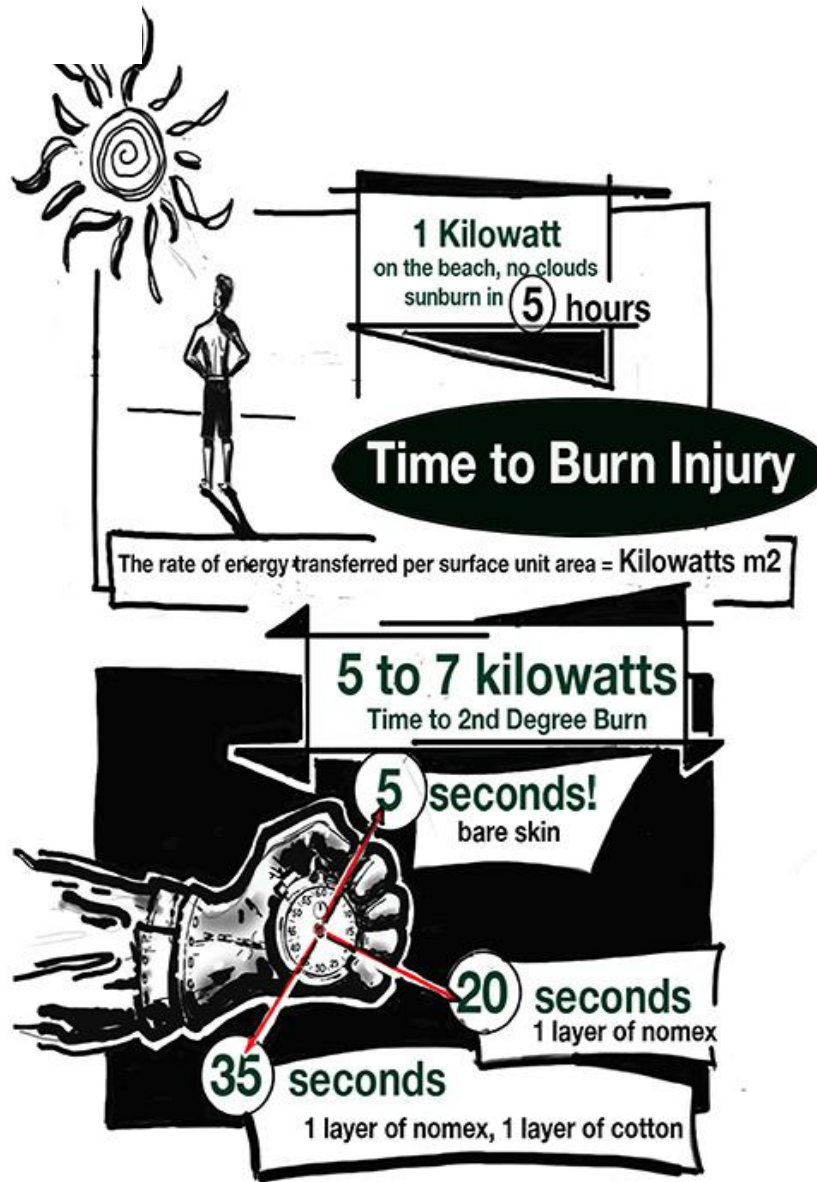
Predictive Services Discussion: Warm and dry conditions will continue across most of the West as high pressure remains centered over the Great Basin and the Pacific Northwest. A low pressure area off the Northern Californian Coast will produce isolated wet storms across the northern Sierras in the afternoon. East of the Continental Divide, an area of low pressure over the Great Lakes will produce cool, wet conditions around the Lakes region and cool conditions elsewhere...even as far south as northern Florida. In Alaska, the low pressure area over the Bering Sea will move north and will spread additional snow and rain showers across the western Interior. Weak high pressure along the border with the Yukon Territory will keep the eastern Interior mostly dry.
