On July 27<sup>th</sup> two firefighters were fatally injured, one with the Redding Fire Department and one on contract with Cal Fire, while suppressing the Carr fire in Redding, CA. The firefighting community extends condolences to the family and friends of the deceased.

On July 29<sup>th</sup> an Arrowhead Interagency Hotshot Crew firefighter was fatally injured while suppressing the Ferguson fire near Mariposa, CA. The firefighting community extends condolences to the family and friends of the deceased.

Two MAFFS C-130 airtankers and support personnel from the 146th Airlift Wing (California Air National Guard) have been deployed to McClellan Airfield, CA in support of wildland fire operations.

The U.S. has mobilized 12 federal wildland firefighters to support fire suppression efforts in Ontario, Canada.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Spokane, WA in support of wildland fire operations in the West.

**Garner Complex** (4 fires), Grants Pass Unit, ODF. Transfer of command from ODF IMT 1 (Cline) to ODF IMT 1 (Hessel) will occur today. IMT 2 (Schulte). Four miles east of Cave Junction, OR. Timber and medium logging slash. Active fire behavior with short crown runs, uphill runs and group torching. Numerous structures threatened. Evacuations, road and area closures in effect.

**Klondike**, Rogue River-Siskiyou NF. IMT 1 (Livingston). IMT is also managing the Natchez incident. Nine miles northwest of Selma, OR. Hardwood litter and brush. Active fire behavior with torching, long-range spotting and short crown runs. Residences threatened. Road and area closures in effect.

**Natchez**, Rogue River-Siskiyou NF. Fifteen miles southeast of Cave Junction, OR. Timber, chaparral and hardwood litter. Active fire behavior with torching, long-range spotting and short crown runs. Structures threatened. Road, area and trail closures in effect.

**Sugar Pine**, Rogue River-Siskiyou NF. IMT 2 (Gales). IMT is also managing the Goodview, Round Top and Union incidents. Twelve miles northwest of Prospect, OR. Timber. Active fire behavior with running, torching and spotting. Numerous structures threatened.

**Goodview**, Rogue River-Siskiyou NF. Ten miles northwest of Prospect, OR. Timber. Active fire behavior with running, backing and flanking. Road closures in effect.

**Round Top**, Rogue River-Siskiyou NF. Eight miles northeast of Prospect, OR. Timber. Minimal fire behavior.

**Union**, Rogue River-Siskiyou NF. Ten miles northeast of Prospect, OR. Timber. Minimal fire behavior.

**South Umpqua Complex** (4 fires), Umpqua NF. IMT 2 (Sheldon). Thirty miles southeast of Myrtle Creek, OR. Timber. Active fire behavior with long-range spotting, group torching and short crown runs. Residences threatened. Road and trail closures in effect.

**Long Hollow 0806 RN**, Prineville District, BLM. IMT 2 (Lawson). Started on private land five miles south of Dufur, OR. Brush and grass. Minimal fire behavior. Numerous residences threatened. Road, area and trail closures in effect.

**Timber Crater 6**, Crater Lake National Park, NPS. IMT 2 (Goff). IMT is also managing the Timber Crater 10 incident. Twenty miles southwest of Chemult, OR. Timber. Active fire behavior with isolated torching, short-range spotting and smoldering. Area closures in effect.

**Chelan Hills**, Southeast Region, Washington DNR. IMT 2 (Rabe). IMT is also managing the Cougar Creek incident. Two miles east of Chelan, WA. Timber, brush and short grass. Minimal fire behavior.

\* **Cougar Creek**, Okanogan/Wenatchee NF. Eight miles northwest of Manson, WA. Timber. Active fire behavior with group torching, single-tree torching and uphill runs. Trail closures in effect.

\* **Warner Gulch**, Southeast Region, Washington DNR. Eleven miles southwest of Asotin, WA. Brush and short grass. Active fire behavior. Structures threatened.

**Substation**, Wasco County. Started on private land five miles south of The Dalles, OR. Brush and tall grass. Minimal fire behavior.

**Cemetery**, Prineville District, BLM. Thirty-two miles southeast of Prineville, OR. Timber, brush and tall grass. Minimal fire behavior. Sage-grouse habitat threatened.

**Hendrix**, Rogue River-Siskiyou NF. Nine miles southwest of Ashland, OR. Timber and medium logging slash. Minimal fire behavior. Residences threatened. Road, area and trail closures in effect.

**Pole Creek**, Vale District, BLM. Started on state land 20 miles south of Jordan Valley, OR. Timber and short grass. Minimal fire behavior. Sage-grouse habitat threatened.

\* **Lake Wallula**, Mid Columbia National Wildlife Refuge, FWS. Started on BLM land five miles east of Umatilla, OR. Brush, tall grass, and short grass. Active fire behavior with backing and uphill runs. Residences threatened. Road and area closures in effect. Last narrative report unless significant activity occurs.

**Perry**, Carson City District, BLM. IMT 2 (Roide). Thirty miles northeast of Reno, NV. Brush, short grass and closed timber litter. Active fire behavior with running, backing and wind-driven runs. Numerous structures and sage-grouse habitat threatened. Evacuations, road, area and trail closures in effect.

**Goose Creek**, Elko District, BLM. IMT 1 (DeMasters). Thirty-three miles southeast of Jackpot, NV. Includes previously reported China Jim incident. Timber and brush. Active fire behavior with wind-driven runs, group torching and spotting. Structures and sage-grouse habitat threatened.

**Mesa**, Payette NF. IMT 2 (Chadwick). Four miles south of Council, Idaho. Brush and tall grass. Active fire behavior with group torching, running and flanking. Numerous structures and sage-grouse habitat threatened. Evacuations, road, area and trail closures in effect.

\* **Sharps**, Eastern Idaho Area, Idaho Department of Lands. IMT 1 (Lund) mobilizing. Six miles east of Bellevue, ID. Timber, brush and tall grass. Extreme fire behavior with running, uphill runs and torching. Structures and sage-grouse habitat threatened. Evacuations, road and area closures in effect.

**Grassy Ridge**, Idaho Falls District, BLM. IMT 2 (Rohrer). Fifteen miles northwest of St. Anthony, ID. Brush and short grass. Active fire behavior with wind-driven runs, running and spotting. Numerous structures, sage-grouse habitat and energy infrastructure threatened. Road and area closures in effect.

**Keithly**, Payette NF. Transfer of command from IMT 2 (Bird) back to the local unit will occur tomorrow. Started on private land four miles northwest of Midvale, ID. Brush and tall grass. Minimal fire behavior. Residences, sage-grouse habitat and energy infrastructure threatened. Area closures in effect.

**Cove Creek**, Fishlake NF. Twenty miles north of Beaver, UT. Timber and closed timber litter. Moderate fire behavior with backing, flanking and isolated torching. Structures, energy and communication infrastructure threatened. Road, area and trail closures in effect.

**Jim Sage**, Twin Falls District, BLM. Four miles southeast of Elba, ID. Brush and short grass. Moderate fire behavior with smoldering and torching. Structures and sage-grouse habitat threatened.

**Dollar Ridge**, Northeast Area, Utah DOF. Thirty-six miles southeast of Heber City, UT. Timber, brush and tall grass. Moderate fire behavior with single tree torching, creeping and smoldering.

**Lodgepole**, Boise NF. Sixteen miles northeast of Garden Valley, ID. Timber, brush and tall grass. Moderate fire behavior with group torching and single-tree torching.

**Raft River**, Salt Lake Field Office, BLM. Five miles southwest of Yost, UT. Timber, brush and short grass. Moderate fire behavior with smoldering, single-tree torching and creeping. Sage-grouse habitat threatened. Reduction in acreage due to more accurate mapping.

**Telegraph**, Humboldt-Toiyabe NF. Eight miles northeast of Austin, NV. Brush and short grass. Minimal fire behavior. Structures and sage-grouse habitat threatened.

\* **Area 19**, Nevada Test Site, Department of Energy. Thirty-six miles northeast of Beatty, NV. Timber and short grass. Active fire behavior with running and group torching. Structures threatened. Last narrative report unless significant activity occurs.

**Prescribed Service Discussion:** The Four Corners high pressure ridge will remain amplified and strong over the Intermountain West. Near-record high temperatures are expected in several inland locations. Monsoonal convection will be very limited in most areas except Southern California, Arizona, and New Mexico. Breezy southwest winds are expected along the northwestern coastline in the afternoon as a cold front begins to push on shore. In the East, a developing area of low pressure over Iowa will lead to the development of scattered storms. Its frontal boundary will push across Texas late in the day creating scattered wet storms. The southeastern states will remain wet and humid while the Mid-Atlantic States and New England remain warm and dry. In Alaska, a warming and drying trend will return to the Interior as high pressure along the international border begins to strengthen and begins to build into eastern portions of the state.

## On A Hillside Where Rolling Material Can Ignite Fuel Below

*Operational Engagement Category*

When firefighters find themselves in Watchout Situation #13, they must answer the following questions:

- Can you locate/construct a line to prevent material from rolling below? What do you call line that catches rolling material? Describe how you would construct this type of line and what factors you would have to consider (e.g., slope, fuels, etc.)
- Will you get enough warning of rolling material to prevent being hit by it? Who needs to be watching for rolling material? What kinds of warning systems could you establish?
- Can you see where any material that rolls below you goes and what it does? What can happen when material rolls out of the fire and below you out of view? What needs to be done to mitigate this danger?
- Is the area free of large amounts of flashy fuels? Review the Common Denominators of Tragedy Fires.
- Is the area free of chimneys, gullies, and steep slopes? Review the Common Denominators of Tragedy Fires.
- Do you have two escape routes so you can go either way? Talk about where your most likely escape routes and safety zones will be when you are on a hillside where rolling material can ignite fuel below.
- To reduce the risks:
  - Post lookouts.
  - Consider locating line in a defensible position.
  - Talk about steep fires where you have had material rolling out below you and how you dealt with it.
