One hundred thirty-eight fireline management personnel from Australia and New Zealand are assigned to support large fires in the California and Northwest Areas.

Two MAFFS C-130 airtankers and support personnel from the 152nd Airlift Wing (Nevada Air National Guard), one from the 146th Airlift Wing (California Air National Guard) and one from the 302nd Airlift Wing (Colorado Springs, Air Force Reserve) have been deployed to McClellan Airfield, CA in support of wildland fire operations.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Spokane, WA in support of wildland fire operations in the West.

**Cougar Creek,** Okanogan/Wenatchee NF. IMT 1 (Young). IMT is also managing the Bannock Lakes incident. Twelve miles northwest of Ardenvoir, WA. Timber, medium logging slash and closed timber litter. Extreme fire behavior with uphill runs, flanking and backing. Numerous structures and energy infrastructure threatened. Evacuations, road, area and trail closures in effect.

**Bannock Lakes,** Okanogan/Wenatchee NF. Fourteen miles southwest of Stehekin, WA. Timber and brush. No new information. Last report unless new information is received.

**Miles,** Umpqua NF. Unified Command between IMT 1 (Turman) and ODF IMT 1 (Smith). IMT is also managing the Snow Shoe, Columbus and Round Top incidents. Five miles northeast of Trail, OR. Timber. Active fire behavior with running, spotting and short crown runs. Numerous residences, energy and communication infrastructure threatened. Evacuations, road, area and trail closures in effect.

**Snow Shoe**, Umpqua NF. Six miles northwest of Trail, OR. Timber. Moderate fire behavior.

**Columbus,** Umpqua NF. Fifteen miles east of Tiller, OR. Timber. Active fire behavior with single-tree torching, short-range spotting and flanking. Road and trail closures in effect.

Round Top, Rogue River-Siskiyou NF. Eight miles northeast of Prospect, OR. Timber. Moderate fire behavior.

**Natchez,** Rogue River-Siskiyou NF. IMT 1 (Goicoechea). Fifteen miles southeast of Cave Junction, OR. Timber and chaparral. Active fire behavior with torching, short-range spotting and uphill runs. Structures threatened. Evacuations, road, area and trail closures in effect.

**Crescent Mountain**, Okanogan/Wenatchee NF. IMT 1 (Dueitt). Eighteen miles west of Winthrop, WA. Timber. Moderate fire behavior with torching, flanking and creeping. Numerous residences threatened. Road, area and trail closures in effect.

**Miriam**, Okanogan/Wenatchee NF. IMT 2 (Knerr). IMT 2 (Johnson) mobilizing. Fifteen miles east of Packwood, WA. Timber and brush. Moderate fire behavior with creeping and smoldering. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

**Taylor Creek**, Medford District, BLM. IMT 1 (Schulte). IMT is also managing the Klondike incident. Ten miles west of Grants Pass, OR. Timber and brush. Moderate fire behavior with uphill runs, group torching and short-range spotting. Numerous structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Klondike,** Rogue River-Siskiyou NF. IMT 1 (Kurth) mobilizing. Nine miles northwest of Selma, OR. Timber and chaparral. Active fire behavior with backing, group torching and spotting. Numerous residences threatened. Evacuations, road, area and trail closures in effect.

**Maple,** Olympic NF. IMT 2 (Lawson). Ten miles north of Hoodsport, WA. Timber. Moderate fire behavior with creeping, backing and flanking. Structures and communication infrastructure threatened. Road, area and trail closures in effect.

**Angel Springs**, Northeast Region, Washington DNR. IMT 2 (Goldman). Eight miles northeast of Davenport, WA. Timber, brush and tall grass. Minimal fire behavior. Numerous residences threatened.

**Hendrix,** Rogue River-Siskiyou NF. Nine miles southwest of Ashland, OR. Timber and medium logging slash. Minimal fire behavior. Residences threatened. Road, area and trail closures in effect.

**Long Hollow 0806 RN,** Prineville District, BLM. Started on private land five miles south of Dufur, OR. Brush and grass. Minimal fire behavior.

**0905 RN**, Prineville District, BLM. Started on private land seventeen miles south of Madras, OR. Brush and grass. Minimal fire behavior. Structures threatened.

**Silver Lake,** Northeast Region, Washington DNR. Five miles west of Cheney, WA. Timber, light logging slash and short grass. Minimal fire behavior.

- \* **Porcupine 2 0927 RN,** Prineville District, BLM. Started on BIA lands nine miles east of Clarno, OR. Timber brush and grass. Active fire behavior with crown runs and wind-driven runs. Residences threatened. Road closures in effect.
- \* **Boffer,** Washington State. Two miles south of Kennewick, WA. Brush and grass. Extreme fire behavior. Evacuations and road closures in effect.
- \* **Grass Valley,** Spokane District, BLM. Sixteen miles southwest of Grand Coulee, WA. Brush and grass. Extreme fire behavior with running and spotting. Numerous structures, energy infrastructure and sage-grouse habitat threatened. Evacuations and road closures in effect.
- \* **Little Rail,** Pendelton Unit, ODF. Thirteen miles east of Pilot Rock, OR. Brush and grass. Active fire behavior with flanking, backing and uphill runs.
- \* **Buffalo,** Lakeview District, BLM. Sixty-six miles northeast of Lakeview, OR. Brush and grass. Minimal fire behavior. Sage-grouse habitat threatened.

**Sheep Creek**, Northeast Region, Washington DNR. Four miles northwest of Northport, WA. Timber. No new information.

**Hawk,** Yakama Agency, BIA. Two miles southwest of White Swan, WA. Timber, brush and grass. No new information. Last report unless new information is received.

**Sharps,** Eastern Idaho Area, Idaho Department of Lands. Transfer of command from IMT 1 (Lund) back to local unit will occur today. Six miles east of Bellevue, ID. Timber, brush and tall grass. Moderate fire behavior with creeping, smoldering and single-tree torching. Sage-grouse habitat threatened. Road, area and trail closures in effect.

Predictive Services Discussion: Critical fire weather conditions will continue across the northern Great Plains from central Montana east across North Dakota, as a breezy, dry northwesterly flow develops behind a front. A trough of low pressure extending southwest from south central Canada into the Pacific Northwest will promote near normal temperatures across the northwestern corner of the country. Widely scattered thunderstorms will drift northward into the Great Basin from the Southwest. Developing storms on the northern fringes of the moisture plume will tend to produce little rainfall. In the East, a strong, broad area of low pressure will allow wet conditions to continue across the Mid-Atlantic States and the Deep South. Localized flooding is possible in some areas across the Deep South from the continuance of precipitation. Scattered showers and storms will bring some relief to Texas, as a stalled-out area of low pressure lingers over the Panhandle.

# SAFETY ZONES 1 (LCES)

Operational Engagement Category

A safety zone is a location where the threatened firefighter can find adequate refuge from an approaching fire.

- What is the difference between a safety zone and a deployment site?
  - The safety zone is the area where a firefighter can survive without using a fire shelter. The deployment site is used when fire conditions are such that escape routes and safety zones have been compromised.
- How do you identify a good safety zone?
  - Consider the distance from the escaped fire as well as topography, winds, fire behavior, and fuels in the area.
  - The best locations are usually "in the black;" those with a minimum of, or devoid of, ground/aerial vegetation; or large bodies of water.
  - Location is scouted and marked well for visibility at all times.
  - Location has been reassessed in relation to line work progress, fatigue, changes in fire behavior, and arrival of additional resources.
  - For radiant heat only, the distance separation between the firefighter and the flames must be at least four times the maximum flame height. This distance must be maintained on all sides, if the fire has ability to burn completely around the safety zone. Convective heat from wind and/or terrain influences will increase this distance requirement.
  - Take advantage of heat barriers such as lee side of ridges, large rocks, or solid structures.
- What should you avoid in selecting a safety zone?
  - Avoid locations that are downwind from the fire.
  - Avoid locations that are in chimneys, saddles, or narrow canyons.
  - Avoid locations that require a steep uphill escape route.
