One NIMO (Atlanta) and two Type 1 crews, staged in south Florida, have been tasked with assisting medical and urban search and rescue teams.

**McKinley**, Mat-Su Area, Alaska DOF. Transfer of command from IMT 2 (AK Green Team) to IMT 2 (NR Team 7) will occur today. Started on private land 18 miles north of Willow, AK. Timber and brush. Minimal fire behavior with backing, creeping and single tree torching. Numerous residences threatened. Precipitation occurred over the fire area yesterday.

**Deshka Landing**, Mat-Su Area, Alaska DOF. IMT 2 (NW Team 10). Seven miles southwest of Willow, AK. Timber, brush and short grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

\* Lower Klutuk, Southwest Area, Alaska DOF. Started on BLM land 19 miles southeast of Ekwok, AK. Timber and short grass. Extreme fire behavior with torching and running. Last narrative report unless significant activity occurs.

**Predictive Services Discussion:** Major hurricane Dorian will turn north today as it approaches the Floridian coast and begin a gradual weakening process over the next couple of days as it moves toward the Outer Banks of the Carolinas. The Four Corners High will drift northeast into Colorado bringing hot and dry conditions to areas along the Continental Divide. As it does so, and as a low pressure area begins to develop off the coast of Oregon and California, monsoonal moisture will be pulled northward into the Great Basin and the Sierra of California. Breezy and dry conditions will continue across the upper Midwest and the Great Lakes regions. In Alaska, wet conditions will continue across the southwestern and south central portions of the state as a large area of low pressure extends east from the Bering Sea and sends disturbances northeastward into the state from the northwestern Gulf of Alaska.

# **Aircraft and Pilot Carding**

Aviation Category

Every aircraft and pilot used in support of a Federal wildland fire mission must have a current Aircraft and Pilot Card or letter of authorization. The card must be held in the aircraft or with the pilot, and give specific authorization to do the mission being requested. **These missions could be all, one, or any number of missions as follows:** 

- Air attack (Level I, Level II, Level III).
- Reconnaissance.
- Fire surveillance.
- Water Delivery (buckets).
- Helitorch.
- Cargo.
- Longline.
- PSD Operations.

Every pilot who flies a properly carded aircraft must possess a current Interagency Airplane or Helicopter Pilot Qualification Card that gives specific authorization to fly the type of mission being requested and for the specific type of aircraft being used for the mission.

# These missions could be all, or any number of missions as follows:

- Air attack.
- Reconnaissance.
- Fire surveillance.
- Low-level.
- Paracargo.
- Mountain/Remote airstrips.
- Smokejumper.
- Longline.

Before the aircraft and pilot can be used for a specific mission, the aircraft must be specifically listed on a valid and current contract for the type of work being performed and a copy of the contract must be onboard the aircraft.

Each user of the aircraft and pilot has the authorization to physically inspect the Aircraft Data Card, the Interagency Airplane or Helicopter Pilot Qualification Card, and the contract. If any one of these three is not available for inspection, the mission must be canceled or at least postponed until the authorizations of the aircraft, pilot, or contract can be determined.

Pilots have very specific and closely monitored duty time and flight time limitations that users must understand and adhere to:

- 14-hour duty day
- 8 hours flight time per day
- 2 days off in 14 calendar days
- 36 hours cumulative flight hours in any 6 consecutive days
