One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

One MAFFS C-130 airtankers and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 152nd Airlift Wing (Nevada Air National Guard) have been deployed to McClellan Airfield, CA, in support of wildland fire operations.

Grizzly Creek, Garfield County. IMT 1 (GB Team 1). One mile east of Glenwood Springs, CO. Timber and brush. Extreme fire behavior with crowning, running and long-range spotting. Energy and transportation infrastructure and numerous structures threatened. Evacuations, area, road and trail closures in effect.

Williams Fork, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 2 (SW Team 3) and IMT 1 (GB Team 2) mobilizing. Fifteen miles southwest of Fraser, CO. Timber. Extreme fire behavior with crowning, running, and long-range spotting. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

Pine Gulch, Grand Junction Field Office, BLM. IMT 1 (RM Team 1). Eighteen miles north of Grand Junction, CO. Timber and brush. Extreme fire behavior with group torching and running. Structures, energy infrastructure and sage-grouse habitat threatened. Evacuations and road closures in effect.

Cameron Peak, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 2 (RM Blue Team). Fifteen miles southwest of Redfeather Lakes, CO. Timber and closed timber litter. Extreme fire behavior with short crown runs and long-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

High Bull, Pine Ridge Agency, BIA. Seven miles northeast of Pine Ridge, SD. Grass and timber. Minimal fire behavior.

Loyalton, Tahoe NF, USFS. IMT 2 (CA Team 10). Four miles northeast of Loyalton, CA. Timber and tall grass. Extreme fire behavior with wind-driven runs, running and long-range spotting. Numerous residences threatened. Evacuations in effect.

* **Doe**, Mendocino NF, USFS. Fifteen miles northwest of Elk Creek, CA. Timber and brush. Extreme fire behavior with torching, crowning, and spotting.

* **Deer**, Santa Clara Unit, Cal Fire. Five miles southwest of Brentwood, CA. Chaparral and tall grass. Active fire behavior with wind-driven runs.

* **Arroyo**, Santa Clara Unit, Cal Fire. Four miles south of Livermore, CA. Tall grass. Active fire behavior with running.

* **Canyon**, Santa Clara Unit, Cal Fire. Four miles northwest of Diablo Grande, CA. Tall grass and chaparral. Active fire behavior with running.

Lake, Angeles NF, USFS. IMT 1 (CA Team 5). Seventeen miles west of Lancaster, CA. Timber, brush and chaparral. Active fire behavior with group torching, crowning and spotting. Numerous structures, multiple communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Ranch2, Angeles NF, USFS. IMT 2 (CA Team 11). Two miles north of Azusa, CA. Brush and tall grass. Active fire behavior with running, uphill runs and group torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

* **Dome**, Mojave National Preserve, NPS. Seven miles northwest of Cima, CA. Brush and tall grass. Extreme fire behavior with running, flanking, and wind-driven runs. Structures, energy and railroad infrastructure threatened. Area, road and trail closures in effect.

* **River**, San Benito-Monterey Unit, Cal Fire. Five miles southeast of Salinas, CA. Brush, chaparral and short grass. Extreme fire behavior with uphill runs and running. Numerous residences threatened. Evacuations in effect.

* **Hills**, Fresno-Kings Unit, Cal Fire. Nine miles south of Coalinga, CA. Chaparral and tall grass. Moderate fire behavior with uphill runs, wind-driven runs and short-range spotting.

Predictive Services Discussion: The Four Corners High will reach peak intensity today as it stretches from northeastern Mexico through the West and to the North Pole. Widely scattered thunderstorms will develop across the West Coast states and western portions of the Northern Rockies. Storms will be a mix of wet and dry. Widely scattered storms will also be possible across central Colorado, New Mexico, and Arizona. The presence of two strong thermal troughs will allow for record heat in many areas. The first trough will extend from the San Joaquin Valley north into Oregon and Washington east of the Cascade Crest. The other thermal trough will be centered over the Great Basin. The heat will gradually build into western portions of the Great Plains as the ridge shifts east slightly. In the East, hot and humid conditions are expected across the South, but the northeastern states will remain cooler than average.

Nomex®

Firefighter Health & First Aid

Nomex® is the brand name for a **heat and flame-resistant** textile made by the DuPont chemical company and first marketed in 1967. Today, more than three million firefighters and aviation personnel around the world are protected by structure fire turnout gear, wildland fire PPE, and flight suits and jackets made of Nomex®.

Nomex® IS NOT flame-proof. It burns when you hold a flame to it, but stops burning once the heat source is removed. The thick woven structure of synthetic fibers is a very poor conductor of heat. When exposed to heat, the fibers expand closing the spaces between them insulating the wearer. But to work correctly, Nomex® needs care.

Dirty Nomex®

- Wash Nomex® like normal laundry, but always include a rinse cycle that adequately removes soaps and detergents.
- Nomex® garments should never be subjected to strong oxidizing agents such as peroxides or bleaches. These products harm the physical strength of the fabric.
- Tumble-dry and remove while slightly damp. Over-drying damages the fabric.

Poison Oak/Ivy/Sumac on Nomex® - MTDC researched the laundering of Nomex® firefighting clothing that has been contaminated with urushiol oil (what causes the rash) from poison oak/ivy/sumac exposure.

- MTDC recommends that fire clothing contaminated with urushiol oil be cleaned following normal Nomex® laundering procedures, with a degreaser such as a detergent or a laundry soap, and as soon as possible.
- Extra care should be exercised when handling the contaminated clothing and should be kept separate from unaffected clothing and equipment.
- Put the affected clothing in a marked bag if you are giving it to someone else to wash. Before handling the affected clothing, apply a skin-barrier product such as Ivy Block or Technu®.

Fuel Soaked Nomex® - Flammable contaminants will reduce the thermal performance of any flame-resistant garment including Nomex®.

- Proper and periodic cleaning is essential to maintain thermal protective performance.

Action Item – Nomex® is not effective if it is excessively dirty, fuel-soaked, or has holes. Does your Nomex® need to be washed, repaired, or replaced?
