NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

Two hundred thirty-three soldiers from the $14^{\text {th }}$ Brigade Engineer Battalion based out of Joint Base LewisMcChord, Washington are deployed in support of the August Complex.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtanker and support personnel each from the 153rd Airlift Wing (Wyoming Air National Guard) and the 146th Airlift Wing (California Air National Guard) have been deployed to support wildland fire operations in California.

Three wildland fire suppression crews and three overhead personnel from Quebec, Canada are supporting fire suppression efforts in the Northern California Area.

Area Command Team (Jalbert) has been mobilized to support wildland fire in Northern California.

* Slater, Klamath NF, USFS. IMT 2 (CA Team 10) mobilizing. Five miles northeast of Happy Camp, CA. Timber. Extreme fire behavior with crowning, long-range spotting and wind-driven runs. Community of Happy Camp threatened. Evacuations, area, road and trail closures in effect.
* Fork, Eldorado NF, USFS. Fifteen miles northeast of Pollock Pines, CA. Timber. Active fire behavior with group torching and wind-driven runs. Structures threatened. Area, road and trail closures in effect.

North Complex, Plumas NF, USFS. IMT 1 (CA Team 4). IMT is also managing the Sheep fire. One mile southwest of Crescent Mills, CA. Timber and brush. Extreme fire behavior with crowning, running and group torching. Numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

Butte/Tehama/Glenn Complex (7 fires), Butte Unit, Cal Fire. IMT 1 (Cal Fire Team 4). Two miles northwest of Oroville, CA. Timber, brush and tall grass. Active fire behavior with short crown runs and short-range spotting. Residences threatened. Evacuations, area, road and trail closures in effect.

August Complex (3 fires), Mendocino NF, USFS. IMT 1 (SA Blue Team). IMT 1 (GB Team 2) mobilizing. Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Active fire behavior with running, creeping and flanking. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Red Salmon Complex (2 fires), Six Rivers NF, USFS. NIMO (Quesinberry) and IMT 2 (CA Team 14). Fourteen miles northeast of Willow Creek, CA. Timber and closed timber litter. Active fire behavior with uphill runs, spotting and torching. Community of Hoopa threatened. Area, road and trail closures in effect.

Oak, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5) mobilizing. Six miles north of Willits, CA. Timber and short grass. Active fire behavior. Structures threatened. Road closures in effect.

Sheep, Plumas NF, USFS. Thirteen miles east of Westwood, CA. Timber, chaparral and short grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

Woodward, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Active fire behavior with flanking, backing and isolated torching. Numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

Hobo, Shasta-Trinity NF, USFS. Seven miles northwest of Junction City, CA. Timber, brush and short grass. Minimal fire behavior with smoldering.

CZU Aug Lightning Complex, San Mateo-Santa Cruz Unit, Cal Fire. Transition from IMT 1 (Cal Fire Team 3) back to the local unit will occur today. Eight miles east of Pescadero, CA. Timber, chaparral and closed timber litter. Moderate fire behavior with backing, creeping and smoldering. Numerous residences and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

SCU Lightning Complex, Santa Clara Unit, Cal Fire. IMT 1 (Cal Fire Team 6). Five miles southwest of Brentwood, CA. Timber, chaparral and tall grass. Minimal fire behavior with smoldering. Area and trail closures in effect.

LNU Lightning Complex (2 fires), Sonoma-Lake Napa Unit, Cal Fire. Transfer of command from IMT 1 (Cal Fire Team 2) back to the local unit will occur on 9/11. Two miles north of Barro, CA. Timber, chaparral and tall grass. Moderate fire behavior with torching, running and smoldering. Evacuations, area, road and trail closures in effect.

W-5 Cold Springs, Northern California District, BLM. Eleven miles east of Madeline, CA. Timber and brush. Minimal fire behavior with backing and creeping.

Creek, Sierra NF, USFS. Unified command between IMT 1 (Cal Fire Team 1) and IMT 1 (GB Team 1). Thirtyfive miles northeast of Clovis, CA. Timber and chaparral. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

El Dorado, San Bernardino Unit, Cal Fire. IMT 2 (CA Team 11). Three miles northeast of Yucaipa, CA. Timber, chaparral and tall grass. Moderate fire behavior with flanking, backing and single tree torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Valley, Cleveland NF, USFS. IMT 2 (CA Team 15). Nineteen miles northeast of Chula Vista, CA. Chaparral and tall grass. Moderate fire behavior flanking, creeping and smoldering. Several communities, communication and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Bobcat, Angeles NF, USFS. IMT 2 (EA Silver Team). IMT 1 (CA Team 1) mobilizing. Twelve miles northeast of Pasadena, CA. Chaparral and tall grass. Active fire behavior with short-range spotting, uphill and winddriven runs. Several communities, communications and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

SQF Complex (2 fires), Sequoia NF, USFS. IMT 1 (NR Team 1). Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with short crown runs, group torching and long-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Dolan, Los Padres NF, USFS. IMT 1 (PNW Team 2). Ten miles south of Big Sur, CA. Timber, brush and chaparral. Extreme fire behavior with short crown runs, uphill runs and spotting. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

* Two Four Two, Fremont-Winema NF, USFS. IMT 1 (ODF Team 2). Six miles northeast of Chiloquin, OR. Timber, brush and tall grass. Extreme fire behavior with long-range spotting, group torching and crowning. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

Evans Canyon, Southeast Region, Washington DNR. Transfer of command from IMT 2 (NW Team 12) back to the local unit will occur today. Started on county land eight miles northwest of Naches, WA. Timber, brush and tall grass. Minimal fire behavior with smoldering. Numerous residences threatened. Area and road closures in effect.

Cold Springs, Colville Agency, BIA. Four miles southeast of Omak, WA. Brush and grass. Extreme fire behavior with running, isolated torching and flanking. Numerous structures threatened. Evacuations, road, area and trail closures in effect.

Pearl Hill, Washington State Fire Marshal's Office. IMT 2 (NW Team 6). Four miles east of Okanogan, WA. Brush and short grass. Moderate fire behavior with flanking, short crown runs and backing. Numerous structures and communication infrastructure threatened. Evacuations, area and road closures in effect.

Predictive Services Discussion: A cold front will stall off the West Coast while pushing into northern Mexico and stretching northeast through the southern Plains into the Ohio Valley. Precipitation will over spread the Southern Rockies and southern and central Plains with snow over the higher elevations. Gusty offshore winds amid a dry airmass will continue across the West Coast with critical fire weather conditions expected. Dry and breezy post-frontal conditions will continue across portions of the Great Basin and into the Desert Southwest as well. Thunderstorms are likely along the Gulf Coast and through portions of the Southeast into the Mid-Atlantic, especially near the coast.

Attempting A Frontal Assault On A Fire<br>Operational Engagement Category

Attempting a frontal assault on a fire is recognized as Watchout Situation \#10 and is a potentially dangerous tactic.

If your tactics include a frontal assault, the following checklist must be adequately addressed before engaging the fire:

- Has the fire been scouted and sized up? Who will scout and size up a fire and what are they looking for?
- Is your position defensible? List what makes a firefighter's position defensible. (Anchor points, safety zones, escape routes, etc.)
- Are escape routes and safety zones adequate? Review what constitutes an adequate safety zone and escape route.
- Do you have an anchor point? How would you establish an anchor point for a frontal assault on a fire?
- Do you have adequate resources to complete the assault? Discuss things you need to consider; for example, if the frontal assault fails, do you have backup?
- Are you informed on strategy, tactics, and hazards? Consider what could happen if someone has a different approach than you; i.e., the IC has a burnout operation planned while you are attempting frontal assault.
- Is the terrain favorable to holding the fire? Discuss ways the terrain will influence where you will make a stand.
- Are you relying on aircraft for support operation? Any operation, especially frontal assault, should not need air resources to be safe.

In order to reduce the risks, reassess your tactics, post lookouts, identify situations in which firefighters may be enticed to attempt frontal assault on a fire. Review why this may or may not be a good idea.
