NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

NIMO (Reinarz) has been assigned to provide wildland fire support to California.

NIMO (Day) has been assigned to provide wildland fire support to federal land management agencies in Oregon and Washington.

Two hundred thirty-three soldiers from the 14th Brigade Engineer Battalion based out of Joint Base Lewis-McChord, Washington are deployed in support of the August Complex.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtankers and support personnel from the 146th Airlift Wing (California Air National Guard) and one MAFFS C-130 airtanker and support personnel from each the 153rd Airlift Wing (Wyoming Air National Guard) and the 152nd Airlift Wing (Nevada Air National Guard) have been deployed to support wildland fire operations in California.

One fire suppression crew and one overhead personnel from Canada are supporting fire suppression efforts in northern California.

Seven fire suppression crews, 18 fire engines and 55 overhead personnel from Canada are supporting fire suppression efforts in Oregon.

August Complex West Zone, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5). Four miles northeast of Covelo, CA. Timber, chaparral and tall grass. Active fire behavior with smoldering, creeping and backing. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

North Complex, Plumas NF, USFS. Unified command between IMT 1 (CA Team 4) and IMT 1 (Cal Fire Team 4). IMT 2 (RM Team Black) mobilizing. One mile southwest of Crescent Mills, CA. Timber and brush. Active fire behavior with running, spotting and isolated torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

August Complex (2 fires), Mendocino NF, USFS. Area Command (Jalbert), IMT 1 (GB Team 2) and IMT 1 (AK Team 1). Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Moderate fire behavior with running, flanking and torching. Several communities threatened. Evacuations, area, road and trail closures in effect.

Slater, Klamath NF, USFS. IMT 1 (NR Team 2) and IMT 2 (CA Team 10). IMT is also managing the Devil fire. Five miles northeast of Happy Camp, CA. Timber and brush. Moderate fire behavior with backing, short-range spotting and isolating torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Devil, Klamath NF, USFS. Five miles north of Seiad, CA. Timber. Moderate fire behavior with backing, creeping and isolated torching. Numerous residences threatened. Area, road and trail closures in effect.

Fork, Eldorado NF, USFS. IMT 2 (SW Team 4) Fifteen miles northeast of Pollock Pines, CA. Timber and brush. Minimal fire behavior with creeping, flanking and backing. Numerous structures threatened. Area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Red Salmon Complex (2 fires), Six Rivers NF, USFS. IMT 2 (CA Team 14). Fourteen miles northeast of Willow Creek, CA. Timber and closed timber litter. Active fire behavior with torching, backing and short-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

Fox, Klamath NF, USFS. Three miles east of Callahan, CA. Timber and brush. Moderate fire behavior with flanking and backing. Structures threatened. Area, road and trail closures in effect.

Woodward, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

CZU Aug Lightning Complex, San Mateo-Santa Cruz Unit, Cal Fire. Eight miles east of Pescadero, CA. Timber, chaparral and closed timber litter. Minimal fire behavior with smoldering. Numerous residences and energy infrastructure threatened. Area, road and trail closures in effect.

Area Command Team (Stutler) has been mobilized to support wildland fire in northwest Oregon.

Riverside, Mt. Hood NF, USFS. IMT 1 (SW Team 1). One mile southeast of Estacada, OR. Timber, brush and short grass. Minimal fire behavior with smoldering and creeping. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Lionshead, Warm Springs Agency, BIA. IMT 1 (RM Team 1). Twenty miles west of Warm Springs, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Beachie Creek, Willamette NF, USFS. IMT 1 (SW Team 2). Six miles north of Detroit, OR. Timber. Minimal fire behavior with smoldering, creeping and backing. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Archie Creek, Umpqua NF, USFS. IMT 1 (SA Red Team). Twenty miles east of Glide, OR. Timber and brush. Moderate fire behavior with flanking, backing and smoldering. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

S. Obenchain, Medford Unit, Oregon DOF. IMT 2 (NW Team 8). Five miles east of Eagle Point, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Evacuations, area and road closures in effect. Reduction in acreage due to more accurate mapping.

Brattain, Fremont-Winema NF, USFS. IMT 2 (EA Silver Team). Eight miles south of Paisley, OR. Timber and brush. Active fire behavior with running, backing and isolated torching. Numerous structures and sage-grouse habitat threatened. Area, road and trail closures in effect.

Thielsen, Umpqua NF, USFS. IMT 2 (SA Gold Team). Sixteen miles west of Chemult, OR. Timber and brush. Minimal fire behavior with creeping, smoldering and single tree torching. Numerous structures and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

Inchelium Complex (3 fires), Colville Agency, BIA. IMT 2 (NW Team 7). One mile north of Inchelium, WA. Timber and brush. Moderate fire behavior with backing and creeping. Numerous structures threatened.

Big Hollow, Gifford Pinchot NF, USFS. IMT 2 (NW Team 12). Twenty miles north of Stevenson, WA. Timber. Minimal fire behavior with creeping, smoldering and backing. Structures threatened. Evacuations, area, road and trail closures in effect.

Two Four Two, Fremont-Winema NF, USFS. IMT 1 (ODF Team 2). Six miles northeast of Chiloquin, OR. Timber, brush and tall grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

North Cascade Complex (3 fires), Molalla Unit, Oregon DOF. One mile south of Molalla, OR. Timber and tall grass. Minimal fire behavior with smoldering. Numerous structures threatened. Evacuations and road closures in effect.

Echo Mtn. Complex (2 fires), Toledo Unit, Oregon DOF. Four miles east of Lincoln City, OR. Timber, brush and tall grass. Minimal fire behavior. Community of Otis threatened. Evacuations and road closures in effect. Precipitation occurred over the fire area yesterday.

Cold Creek, Okanogan-Wenatchee NF, USFS. Thirty-eight miles west of Yakima, WA. Timber and hardwood litter. Moderate fire behavior with creeping, backing and smoldering. Numerous structures threatened. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday. Reduction in acreage due to more accurate mapping.

Area Command Team (Sexton) has been mobilized to support wildland fire in southern California.

Creek, Sierra NF, USFS. Unified command between IMT 1 (Cal Fire Team 1) and IMT 1 (GB Team 1). Thirty-five miles northeast of Clovis, CA. Timber, chaparral and tall grass. Active fire behavior with wind-driven runs flanking and backing. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

SQF Complex (2 fires), Sequoia NF, USFS. IMT 1 (NR Team 1) and IMT 1 (Cal Fire Team 6). IMT 1 (CA Team 2) mobilizing. Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with flanking, group torching and short-range spotting. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Bobcat, Angeles NF, USFS. IMT 1 (CA Team 1). Twelve miles northeast of Pasadena, CA. Chaparral, brush and tall grass. Active fire behavior with flanking, backing and wind-driven runs. Several communities, communications and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

El Dorado, San Bernardino Unit, Cal Fire. IMT 2 (CA Team 13). Three miles northeast of Yucaipa, CA. Timber, chaparral and tall grass. Active fire behavior with backing, spotting and isolated torching. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Snow, Riverside Unit, Cal Fire. Eight miles northwest of Palm Springs, CA Timber, brush and tall grass. Minimal fire behavior with smoldering and creeping. Several communities and energy infrastructure threatened.

Dolan, Los Padres NF, USFS. IMT 1 (PNW Team 2). NIMO (Quesinberry) and IMT 2 (CA Team 15) mobilizing. Ten miles south of Big Sur, CA. Timber, brush and chaparral. Active fire behavior with short crown runs, uphill runs and flanking. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Bullfrog, Sierra NF, USFS. Forty-three miles northeast of Clovis, CA. Timber, brush and short grass. Moderate fire behavior with torching, creeping and backing. Area, road and trail closures in effect.

Moraine, Sequoia & Kings Canyon NP, NPS. Five miles northeast of Kanawyers, CA. Timber and brush. Minimal fire behavior with creeping and smoldering.

Predictive Services Discussion: An upper-level shortwave trough will move into the Pacific Northwest today bringing higher RH into the region. Gusty winds and low RH are expected along the Sierra Front and portions of the Great Basin. Isolated thunderstorms are possible in the broader Four Corners region. Tropical Storm Beta will continue to produce heavy rainfall and storm surge flooding to portions of the Texas and Louisiana coasts and farther inland across east/central Texas into the Lower Mississippi Valley. A cold front will continue moving east into the western Great Lakes with dry conditions remaining across much of New England.

Downhill Fireline Construction Checklist

Operational Engagement Category

Downhill fireline construction is hazardous in steep terrain, fast-burning fuels, or rapidly changing weather. Downhill fireline construction should not be attempted unless there is no tactical alternative. When building downhill fireline, the following is required:

- Crew supervisor(s) and fireline overhead discuss assignments prior to committing crew(s). Responsible overhead individual (TFLD or ICT4 qualified or better) will stay with resources until the job is completed.
- Decision will be made after proposed fireline has been scouted by supervisor(s) of involved crew(s).
- LCES will be coordinated for all personnel involved.
 - Crew supervisor(s) is in direct contact with lookout who can see the fire.
 - Communication is established between all crews.
 - Rapid access to safety zone(s) is ensured in case fire crosses below crew(s).
- Direct attack will be used whenever possible; if not possible, the fireline should be completed between anchor points before being fired out.
- Fireline will not lie in or adjacent to a chute or chimney.
- Starting point will be anchored for crew(s) building fireline down from the top.
- Bottom of the fire will be monitored; if the potential exists for the fire to spread, action will be taken to secure the fire edge.
- Can fire be carried with you?
