NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

NIMO (Reinarz) has been assigned to provide wildland fire support to California.

NIMO (Day) has been assigned to provide wildland fire support to federal land management agencies in Oregon and Washington.

Two hundred thirty-three soldiers from the 14th Brigade Engineer Battalion based out of Joint Base Lewis-McChord, Washington are deployed in support of the August Complex.

Two hundred thirty-four Marines from the 7th Engineer Support Battalion, 1st Marine Logistics Group, 1 Marine Expeditionary Force based out of Camp Pendleton, California are deployed in support of the Creek fire.

One RC-26 aircraft with Distributed Real-Time Infrared (DRTI) capability and support personnel from the 141st Air Refueling Wing (Washington Air National Guard) has been deployed to Fairchild AFB (Spokane, WA), in support of wildland fire operations.

Two MAFFS C-130 airtankers and support personnel from the 146th Airlift Wing (California Air National Guard) and one MAFFS C-130 airtanker and support personnel from each the 153rd Airlift Wing (Wyoming Air National Guard) and the 152nd Airlift Wing (Nevada Air National Guard) have been deployed to support wildland fire operations in California.

One fire suppression crew and one overhead personnel from Canada are supporting fire suppression efforts in northern California.

Seven fire suppression crews, 18 fire engines and 54 overhead personnel from Canada are supporting fire suppression efforts in Oregon.

Five fire suppression crews and four overhead personnel from Mexico are supporting fire suppression efforts in southern California.

North Complex, Plumas NF, USFS. Unified command between IMT 1 (Cal Fire Team 4) and IMT 2 (RM Team Black). One mile southwest of Crescent Mills, CA. Timber and brush. Active fire behavior with group torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

August Complex (2 fires), Mendocino NF, USFS. Area Command Team (Jalbert), NIMO (Quesinberry) and IMT 1 (AK Team 1). Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Moderate fire behavior with uphill runs, flanking and group torching. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

Slater, Klamath NF, USFS. IMT 1 (NR Team 2). IMT is also managing the Devil fire. Five miles northeast of Happy Camp, CA. Timber and brush. Moderate fire behavior with backing, isolated torching and flanking. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Devil, Klamath NF, USFS. Five miles north of Seiad, CA. Timber. Moderate fire behavior with backing, flanking and isolated torching. Area and trail closures in effect. Precipitation occurred over the fire area yesterday.

Red Salmon Complex (2 fires), Six Rivers NF, USFS. Transfer of command from IMT 2 (CA Team 14) to IMT 2 (NW Team 10) will occur tomorrow. Fourteen miles northeast of Willow Creek, CA. Timber and closed timber litter. Active fire behavior with backing, flanking and creeping. Structures threatened. Evacuations, area, road and trail closures in effect.

Fox, Klamath NF, USFS. Three miles east of Callahan, CA. Timber and brush. Minimal fire behavior with creeping and smoldering. Community of Callahan and communication infrastructure threatened. Area, road and trail closures in effect.

August Complex West Zone, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5). Four miles northeast of Covelo, CA. Timber, chaparral and tall grass. Minimal fire behavior with creeping, backing and smoldering. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

Fork, Eldorado NF, USFS. Fifteen miles northeast of Pollock Pines, CA. Timber and brush. Minimal fire behavior with creeping, smoldering and backing. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect.

Woodward, Point Reyes National Seashore, NPS. Three miles southwest of Olema, CA. Timber, brush and chaparral. Moderate fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

Area Command Team (Sexton) has been mobilized to support wildland fire in southern California.

SQF Complex (2 fires), Sequoia NF, USFS. IMT 1 (CA Team 2) and IMT 1 (Cal Fire Team 6). Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with short-range spotting, creeping and group torching. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

Bobcat, Angeles NF, USFS. IMT 1 (CA Team 1). Twelve miles northeast of Pasadena, CA. Chaparral, brush and tall grass. Moderate fire behavior with backing, creeping and uphill runs. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

Creek, Sierra NF, USFS. Unified command between IMT 1 (Cal Fire Team 1), IMT 1 (GB Team 1) and IMT 1 (CA Team 5). IMT 2 (NR Team 4) mobilizing. Thirty-five miles northeast of Clovis, CA. Timber, chaparral and tall grass. Active fire behavior with torching, flanking and short-range spotting. Several communities and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Dolan, Los Padres NF, USFS. IMT 2 (CA Team 15). Ten miles south of Big Sur, CA. Brush, chaparral and short grass. Moderate fire behavior with backing, flanking and creeping. Numerous residences and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

El Dorado, San Bernardino Unit, Cal Fire. IMT 2 (CA Team 13). Three miles northeast of Yucaipa, CA. Timber, chaparral and brush. Minimal fire behavior with creeping, smoldering and isolated torching. Structures threatened. Evacuations have been lifted. Area, road and trail closures in effect.

Snow, Riverside Unit, Cal Fire. Eight miles northwest of Palm Springs, CA. Timber, brush and tall grass. Minimal fire behavior with smoldering. Trail closures in effect.

Moraine, Sequoia & Kings Canyon NP, NPS. Five miles northeast of Kanawyers, CA. Timber and brush. Minimal fire behavior with creeping and smoldering.

Bluejay, Yosemite NP, NPS. Previously reported incident. Five miles northwest of Yosemite Valley, CA. Timber. Moderate fire behavior with smoldering, flanking and creeping. Last narrative report unless significant activity occurs.

Rattlesnake, Sequoia & Kings Canyon NP, NPS. Previously reported incident. Twenty-five miles southwest of Lone Pine, CA. Timber and brush. Active fire behavior with group torching, short-range spotting and uphill runs. Area and trail closures in effect. Last narrative report unless significant activity occurs.

Beachie Creek, Willamette NF, USFS. IMT 1 (SW Team 2). Six miles north of Detroit, OR. Timber and brush. Minimal fire behavior with smoldering. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Riverside, Mt. Hood NF, USFS. Transfer of command from IMT 1 (SW Team 1) to IMT 1 (PNW Team 3) occurred yesterday. One mile southeast of Estacada, OR. Timber, brush and short grass. Minimal fire behavior with smoldering. Several communities threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Lionshead, Warm Springs Agency, BIA. IMT 1 (RM Team 1). IMT 2 (NW Team 13) mobilizing. Twenty miles west of Warm Springs, OR. Timber and brush. Minimal fire behavior with backing, creeping and smoldering. Several communities threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Archie Creek, Umpqua NF, USFS. IMT 1 (SA Red Team). Twenty miles east of Glide, OR. Timber. Minimal fire behavior with smoldering. Numerous residences threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

OR-WIF-200430, Willamette NF, USFS. IMT 1 (ODF Team 3). Thirty-five miles east of Eugene, OR. Timber and brush. Minimal fire behavior with smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

S. Obenchain, Medford Unit, Oregon DOF. Transfer of command from IMT 2 (NW Team 8) back to the local unit will occur tomorrow. Five miles east of Eagle Point, OR. Timber and brush. Minimal fire behavior with smoldering and creeping. Numerous structures threatened. Evacuations, area and road closures in effect. Precipitation occurred over the fire area yesterday.

Thielsen, Umpqua NF, USFS. IMT 2 (SA Gold Team). Sixteen miles west of Chemult, OR. Timber and brush. Minimal fire behavior with creeping and smoldering. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Brattain, Fremont-Winema NF, USFS. Transfer of command from IMT 2 (EA Silver Team) back to the local unit will occur today. Eight miles south of Paisley, OR. Timber and brush. Active fire behavior with backing, creeping and smoldering. Sage-grouse habitat threatened. Evacuations, area, road and trail closures in effect.

North Cascade Complex (3 fires), Molalla Unit, Oregon DOF. One mile south of Molalla, OR. Timber and tall grass. Minimal fire behavior. Evacuations in effect. Precipitation occurred over the fire area yesterday.

Two Four Two, Fremont-Winema NF, USFS. Six miles northeast of Chiloquin, OR. Timber, brush and tall grass. Minimal fire behavior with smoldering. Area, road and trail closures in effect.

Predictive Services Discussion: Critical fire weather will continue across southern Wyoming, northern Colorado, and much of Utah as a cold front stalls across the region. Very breezy winds will combine with low humidities to yield favorable conditions for rapid fire spread on new/existing fires. Rain and generally cooler temperatures will be present across much of the Northwest, Idaho Panhandle, and western Montana/Wyoming. Hot and dry conditions persist for much of the Desert Southwest, Texas/Oklahoma Panhandles, and plains of Colorado and Kansas. Heavy precipitation will impact much of the southeastern coastal states due to post-tropical cyclone Beta.

Instructions And Assignments Not Clear

Fire Communications Category

Every firefighter will be giving and receive briefings at some point on the job. Briefings are an effective way to disseminate information that can make the firefighter's job safer and easier. When giving a briefing, it is important to keep the following questions in mind and remain perceptive to how the audience is receiving the information:

- Did you use the Incident Response Pocket Guide standards briefing checklist?
- Did they ask questions? Talk about what it is like giving a briefing. Do you get empty stares? What feedback are you looking for to ensure they understand you?
- Did they take notes? What kind of information would you like to see people write down?
- Did they repeat information back? What other ways can you identify that your briefing is registering?
- Did you give all the necessary information? How will you ensure that you covered everything necessary?
 - Task
 - Location
 - Communications
 - Hazards
 - Who, when, etc.
- It is also important for the firefighter who is receiving instructions to be mindful of the following during the briefing:
 - Did you really listen? What do you do to make yourself pay attention to everything being said?
 - Did you understand the assignment, location, and the nature and location of hazards? Do you expect to figure it out for yourself when you get out there or do you step forward and ask questions?
- You must know the location of the assignment and:
 - What is to be done?
 - Who you are to report to and how often to report.
 - When you are expected to complete the assignment.
 - Hazards.
 - Communication plan frequencies.
 - Weather and fire behavior.
 - Status of adjoining forces.
