NIMO (Houseman) has been assigned to COVID-19 support at Forest Service headquarters in Washington, D.C.

NIMO (Reinarz) has been assigned to provide wildland fire support to California.

Two hundred thirty-four Marines from the 7<sup>th</sup> Engineer Support Battalion, 1<sup>st</sup> Marine Logistics Group, 1 Marine Expeditionary Force based out of Camp Pendleton, California are deployed in support of the August Complex.

Eleven fire suppression crews and four overhead personnel from Canada are supporting fire suppression efforts in northern California.

Five fire suppression crews, 15 fire engines and 12 overhead personnel from Canada are supporting fire suppression efforts in Oregon.

Five fire suppression crews and four overhead personnel from Mexico are supporting fire suppression efforts in southern California.

**August Complex West Zone**, Mendocino Unit, Cal Fire. IMT 1 (Cal Fire Team 5). Four miles northeast of Covelo, CA. Timber, chaparral and tall grass. Moderate fire behavior with torching, flanking and backing. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**August Complex** (2 fires), Mendocino NF, USFS. Area Command Team (Sexton), IMT 1 (PNW Team 2), IMT 1 (SW Team 1) and IMT 1 (GB Team 2). Area Command Team (Stutler) mobilizing. Fourteen miles northwest of Elk Creek, CA. Timber, chaparral and tall grass. Active fire behavior with single tree torching, uphill runs and backing. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Slater**, Klamath NF, USFS. IMT 2 (NW Team 7). IMT is also managing the Devil fire. Five miles northeast of Happy Camp, CA. Timber and brush. Moderate fire behavior with flanking, backing and isolated torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Devil**, Klamath NF, USFS. Five miles north of Seiad, CA. Timber. Moderate fire behavior with backing, flanking and isolated torching. Area and trail closures in effect.

**North Complex**, Plumas NF, USFS. IMT 1 (CA Team 4). One mile southwest of Crescent Mills, CA. Timber and brush. Minimal fire behavior with creeping, backing and isolated torching. Several communities and infrastructure threatened. Evacuations have been lifted. Area, road and trail closures in effect.

**Red Salmon Complex** (2 fires), Six Rivers NF, USFS. IMT 2 (NW Team 10). Fourteen miles northeast of Willow Creek, CA. Timber. Active fire behavior with uphill runs, flanking and backing. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Glass**, Sonoma-Lake Napa Unit, Cal Fire. IMT 1 (Cal Fire Team 3). Thirteen miles northwest of Napa, CA. Tall grass, brush and timber. Minimal fire behavior with creeping and smoldering. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Zogg**, Shasta-Trinity Unit, Cal Fire. Nine miles southwest of Redding, CA. Chaparral, brush and short grass. Minimal fire behavior with smoldering. Evacuations have been lifted. Road closures in effect.

**Fork**, Eldorado NF, USFS. Fifteen miles northeast of Pollock Pines, CA. Timber and brush. Numerous structures and energy infrastructure threatened. Area, road and trail closures in effect. No new information.

Active fire behavior with uphill runs, group torching and creeping. Several communities and infrastructure threatened. Evacuations, area, road and trail closures in effect.

**SQF Complex**, Sequoia NF, USFS. IMT 2 (CA Team 13). Thirty-three miles east of Porterville, CA. Timber and chaparral. Active fire behavior with flanking, backing and spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

**Bobcat**, Angeles NF, USFS. Twelve miles northeast of Pasadena, CA. Chaparral, brush and tall grass. Minimal fire behavior with creeping and smoldering. Numerous structures and infrastructure threatened. Area, road and trail closures in effect.

**Dolan**, Los Padres NF, USFS. Ten miles south of Big Sur, CA. Brush, chaparral and short grass. Minimal fire behavior with smoldering and creeping. Area, road and trail closures in effect.

**El Dorado**, San Bernardino Unit, Cal Fire. Three miles northeast of Yucaipa, CA. Timber, chaparral and brush. Minimal fire behavior with creeping, backing and smoldering. Numerous structures threatened. Area and trail closures in effect.

**Moraine**, Sequoia & Kings Canyon NP, NPS. Five miles northeast of Kanawyers, CA. Timber and brush. Minimal fire behavior with backing, creeping and smoldering.

**Cameron Peak**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 2 (NW Team 6). Fifteen miles southwest of Redfeather Lakes, CO. Timber. Extreme fire behavior with crowning, wind-driven runs and long-range spotting. Several communities threatened. Evacuations, area, road and trail closures in effect.

**Mullen**, Medicine Bow-Routt NF and Thunder Basin National Grassland, USFS. IMT 1 (SA Blue Team). Thirty-eight miles west of Laramie, WY. Timber. Active fire behavior with short crown runs and torching. Several communities and communication infrastructure threatened. Evacuations, area, road and trail closures in effect.

**Williams Fork**, Arapaho and Roosevelt NF and Pawnee National Grassland, USFS. IMT 2 (NR Team 6). Fifteen miles southwest of Fraser, CO. Timber. Moderate fire behavior with group torching, short-range spotting and flanking. Several communities and energy infrastructure threatened. Area, road and trail closures in effect.

**Middle Fork**, Medicine Bow-Routt NF and Thunder Basin National Grassland, USFS. Ten miles north of Steamboat Springs, CO. Timber. Extreme fire behavior with crowning, short-range spotting and running. Structures threatened. Area, road and trail closures in effect.

Minimal fire behavior with flanking, creeping and smoldering. Numerous structures and infrastructure threatened. Evacuations, area, road and trail closures in effect. Reduction in acreage due to more accurate mapping.

**Riverside**, Mt. Hood NF, USFS. One mile southeast of Estacada, OR. Timber. Minimal fire behavior with flanking, creeping and smoldering. Energy infrastructure threatened. Area, road and trail closures in effect.

**Predictive Services Discussion:** A cold front associated with the upper low will move through the Pacific Northwest. Precipitation will become more widespread, with rain and snow across the Pacific Northwest, northwest California, Idaho, and western Montana and Wyoming. Snow levels will range from 5,000 to 6,500 feet. Critically dry winds and relative humidity are expected ahead of the cold front across portions of the Great Basin, Rocky Mountain Area, and the Northern Rockies. Strong winds with higher humidity are expected east of the Cascades, Idaho, Montana, and across the upper Great Plains. Low temperatures Saturday night into Sunday will be in the 20 to 30-degree range across the higher terrain of the Intermountain West.



# Hazard Tree – No Work Zones (NWZ)

Felling Safety Category

Knowing when the exact time a given hazard tree (or compromised section) will fail is extremely difficult, and is, in many cases, an unpredictable task. Given this fact, we need to manage firefighters' exposure to these hazards by creating a safe work area or No Work Zone (NWZ). The size and extent of the NWZ must be determined by onsite conditions, such as terrain, stand structure, and fire impacts on the tree and adjoining trees.






When an identified hazardous tree or trees cannot be felled, then perform an assessment of which areas have too high a risk, and post a lookout to warn the personnel to stay clear of these areas while working in adjacent areas. If hazard still exists before leaving the area, flag the NWZ so that personnel entering the area will be able to recognize the hazard. Use the following failure zone illustrations as examples to help manage firefighter exposure to these identified hazards. Also, remember to include the possibility of the "Domino Effect" to surrounding trees.
