Cedar Creek, Willamette NF, USFS. IMT 1 (AK Team 1). Transfer of command from IMT 2 (NW Team 6) to IMT1 (PNW Team 3) will occur today. Fifteen miles east of Oakridge, OR. Timber and closed timber litter. Moderate fire behavior with running, flanking and isolated torching. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Double Creek, Wallowa-Whitman NF, USFS. IMT 1 (PNW Team 2). IMT 1 (SA Blue Team) mobilizing. IMT is also managing the Sturgill, Nebo, and Goat Mountain Two fires. Ten miles southeast of Imnaha, OR. Timber and short grass. Active fire behavior with torching, flanking and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Sturgill, Wallowa-Whitman NF, USFS. Fifteen miles southwest of Enterprise, OR. Timber and closed timber litter. Active fire behavior with isolated torching, flanking and backing. Residences threatened. Evacuations, area, road and trail closures in effect.

Nebo, Wallowa-Whitman NF, USFS. Twenty-one miles southeast of Enterprise, OR. Timber. Active fire behavior with group torching, flanking and backing. Area, road and trail closures in effect.

Goat Mountain Two, Wallowa-Whitman NF, USFS. Nine miles south of Lostine, OR. Timber. Moderate fire behavior with backing.

Bolt Creek, Northwest Region, DNR. IMT 2 (NW Team 8). Two miles north of Skykomish, WA. Timber and brush. Moderate fire behavior with backing and uphill runs. Numerous structures threatened. Evacuations, area, road and trail closures in effect.

Boulder Mountain, Northeast Region, DNR. IMT 2 (GB Team 7). Nine miles northwest of Cusick, WA. Timber and medium slash. Active fire behavior with spotting and torching. Structures threatened. Area, road and trail closures in effect.

Rum Creek, Medford District, BLM. IMT 2 (NR Team 6). Twelve miles northwest of Hugo, OR. Timber and closed timber litter. Minimal fire behavior with creeping, smoldering and backing. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Van Meter, Lakeview District, BLM. Transfer of command from IMT 1 (ODF Team 3) back to the local unit will occur on 9/15. Thirteen miles southeast of Klamath Falls, OR. Timber, brush and short grass. Minimal fire behavior with creeping and smoldering.

Chilliwack Complex (4 fires), North Cascades NP, NPS. NIMO (Team 2). IMT is also managing the NW Pasayten Complex. Thirty miles east of Maple Falls, WA. Timber. Minimal fire behavior. Structures threatened. Trail closures in effect. Precipitation occurred over the fire area yesterday.

NW Pasayten Complex (5 fires), Okanogan-Wenatchee NF, USFS. Twenty miles northeast of Diablo, WA. Timber. Minimal fire behavior. Structures threatened. Trail closures in effect. Precipitation occurred over the fire area yesterday.

Crocketts Knob, Malheur NF, USFS. Nineteen miles north of Prairie City, OR. Brush, closed timber litter and timber. Minimal fire behavior with backing, creeping and smoldering. Structures threatened. Area, road and trail closures in effect.

White River, Okanogan-Wenatchee NF, USFS. Twenty-three miles northwest of Leavenworth, WA. Timber. Minimal fire behavior with backing and creeping. Numerous structures threatened. Area, road and trail closures in effect.

Irving Peak, Okanogan-Wenatchee NF, USFS. Twenty-six miles northwest of Leavenworth, WA. Timber. Moderate fire behavior with backing and creeping. Structures threatened. Area, road and trail closures in effect.

Minnow Ridge, Okanogan-Wenatchee NF, USFS. Twenty-five miles north of Leavenworth, WA. Timber. Moderate fire behavior with backing and creeping. Road, area and trail closures in effect. Reduction in acreage due to more accurate mapping.

Potter, Willamette NF, USFS. Forty-six miles southwest of La Pine, OR. Closed timber litter, timber and medium slash. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect.

Goat Rocks, Gifford Pinchot NF, USFS. IMT 2 (NW Team 10). Eight miles east of Packwood, WA. Timber. No new information.

Moose, Salmon-Challis NF, USFS. IMT 1 (GB Team 1). Seventeen miles north of Salmon, ID. Short grass, brush and timber. Moderate fire behavior with flanking, backing and single tree torching. Numerous residences threatened. Evacuations, area, road and trail closures in effect.

Ross Fork, Sawtooth NF, USFS. IMT 2 (GB Team 3). Six miles east of Atlanta, ID. Short grass, timber and brush. Active fire behavior with uphill runs, isolated torching and short-range spotting. Structures threatened. Evacuations, area, road and trail closures in effect.

Tenmile, Payette NF, USFS. IMT 2 (GB Team 4). Nine miles west of Warren, ID. Timber, brush and medium slash. Active fire behavior with backing, creeping and torching. Area, road and trail closures are in effect.

Four Corners, Payette NF, USFS. Transfer of command from IMT 1 (GB Team 2) back to the local unit will occur tomorrow. Six miles west of Cascade, ID. Timber and closed timber litter. Minimal fire behavior with creeping and smoldering. Several communities, numerous structures and communication infrastructure threatened. Area, road and trail closures in effect.

Owl, Salmon-Challis NF, USFS. Twenty-six miles northwest of Salmon, ID. Tall grass and timber. Moderate fire behavior with creeping, backing and smoldering. Residences threatened.

* **Ellsworth**, Humboldt-Toiyabe NF, USFS. Ten miles northeast of Gabbs, NV. Brush and short grass. Moderate fire behavior with wind driven runs, isolated torching and smoldering. Structures threatened.

Several communities, numerous structures and energy infrastructure threatened. Evacuations, area, road and trail closures in effect.

Barnes, Modoc NF, USFS. IMT 1 (CA Team 1). Two miles east of Willow Ranch, CA. Timber, brush and short grass. Minimal fire behavior with creeping and smoldering. Community of Fort Bidwell threatened. Numerous structures threatened. Evacuations have been lifted. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

Kootenai River Complex (2 fires), Idaho Panhandle NF, USFS. IMT 2 (NR Team 4). Seven miles northwest of Bonners Ferry, ID. Timber and brush. Moderate fire behavior with flanking, backing and single tree torching. Residences threatened. Road and trail closures in effect.

Williams Creek, Nez Perce-Clearwater NF, USFS. IMT 2 (NR Team 5). IMT is also managing the Twin Lakes fire. Fourteen miles southwest of Elk City, ID. Closed timber litter, timber and heavy slash. Active fire behavior with uphill runs, flanking and creeping. Community of Orogrande and structures threatened. Evacuations, area, road and trail closures in effect.

Twin Lakes, Nez Perce-Clearwater NF, USFS. Twenty-five miles southeast of White Bird, ID. Timber, closed timber litter and heavy slash. Active fire behavior with uphill runs, flanking and creeping. Structures threatened. Area, road and trail closures in effect.

Lemonade, Flathead NF, USFS. Transfer of command from IMT 2 (NR Team 3) back to the local unit will occur tomorrow. Twenty-one miles west of Kalispell, MT. Closed timber litter, timber and light slash. Moderate fire behavior with creeping, single tree and isolated torching.

Bull Gin Complex (3 fires), Kootenai NF, USFS. IMT 2 (NR Team 7). Two miles northeast of Heron, MT. Timber and brush. Active fire behavior with flanking, backing and group torching. Area, road and trail closures in effect.

Eagle Creek, Hill County. Thirty miles south of Havre, MT. Timber, brush and short grass. Active fire behavior with uphill runs, single tree torching and flanking. Residences threatened. Road closures in effect.

Blodgett Lake, Bitterroot NF, USFS. IMT 1 (NR Team 1) mobilizing. Eleven miles west of Hamilton, MT. Timber, closed timber litter and brush. Extreme fire behavior with crowning, uphill runs and spotting. Road and trail closures in effect.

* **No Grass Creek**, Helena-Lewis and Clark NF, USFS. Twelve miles east of Deer Lodge, MT. Timber. Active fire behavior with crowning, group torching and spotting. Area and trail closures in effect. Last narrative report unless significant activity occurs.

Predictive Services Discussion: An upper low will move into the Pacific Northwest, with enhanced westerly flow across the southern Cascades and northern Sierra. Elevated conditions are likely across northeast California into south-central Oregon due to westerly winds of 12-20 mph with gusts 20-30 mph amid relative humidity of 12-20%. Brisk east-southeasterly winds will develop across eastern Montana and North Dakota as well, but relative humidity will remain near or above 25%. Temperatures will cool closer to normal across the northern Intermountain West due to the incoming trough, but above normal temperatures are likely to continue across the Plains from South Dakota southward to Texas.

Isolated to scattered mainly wet thunderstorms will develop over the Great Basin and southwest Montana into the Colorado Rockies and Southwest. Rain with the thunderstorms is likely to be heaviest across southeast Nevada into central Utah and west-central New Mexico with potential flooding. Scattered wet thunderstorms are also possible across northern Washington from the Cascade Crest eastward. Showers and embedded thunderstorms are likely in the Northeast, while scattered thunderstorms are forecast for the Florida Peninsula as well.

Medical Incident Report

Fire Communication Category

The Medical Incident Report (MIR) can be found in the following documents: in the [NWCG Incident Response Pocket Guide \(IRPG\), PMS 461](#), under Emergency Medical Care (pink); in the Medical Plan [ICS-206 WF](#) <http://www.nwcg.gov/publications/ics-forms>; and in many Incident Action Plans (IAPs). The MIR evolved from and has replaced the 9 Line Form and pPink sticker.

The MIR is not always tasked to the Emergency Medical Technician (EMT) or Paramedic in Patient Care. The intent of the form is to:

1. establish control of the incident, whether routine or life-threatening, by initiating a new Incident Command System,
 2. standardize a systematic process for reporting medical incidents/injuries, similar to a fire size-up for initial attack, and
 3. enable any firefighter, with prior training and direction, to fill it out and transmit the information.
- Treat it like any incident. If the incident is overwhelming, ask for a more qualified Incident Commander (IC) to assume command. Expand/contract the organization's size depending on the needs of the incident.
 - Fill this report out completely prior to transmitting to dispatch/communications. If the incident is life threatening, do not let documentation delay patient care.
 - When transmitting the report, state the number and title of each section, and say "break" and pause between the sections (e.g., "Dispatch, Task Force Leader (TFLD) Jones. Standby for Priority Medical Incident Report. 1. All other radio traffic please hold, break" (pause/wait for response). "2. Incident Status: Nature of Illness is chest pain. Incident Name is Tank Medical. IC will be TFLD Jones. Patient Care will be Paramedic Smith. Break (pause again). 3. Initial Patient Assessment is...").
 - When using the MIR during a Multi-Casualty Incident (MCI), state the number injured and their severity (Section 3: e.g., "3. Initial Patient Assessment, I have five patients. three Reds, one Yellow, and one Green. Mechanism of Injury is...").
 - Use the terms Paramedic or EMT with the provider's last name in "Patient Care." Do not use EMT to describe a Paramedic or the ambiguous term Medic. All those roles need to be clearly identified to understand the level of care and treatment the patient(s) will receive.
 - Enact more than one transport plan and clear more than one frequency if needed for Sections 5 and 6.
 - Always be ready for the first plan to fail and be flexible enough to move into an alternate plan. Use the acronym PACE (Primary, Alternate, Contingency, and Emergency) for planning purposes.

Action Items:

Consider developing medical emergency tabletop scenarios as part of morning briefings or field scenarios on project work to become familiar with the process. The more comfortable with the MIR you are, the more it will be second nature under stress.

Ensure dispatchers and radio operators are aware of their roles and responsibilities pertaining to the MIR.

Review your local unit emergency plans.
