**Cedar Creek**, Willamette NF, USFS. IMT 1 (AK Team 1) and IMT 1 (PNW Team 3). Fifteen miles east of Oakridge, OR. Timber and closed timber litter. Moderate fire behavior with flanking, backing and isolated torching. Numerous structures threatened. Area, road and trail closures in effect.

**Bolt Creek**, Northwest Region, DNR. IMT 2 (NW Team 8). Two miles north of Skykomish, WA. Timber, closed timber litter and hardwood litter. Minimal fire behavior with flanking, backing and creeping. Numerous structures threatened. Evacuations, area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Double Creek**, Wallowa-Whitman NF, USFS. Transfer of command from IMT 1 (PNW Team 2) to IMT 1 (SA Blue Team) will occur today. IMT is also managing the Sturgill, Nebo, and Goat Mountain Two fires. Ten miles southeast of Imnaha, OR. Timber and short grass. Minimal fire behavior with creeping and smoldering. Area, road and trail closures in effect. Precipitation occurred over the fire area yesterday.

**Predictive Services Discussion:** Scattered showers are expected across northern California, Pacific Northwest, and into Idaho, especially later in the day and overnight. Isolated to scattered thunderstorms are likely from northeast California and eastern Oregon eastward through northern portions of the Great Basin, southern Montana, Wyoming, and northern Colorado. Due to an approaching cold front and enhanced downslope flow, dry and windy conditions will develop in the Sierra, including on the Mosquito Fire, extending into portions of Nevada. Dry and breezy conditions are also likely in portions of the Southwest onto the southern and central High Plains. Recent precipitation should help mitigate fire weather concerns, but locally elevated conditions are possible. Scattered thunderstorms, including strong to severe thunderstorms, are forecast across portions of the central Plains into western Great Lakes. Thunderstorm chances will remain confined to Florida and near the Gulf Coast, while warm and dry conditions continue across much of the Southeast into the southern Plains, Ozarks, and Ohio Valley. Very strong winds, heavy rain, and coastal flooding are likely in western Alaska due to a historically strong storm in the Bering Sea. Tropical storm conditions will spread across the US Virgin Islands and Puerto Rico, with heavy rain and flooding likely.

## Constructing Line Without A Safe Anchor Point

*Operational Engagement Category*

When deciding where to build fireline, the following considerations must be weighed:

- Can you hold the line? How do you do so and ensure your safety if there is a danger of the fire hooking under/around you?
- Are there adequate safety zones and escape routes? Review what constitutes an adequate safety zone and escape route. Who has the responsibility to designate them and monitor their continued suitability?
- Can you develop your starting point into an anchor point? List some effective anchor points. Describe how you would develop your starting point into an anchor point.
- Have you posted lookouts? Where should they be posted? Can they see the main fire? Describe the qualities of a skilled lookout?
- Do you have effective communications? Who do you need to be in contact with? If there are problems with communications, what can you do to improve them?
- To reduce risk, evaluate several locations before making a decision. Talk about fires where you have had to relocate the line because your anchor point did not hold the fire.
- How have you mitigated Watch Out Situation #8 in the past?
